

The following information was obtained from confidential informant New York T-1 who is familiar with some activities in Israeli circles in the New York area.

On June 29, 1961, New York T-1 advised he had learned that Momerch Books, Incorporated is connected in some may with Prederick Fell, Incorporated, Publishers, of 350 Park Avenue South, New York, New York.


