As the Transportation and Infrastructure Committee begins its work to reauthorize the Passenger Rail Investment and Improvement Act of 2008, the National Conference of State Legislatures (NCSL) encourages you to move legislation forward that supports the continued economic viability of Amtrak and other passenger rail providers. It is in our nation's interest to provide our rail system with the same financial security as other modes of transportation – highways, transit, aviation and waterways. As such, NCSL strongly supports a dedicated source of federal funding for passenger rail service, including adequate support for a capital improvement program.

Additionally, NCSL believes that intercity passenger rail systems have been integral to alleviating congestion and environmental concerns in the nation. Federal support for these efforts is imperative. NCSL also urges the federal government to support the states in meeting their expanded role in high-speed and intercity passenger rail and to facilitate interstate coordination as well as relationships among diverse stakeholders.

Moving forward, NCSL welcomes the opportunity to further discuss federal funding of Amtrak and other passenger rail systems across the nation.
