---

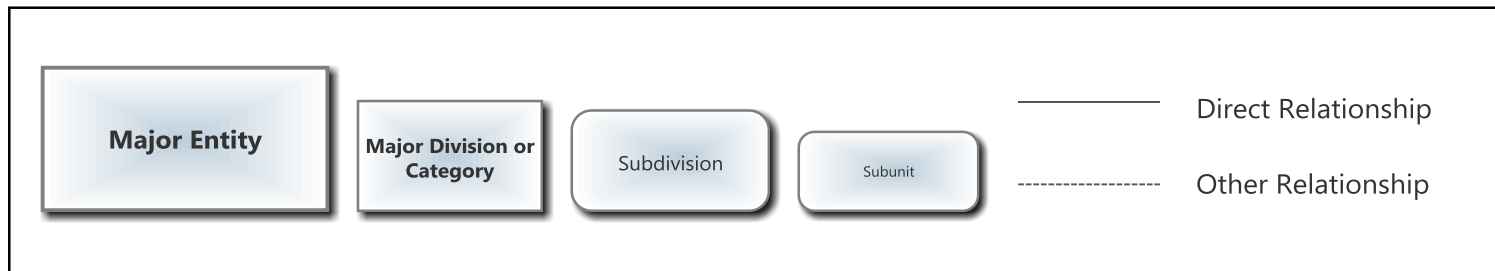
The people of Utah are served by a host of state officials, departments, boards, commissions, committees, and judges, in addition to numerous local government units and subunit. Utah state government is extensive, varied, and complex. In fact, it is one of Utah's largest employers, employing approximately 23,877 persons as of August 1, 2014. This publication includes organization charts for Utah's legislative, executive, and judicial branches of government as well as independent governmental entities. As state government is ever changing, the Office of Legislative Research and General Counsel updates this compilation of charts every two years.

The information in this report has been reviewed by the departments and the other major entities and reflects organizational structures as of September 10, 2014.
