

## Voter Photo Identification Card Application

## Applying for a Virginia Voter Photo Identification Card:

A Virginia Voter Photo Identification Card may be provided to any Virginia voter who does not currently possess another acceptable form of identification necessary for the purpose of voting. Acceptable forms of photo identification include:

- Valid Virginia Driver's License
- DMV issued photo identification card
- Valid United States Passport
- Government issued photo identification
- Valid Employee photo identification
- Valid college or university student photo identification card issued by an institution of higher education located in Virginia.

Virginia Voter Photo Identification Cards are available, free-of-charge, from any General Registrar's Office in Virginia. Voters who wish to have an identification card made should complete the application at the lower portion of this page. A voter may have assistance in completing the application without any need to complete any additional declaration of assistance paperwork. The voter himself/herself must make his/her own mark in Section 6: Swear/Affirm, when physically able.

All required sections of the form must be completed and the form must be presented, in-person, to a General Registrar's office by the voter applying for the identification card. The application may not be faxed or mailed. Any voter lacking proper photo identification may apply for a Virginia Voter Photo Identification Card at any General Registrar's office throughout Virginia.
