International Meeting on the Question of Palestine

Brussels, Belgium (7 and 8 September 2015)

The Committee on the Exercise of the Inalienable Rights of the Palestinian People will convene, in cooperation with the League of Arab States and the Organization of Islamic Cooperation, the International Meeting on the Question of Palestine on *Monday, 7 and Tuesday, 8 September 2015*, at *The Hotel*, in Brussels.

The theme of the Meeting is “Israeli settlements as an obstacle to peace – possible ways forward”. By holding this Meeting, the Committee will discuss Israeli settlements in the West Bank and East Jerusalem, their status under Israeli and international law, as well as the impact of Israeli settlement activity on the life of Palestinian people. It will also look into the role of regional organizations, including the European Union, national institutions, civil society and local authorities in promoting a settlement construction freeze and bringing about a two-State solution to the conflict.

The Meeting is open to Member States, United Nations entities, invited international and regional organizations, as well as, representatives of the civil society and the media.

Pursuant to operative paragraph 17 of resolution 68/307 of 10 September 2014, on the revitalization of the work of the General Assembly, there will be two elections, at the seventieth session, of the non-permanent members of the Security Council and two elections of the members of the Economic and Social Council. Specifically, the General Assembly will conduct the elections of five non-permanent members of the Security Council for the term 2016-2017 and of 18 members of the Economic and Social Council for the term 2016-2018, during the main part of the session, in the *fall of 2015*. The elections for the 2017-2018 term in the Security Council and for the 2017-2019 term in the Economic and Social Council will take place during the resumed part of the session, in the *spring of 2016*. Subsequently, these elections will be conducted once during each session of the General Assembly, in the spring, in accordance with the above-mentioned resolution.
