






Olympic venues – London

 - 17,000 Athletes and Team Officials
 - 26 Sports
- Associated cultural events every night
- Host the Paralympic Games 12 days
- Major events to test preparedness of venues in previous year



Who will deliver Games transport?

- London Organising Committee of the Olympic Games (LOCOG)
 - Planning, organising and staging the Games
 - Olympic Family transport specification & funding
- Olympic Delivery Authority (ODA)
 - Develop Olympic Transport Plan
 - Deliver venues & Games specific transport schemes and services



Who will deliver Games transport?

- Delivery partners
 - Olympic Route Network TfL, London Boroughs, Highways Agency, police organisations
 - Transport operators TfL, National Rail operators, bus/coach operators



Games Transport Strategy

- A public transport Games
 - 100% of ticketed spectators to use public transport, walking and cycling facilities
 - Supplemented by Park & Ride and Park & Rail facilities where necessary
- A sustainable Games
 - Use of existing network minimising need for additional Games specific projects and services
- Integrated plans for Olympic and Paralympic Games



Games transport: the challenge

- Keep London moving and make hosting the Games a positive experience for the whole city
- Leave a legacy and facilitate the regeneration of East London
- Achieve maximum value for money and minimise cost



Spectator Transport: the Olympic Park



Train Service Enhancements

- Increased frequency service and extended hours of operation on North London Line, Great Eastern and c2c lines
- Longer trains on North London Line
- Shuttle service between St Pancras and Stratford on CTRL




London 2012 Olympic Games Planned Rail Infrastructure Enhancements

- Stratford Station Capacity works
- Extension of Platforms at Stratford
- Capacity enhancements/platform lengthening on NLL
- Station and capacity improvements at West Ham
- Modifications to operate Shuttle service on CTRL

Operational Issues

- Integration of works with planned / advanced renewals
- Works to increase resilience/ enhanced maintenance
- Manage changes to timetables/access rights
- Operate the network for extended hours
- Align operational control with Olympic Transport control
- Manage crowds at Managed Stations



Risk Register Structure

- Risk Register maintained in the Network Rail corporate system - Active Risk Manager (ARM)
- Hierarchy of risks in the register
 - Strategic
 - Programme
 - Project



- Four scoring schemes:
 - Corporate
 - Major Project (>£100 million projects)
 - Large Project (£10-100 million projects)
 - Medium Project (£1-10 million projects)
 - Small Project (<£1 million projects)



Programme Level Risks

- Construction causes disruption to existing business
- Disruption to existing services during Games period
- Disruption to maintenance and renewal programmes
- Changes following Beijing Games in 2008
- Delays in agreeing funding



Impact ratings based on 1-5 rating on the 7 corporate goals

- Finance
- Safety
- Performance
- Capability
- Asset Stewardship
- Business Performance
- Customer Stakeholder



Likelihood: Frequency/ probability ratings

Frequency	Description (annual probability)	Score		
5 per year or more	Recurring	5		
1 per year to less than 5 per year	Expected	4		
Less than 1 per year to 1 in 5 years	Possible ≥20%	3
