INTRODUCTION

This release contains information gathered in the 2006 Isle of Man Interim Census held on 23rd / 24th April 2006. It is the most recent in a series dating back to 1821.

The interim census was primarily a headcount of the population but some additional information on such important variables as the age and sex of the population, together with details of nationality and employment status, was collected.

The 2006 Census was conducted by the Economic Affairs Division of the Treasury under the authority of the Census Act 1929.

Whilst an initial summary was published in December 2006, this release presents a fuller analysis of the interim census results. However, should any further analysis be required a written request should be submitted to the address below and we will endeavour to provide any such figures, subject to practicality and confidentiality.

GENERAL EXPLANATORY NOTES

The following definitions relate to the headings used in the Census tables and to concepts underlying the Census analysis.

Population Base

The primary purpose of taking a Census is to gather information on the Island's resident population. To facilitate historical comparisons it is traditional to also examine the figure for the Census population as shown in the historical data section of this report. There is also the *de facto* population, defined as the number of people actually in the Island on Census night. The following are the various population definitions used in this report:

Resident Population:	Isle of Man residents present on Census Night plus residents absent from the Island on Census Night
Census Population:	Resident population plus visitors in the Island on Census Night
<i>De Facto</i> Population:	Residents present on Census Night plus visitors in the Island on Census Night

Visitors

For Census purposes a visitor is defined as a person whose usual place of residence is outside the Isle of Man. This includes persons who are visiting the Island on holiday and those on business who are here to work for a temporary period but who do not intend to take up residence in the Island in the immediate future.

Resident Households

A household comprises of either one person living alone or a group of persons (who may or may not be related) living at the same address with common housekeeping which includes, for example, sharing one meal a day together.

The statistics presented on resident households exclude persons in communal establishments. The total number of such persons in 2006 is 1,579.

Census Districts/Enumeration Districts

Each of the Island's 24 towns, villages and parishes comprises a census district. An enumeration district covers the area of work of a particular enumerator. Heavily populated areas will therefore contain many enumeration districts (Douglas has 38). For census purposes, the Calf of Man is part of the district of Rushen.

Dependency Ratio

The dependency ratio is the number of people under 16 years old and the number of retirement age as a percentage of the working age population. Those of retirement age are taken to be all women 60 years and older and all men 65 years and older. The working age group consists of all adults above the age of 15 and under the age of 60 for women and 65 for men.

Place of Birth and Previous Residency

Many countries have been grouped together for tables relating to place of birth and residency. The groupings are shown in Appendix 2.

Employed/Economically Active

Statistics on the employed population refer to the number of those in the resident population employed at the time of the census. The economically active population is comprised of the employed population and the unemployed who are looking for work or waiting to start work already obtained.

Occupation

Information on employment by occupation relates to the main occupation of persons in employment or self-employment. The person's description of the tasks undertaken in their occupation was used to assign him/her to an occupational group.

The classification system used is the UK Standard Occupational Classification 2000 (SOC). To make the results detailed but readily interpretable, Table 19 of this report presents full or "sub-group" occupational details whereas tables 20 to 23 present results by broad "major" group.

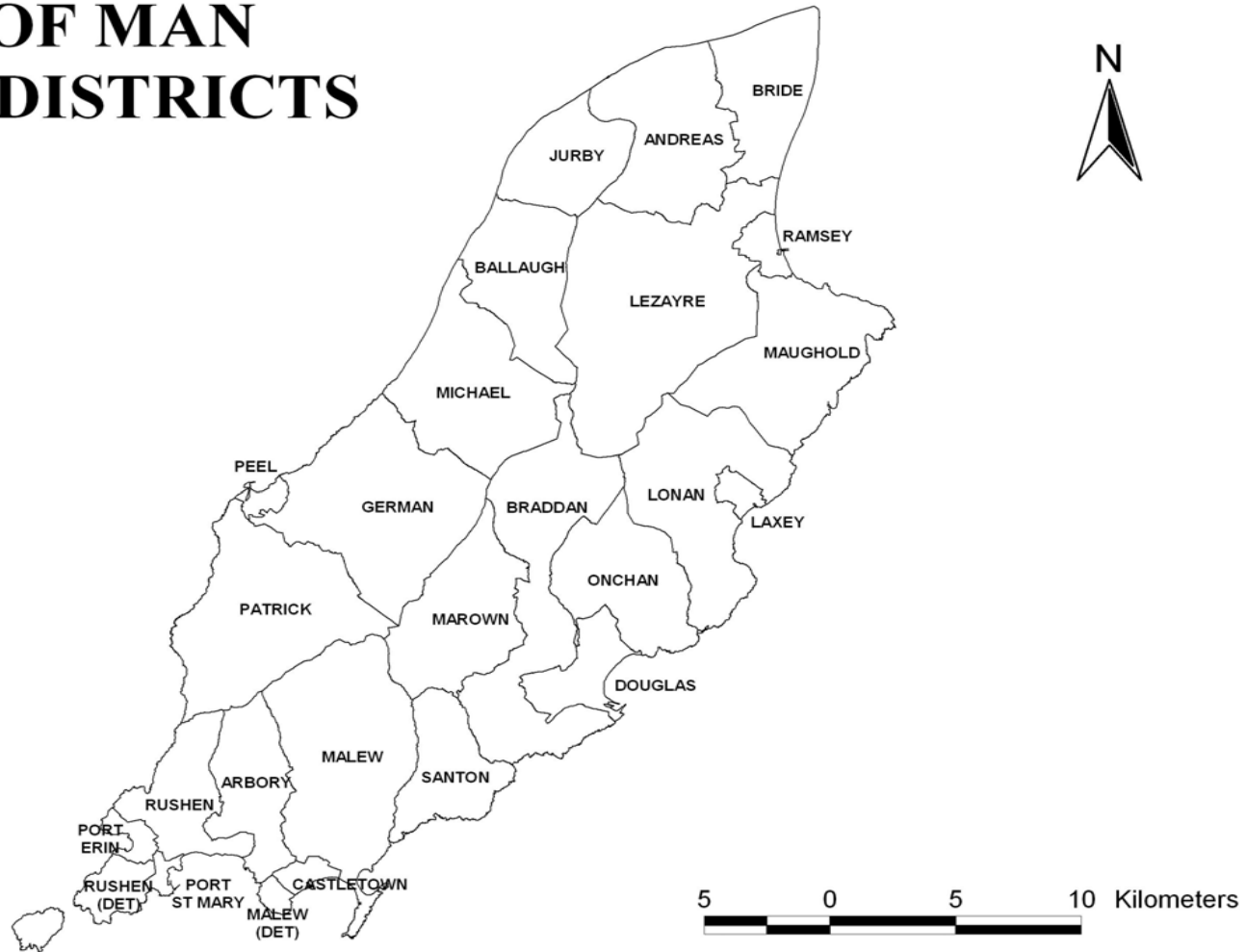
Industry

As with occupation, information on employment by industry relates to the main occupation of persons in employment or self-employment. The person's description of their employer's business is used to assign him/her to an industrial sector. As a result, a degree of judgement is built into the process of allocating individuals to industries and this should be borne in mind when interpreting results, particularly if making inter-censal comparisons.

EXECUTIVE SUMMARY

- On Census Night 2006 the resident population stood at 80,058. This represents an increase of 4.9 % on the 76,315 recorded in the 2001 census.
- At 13.1%, the rate of growth of the population of Peel was faster over the last five years than that of any of the Island's other towns. Douglas grew at a lower than average rate of 3.4%. Of the other towns, the population of Castletown rose by 0.3% whilst Ramsey's fell by 0.2%.
- Reflecting a continuing downward trend in average household size, growth in the number of households continues to increase at a faster rate than population growth. The number of private households increased by 5.9% between 2001 and 2006 compared to population growth of 4.9%. Average household size fell from 2.37 to 2.35 over the five year period.
- The broad age structure of the Island's population continues to change, with the number of people of working age increasing faster than the number not of working age. As in previous years, this has led to a falling dependency ratio (number of children and those of retirement age as a percentage of those of working age).
- The economically active population increased to 41,793 in 2006, up from 39,685 in 2001. The number in employment rose to 40,783, leaving the number unemployed at 1,010.
- Males are more likely to be in full-time employment or self-employment than females. Females account for 81% of part-time positions.
- The most frequently stated reason for not being in work was retirement for both genders. The number of females out of work because they are looking after the home and family has been declining significantly in recent years from 6,733 in 1991 to 4,975 in 1996 and 2,934 in 2001 but rose slightly to 3,075 in 2006.
- Manx born residents account for 47.6 % of the resident population compared with 48.0% in 2001. 6.1% of residents were born outside the British Isles/Eire.


