**Our Mission:** EODA, through the cooperation of its 16 member counties, will promote the economic growth of the region.



This briefing led to a discussion on Public Defender reimbursement, severance tax and other issues that affect the region. In October, EODA held an informational forum/debate with one candidate for governor, and two Congressional candidates addressing the Forum.

# Business Development and Marketing Committee Chairs: Arnold Oliver, Paul Prater, and Jo Sexton

#### Purpose:

The EODA Business Development and Marketing committee is charged with promoting our sixteen county region through a strong network of local, regional and statewide economic development professionals. Our activities include conducting retention and expansion studies, export education, trade shows, industrial site promotion, and maintaining a strong web presence.

#### **Summary of Committee Activities:**

The Business Development Committee of EODA was proud to be a \$250 sponsor of the Shale-abration event organized by the Guernsey County Chamber of Commerce. Dale Hileman, EODA executive director, participated by manning an oil and gas booth to showcase opportunities within the 16 county region of EODA. The program is truly a celebration of the region's natural resources and homegrown energy production. Community and education are the driving forces behind the festival. It is the mission of the organizers for every attendee to come away with a better understanding of the industry, energy production, distribution and usage. It is also a chance for the industry to "meet and greet" in an informal networking session. On behalf of EODA we would also like to thank Jo Sexton and the Guernsey County Chamber for organizing the event and for their leadership in the industry.

The Committee updated the membership on export activities and changes in the website and continued to work with Statewide development officials.

#### EODA CONTINUES TO EXPLORE SHALE PLAY DEVELOPMENT AN IMPORTANT PROGRAM INITIATED BY MIKE JACOBY

In 2014, participating EODA counties held three open houses for commercial real estate brokers: one each in Pittsburgh, Columbus, and Cleveland. The events featured updates on development of the Utica Shale and networking between EODA member and the brokers. Each broker was given a binder of key development properties in each participating county as well as a flash drive with even more sites and buildings. A GIS-enabled webpage created by Buckeye Hills also is available to brokers and anyone else to find sites in shale counties. Link to the page via www.eoda.org.

In June, EODA hosted a booth at the Developing Unconventional Gas East (DUG East) trade show in Pittsburgh. DUG East is the premiere oil and gas show east of the Mississippi. The event is a great networking, awareness building and lead generation tool. The Tuscarawas Economic Development and Finance Authority worked to create a very informative booth presentation.

Over two years of efforts, the EODA Utica Shale Marketing Initiative has helped counties in the region land seven projects and generate many more searches, leads, and ongoing relationships between EODA members and commercial brokers.

In 2015, the Committee will hold a brokers open house in Pittsburgh and host another booth at DUG East. Rather than host open houses in Cleveland and Columbus, we hope to hold an event at the SouthPointe office park near Canonsburg, PA, where many oil and gas companies have offices. Details are yet to be determined.

We extend our gratitude to the sponsors that make these efforts possible: American Electric Power, the Appalachian Partnership for Economic Growth, Buckeye Power, Buckeye Hills, OMEGA, and Columbia Gas.

# Education and Technology Committee Chairs: Mary Kaufmann and Greg Adams

The EODA Education Committee continued its work in 2014-2015 focused on supporting EODA through its mission to develop the region's development in the area of business and education by:

- Further helping to develop math skills for students in our region through "EODA's Easy as Pi" supplemented by online tools from the Khan Academy.
- Building bridges with the business community to help foster communication and understanding between education and the business world.
- Supporting the Don Myers Legacy fund scholarship program.

"Easy as Pi" is a program that encourages kids to work together to learn math as a team. EODA provides funds to sponsor these programs, although it takes a teacher who is willing to programmatically lead the event in each school. In the 2014-2015 school year, EODA sponsored two math teams, lead by teachers in the Tri Valley School District and the Coshocton School District. A total of 20 students and two teachers were involved in the 2014-2015 program. The "Easy as Pi" program started 3 years ago and runs each year from the fall to the spring ending with a celebration party in April with prizes, pizza and a gift of a personalized T-Shirt to recognize the hard work and effort of each student in the program. Our committee has a goal to have one math team in each of the 16 counties that the EODA serves. EODA's Education co-chair Mary Kaufmann has been the key in getting this program going. The Committee has also been exploring how to build bridges between business and education. We recognize that by strengthening this linkage, there is great opportunity for a new generation of youth to contribute to the economic prosperity of the area. To that end, Zane State College will be coordinating Manufacturing camps for middle school students in Muskingum and Guernsey Counties. Additionally, a VEX Robotics Regional Competition was held at the Zane State College EPIC Center in Cambridge. It attracted 35 teams who competed for a chance to advance to the state tournament in Marion. The VEX Robotics Competition is the ultimate Science Technology Engineering and Math (STEM) activity for middle school and high school students ages 11-18.

A P-20 initiative was also started. This is an education-based initiative coordinated by Batelle for Kids and several area sponsors to explore how public education and the business community might explore how they might work together better moving ahead. Several inaugural meetings took place in 2014. Finally the committee is working to support the Don Meyers Legacy Fund annual grant making process. Committee person Cindi Kerschbaumer (of OMEGA) has been coordinating this effort with the Legacy Fund Grant Committee. Over 20 applications have been received so far for this year's grant competition (exceeding any previous year's application pool). Last year's grant recipient(s) were Scenic Hills Senior

Center(Hocking County), and Tuscarawas County Job and Family Services.

The committee meets monthly by teleconference. It is currently chaired by Greg Adams and Mary Kaufmann and includes Paul Prater, Kellie Brown, Joe Farrell, Cindi Kerschbaumer, John Lowe, Bill Beisel, Paul Prater; James Schoch; Ed Tester, Jeff Ohler, Dorothy Skowrunski; Cindy Voorhies; Joanne Pickrell, Mike Whitson, and Mark Ciccarelli.

The Governmental Affairs and Public Relations Committee worked on the annual meeting and legislative forum. The Committee responded to federal and state updates and correspondence. The Committee sent support letters affecting federal, state and regional issues. The Committee forwarded legislative news releases throughout the region from Governor Kasich, Senators Brown and Portman and also Congressmen Johnson and Gibbs to EODA members.

Co-Chair Chris Abbuhl attended the Appalachian Regional Commission DC meeting and lent support to the Local Development Districts. Committee members were part of proposed severance tax discussions. The committee co-hosted a legislative briefing in Zanesville with the County Commissioners Association of Ohio and regional legislators.

The Governmental Affairs Committee led a discussion on Public Defender reimbursement, severance tax and issues that affect the region. In October, EODA held an informational forum/debate with one candidate for governor and two Congressional candidates addressing the Forum. EODA members were able to ask candidates questions on economic development issues.

# SBDC Committee Chair: Cindy Voorhies

The Small Business Development Centers Network of Ohio is the premier technical assistance program for Ohio's small businesses. The network is provided through a partnership between the Ohio Service Agency, the U.S. Small Business Administration and selected Ohio chambers of commerce, colleges and universities, and economic development agencies. Today, these federal, state, and local partnerships contribute more than \$10 million in cash and resources to the support of small business development in Ohio.

District 10 of the Ohio SBDC network covers the following counties:Belmont, Carroll, Columbiana, Coshocton, Guernsey, Harrison, Holmes, Jefferson, Muskingum and Tuscarawas Counties. During 2014, SDBC assisted 29 business start ups and met with 454 clients.

The Network counseled over 4621 hours and assisted with \$6,373,412 in capital infusion that resulted in an increase in sales of \$31,268,972. Through their efforts 212 jobs were created, and 444 jobs retained. Seventy-seven training events were held with 966 attending.

As an example, Traci Bell, owner of Ripple Rock Fish Farm, states 'Cindy provided support in many aspects of the business from legal structure, to technological resources to marketing avenues. Working with the SBDC opened doors for networking in our community and beyond. On a broad level, the SBDC provided a resource to answer our questions. Today, her business is nearly in full operation, with the aquaponics operation nearing completion by the end of 2014. We look forward to continued cooperation with the SBDC as we refine our tours and educational workshops as well as our consulting practice.'

# 2014 Technology Excellence Award Zane State Cambridge

The Cambridge campus, located on Brick Church Road, offers educational opportunities to residents of Guernsey County and the surrounding areas. The campus includes two buildings connected by an enclosed walkway. Several programs can be completed in full at the Cambridge campus, including Welding & Fabrication, Oil & Gas Engineering Technology, and Medical Assisting, and Business Management.

The newest addition to campus, the EPIC Center, opened in January 2014. This learning center features state-of-the-art classrooms and labs, study areas for students, a bookstore, and community

rooms. The Willett-Pratt Training Center (WPTC) features the Center for Workforce Solutions and Entrepreneurship, which offers industry training and the Small Business Development Center. WPTC also includes classrooms, labs, and a computer lab for student use.

# 2014 Tourism Excellence Award Village of Sugarcreek

The Village of Sugarcreek has led the way in tourism. The World's Largest Cuckoo clock was purchased and restored and found its new home on the square in downtown Sugarcreek. Over 23 feet tall and 24 feet wide, the Sugarcreek clock is all clock, with innards that are a maze of mechanical parts and 1972 transistor technology. Every-half-hour, a cuckoo bird pops out and then you hear Swiss polka. Secondly, there is an unique brick wall containing a series of 13 sculptured brick panels in downtown Sugarcreek. The panels, designed and sculptured by local artist, Sherrell Crilow, tell the story and history of the area. Thirdly, downtown Sugarcreek features a horse-drawn trolley. The knowledgeable driver explains to tourists the history of the area and things to do.

# 2014 Large Employer Excellence Award Hannibal Real Estate LLC

Hannibal Real Estate has created over 200 jobs in the Hannibal Industrial Park The Hannibal Industrial Park comprises 1.25 Million SF of building space located on 122 acre site. It's an ideal building/location for companies operating in the Oil & Gas industry and related support services, as well as Steel, Metal Products, and other industrial machinery manufacturing. In addition to manufacturing and warehouse opportunities, office space and outside storage areas are also available. Rail service is available onsite via the Ohio Terminal Railway, and interchanges with Norfolk Southern. Barge service is available via Westbank Barge Terminal. The Hannibal Industrial Park also features several cranes, ranging in capacity from 10 to 100 tons, abundant utilities capacity, high ceiling clearances (50'+ in many areas), a certified truck scale and 24/7 site security.

The Hannibal Industrial Park is located on the Ohio River in Monroe County, Ohio. This location provides access to major North American markets, East Coast ports via rail service, and the Gulf Coast ports via barge service. 
# 2014 Emerging Business Excellence Award Three Rivers Energy LLC

Three Rivers Energy, LLC is a 50MGY nameplate capacity Delta T bio-refinery located near the City of Coshocton, approximately 70 miles northeast of Columbus, OH. The business was acquired by Three Rivers Energy, a partnership involving Lakeview Energy and Crestwood Biofuels, in June 2012. Lakeview Energy have been investors in the biofuels industry since 2006 and already own and operate another Delta T biorefinery in Iowa called Plymouth Energy. Crestwood Biofuels parent company Crestwood Energy is involved in co-generation and operates a number of Combined Cycle Gas Turbine (CCGT) plants here in the US. Lakeview Energy is the managing partner of the business. Three Rivers Energy has retained Interstates Commodities to procure all of its corn needs for the plant, with Lakeview Energy's trading division retained to sell the plants commodities.

Dale H. Hileman, age 82 of Cambridge, OH, passed away Thursday, February 19, 2015. He was born November 8, 1932, in Damascus, OH to the late Harvey Hileman and Gladys (Kirtland) Hileman. He graduated from Goshen High School and attended Malone College. He served two years in the U.S. Army infantry. Dale was employed for 40 years with Columbia Gas of Ohio.
