 - i. If scores not reported within 24 hours of completion of game, coach will be fined \$5.00
 - ii. Recommend that scores and inning pitched by each pitcher (last name) be reported before midnight. Once we have 3-4 games under the season, Gary will update standing the next morning.
 - d. Zebraweb / Umpires
 - i. You will get your temporary password a few days before your first game. If you have not heard from Jon Adams 48 hrs before game, e-mail Jon with your e-mail address and phone number to ensure he has your correct information.
 - ii. If canceling game due to weather, you must call the opposing coach. Do not use e-mail. If you get voice mail, leave a message, but follow-up. Expectation is the coaches talk live to avoid a team showing up when a game is not going to be played.
 - iii. Canceling a game less than an hour before the game and the umpire is in route, you will owe a show up fee of \$22.00
 - iv. If game started and canceled due to weather (not a complete game), umpire only gets show-up fee. Upon continuation of the

game, umpire gets show-up fee of \$22 plus \$7 per inning to a maximum of \$45.00 So if the umpire does 3 innings, he get \$43 (\$22 +\$21). If the umpire does four inning or more, \$45. Maximum.

e. Rules Review

- i. Highlighted the major change with requiring getting the ball to the bag to stop play rather just in the possession with an infielder in the infield. The circle helps as well to stop play. A pitcher can elect to make the ball live by throwing the ball back out of the circle. Throws by the catch back to the pitcher to reset play that go out of the circle do not make the ball live.
- ii. Base Running Update Details:
 - 1. A play concludes when a play has been made at, near, or in the vicinity of a bag and the ball is in the possession of an infielder.
 - 2. At the conclusion of the play, apply the 2/3rds runner rules:
 - a. If at conclusion of the play the runner is at least two-thirds (2/3's) of the way to the next base:
 - i. If a play is made on the runner and is put out, she is out.
 - ii. If no play is made on the runner and the runner is safe, she is entitled to the base.
 - iii. All preceding runners are allowed to proceed to the base they were attempting to achieve as well
 - b. If at conclusion of the play the runner is NOT at least two-thirds (2/3's) of the way to the next base:
 - i. If a play is made on the runner and is put out, she is out.
 - ii. If a play is made on the runner and she is safe, she must return to the preceding base. All other runners will return to their preceding bases as well.
 - iii. If no play is made on the runner she is to be returned to the preceding bases. All other runners must return to their preceding bases.
 - c. Overthrows: balls hit to the outfield
 - i. Infielder throws to a bag
 - 1. Play reaches conclusion, apply 2/3rd
 - 2. Ex: LF throws to SS who attempt to throw to 2B bag, but overthrows the bag.
 - 3. If at the time of the throw to the bag, the runner is at least 2/3rds of the way to the bag she may continue to 2B, but may go no further.

- 4. If at the time of the throw to the bag, the runner is NOT at least 2/3rd of the way to the bag, she must return to 1B.
- ii. Outfielder throws directly to a bag, but overthrows the base.
 - 1. Runner can advance, at their own peril, to the bag the ball was overthrown to, and no further. 2/3 rule does not apply.
 - 2. Ex: LF throws to 2B bag, but overthrows the bag.
 - 3. Runner (who hit the ball) can advance to 2B and no further, even if an additional play is made on the runner, which results in a second overthrow.
 - 4. If the additional play results in the runner being put out, the runner is out.

d. Pitcher's Circle

- If the ball is returned directly to the pitcher without a play being made at, near, or in the vicinity of a bag, the ball is live so long as the lead runner is continuing to move.
- ii. Once the lead runner has stopped or hesitates and the ball is in the circle, any trailing runner who is less than 2/3 of the way to the next bag must return to their base.
- iii. If the pitcher has the ball in the circle and elects to make a play on a runner:
 - 1. at most the furthest all runners can advance is to their next available base.
 - 2. the 2/3 rules apply at the time the pitcher makes the throw.
- iv. If an infielder has possession of the ball and no advancement is taking place, play is dead.
- v. If a fielder overthrows the ball when attempting to return the ball to the pitcher, and the ball leaves the circle.
 - 1. The ball is once again live.
 - 2. All runners may advance, at their own risk, a maximum of one base.
 - 3. If the ball does not leave the circle, play remains dead.
 - 4. This does not apply to the catcher returning the ball to the pitcher on a non-batted ball.

 - i. Under Base Running, Point 6 Steals.
 - 1. Currently Written as:
 - a. 3. All runners may advance one base when the catcher is attempting to throw a runner out who is attempting to steal. No advancement on an

overthrow. These additional advancements will be considered stolen bases.

Should be update to:

a. 3. All runners may advance one base when the catcher is attempting to throw a runner out who is attempting to steal. The ball is considered live where the base runner can advance one additional base at their own risk if the throw is misplayed. This additional advancement does not count against the steal totals.

3. Commentary for Clarification:

- a. Runner on 1st and 2nd where both runner attempt to steal the next base on a pitched ball. This counts as a double steal (2). The catcher than attempts to throw the runner advancing to third where the ball sails into left field. The runner originally on second can advance to home at her own risk and the original runner on first can advance to third at her own risk with no additional steals counted.
- b. Runner on 1st and 2nd where the runner on second attempts to steal 3rd base on a pitched ball. The runner at 1st initially only take her initial lead and watches the play develop. The catcher than attempts to throw the runner advancing to third where the ball sails into left field. The runner originally on second can advance to home at her own risk with no additional steals. The runner on first can advance no future than third base. However, while her initial move was not to steal second while the catcher is putting the ball in play, her advance to second base will count as a steal. Her advancement to third base will not be counted as a steal.

4. Currently Written as:

- a. 7. Pick-off plays are permitted. Other base runners may advance one (1) base. Pick-off plays are permitted at all bases. The ball is live on pick-off throw and the ball must be returned to the pitcher to stop play. All base runners may advance one base on an overthrow.
 - a. Any advancement on a pick-off play is NOT considered an attempted steal and will not count towards the number of maximum steals allowed per game.

5. Should be update to:

a. 7. Pick-off plays are permitted. Pick-off plays are permitted at all bases. The ball is live on pick-off

throw and the ball must be returned to the pitcher to stop play. There is no limit on the number of bases a runner can advance. Runner continues to advance at her own risk.

 a. Any advancement on a pick-off play is NOT considered an attempted steal and will not count towards the number of maximum steals allowed per game.
