Rules Discussion

- 1. Line-up Card (all Levels)
 - a. Provide LAST NAME, NUMBER, and Position
 - b. Fail to comply, umpire can eject the coach
- 2. 6/7 Rule Change
 - a. Prior to meeting, rule change to allow players to play anywhere in the field to the counter the bunt (not within 3 feet of baseline). We upgraded to unlimited bunting and did not change defense rule to keep equal playing field.
 - b. Clarification on 9th batter rule for batting:
 - i. We removed the automatic 2 out when 9th batter is declared to avoid penalizing the offense for hitting into an out where if any other batter, potential runs could score.
 - ii. Example: runner on third with one out. 9th batter hits to second base who completes the out at first. The runner at third does score.
 - iii. That said, we have had unlimited base running resulting in un-necessary injuries. Example, runner on first with one out and 9th batter hits the ball to second, who gets the out at first. Runner continues to run and is tagged out at home. Normal base running based on possession rule, the runner would get to second, or third base at the most.
 - iv. Rule 3: The ninth (9th) batter will be announced.
 - 1. No Automatic two (2) outs
 - 2. Defer to Base Running Possession Rule For Details. In general, the base runners will advance the same number of bases as the batter.
 - a. Example: Runner at 2nd and 3rd with one out where ninth batter hits to first baseman who steps on the base for out two. The runner on third can score and the runner on second would not score if they did not reach 3rd base when the out is made. (Play is dead with the out and possession by the infielder. The ball does not have to return to the circle.)
 - b. Example: Runner at 2nd and 3rd with one out where ninth batter hits to second baseman who throws to first where possession by the first baseman is not made initially. The first baseman then obtains possession where the runner from second successfully round 3rd base and can advance home at their own risk. (This is regardless if the first baseman was able to make an out on the batter or not).

c. Example: Runner at 2nd and 3rd with one out when the 9th batter walks. If the runner at third is not stealing on the play, once the batter reaches first base, the play is dead with the catcher or pitcher in possession of the ball. The catcher throwing or rolling the ball back to the circle after dead ball is irrelevant.
