From Mediaport to Luxembourg for ICT

- From the 1990's until January 2009, Mediaport Luxembourg was the label used by the Media and Telecommunications Department of the Ministry of State for marketing purposes to promote Luxembourg as a center of excellence for ICT, media and communications
- Mission stated in article 29 (2) c) of the law of July 27, 1991 on electronic media: to promote the Grand-Duchy as a European center for audiovisual and communications activities
- Name change became necessary to:
 - better reflect the new realities
 - align with other initatives
- ICT = Information and communication technologies
- Luxembourg for ICT is a branding, not a new agency

Objectives

- Put Luxembourg on the Internet & e-commerce map
- Become the prime location in Europe for Internet based activities and for collecting, managing and distributing content/data
- Build up cluster of companies active in the collection, handling and distribution of content/data

- Global companies with subsidiaries in Luxembourg having important ICT needs




Be Global from Luxembourg

In parallel: ICT and finance


- More than other countries, Luxembourg's economy is strongly service oriented
- The finance sector is highly depending on ICTs
- The ICT sector grew in parallel with the finance sector
- Strong ICT expertise in the finance sector



Infrastructure: connectivity

- 2005: Study by independent consultant ANALYSYS:
 - General environment ok, but actions needed for Internet connectivity
 - Problems with international Internet connections: high crossborder costs have to be eliminated
- 2006: Launch of LuxConnect SA in October
- 2006: Law of 22 December 2006 on the building of information superhighways charged Luxconnect to:
 - build, operate and promote one or more Internet related data/access centers;
 - build, operate and promote one or more optical fiber networks connecting the country to the main Internet exchange points of Europe;
 - build, operate and promote a national optical fiber ring enabling all national operators to connect among each other.
- 2008: P&T Luxembourg launches Teralink
- 2009: LuxConnect links Luxembourg through new, redundant fiber network to London, Amsterdam and Paris








Infrastructure: data centers

- 2005: vendor diversity insufficient, few operators complying with international standards, high prices
- 2009: several new sites and operators, high standards, lower prices:
 - BCE, BT Infonet / BT Global Services, eBRC, European Data Hub, Lab Group, Luxconnect, root eSolutions, Secure IT, Verizon Business
 - eBRC: Best Data Center Europe Award (2008), Best Managed
 Services Provider & Best Risk Mitigation Service Provider (2009)

Lu-CIX

- LU-CIX = the missing tool to propel Luxembourg onto the European internet map
- Lu-Cix was launched in 02/2009 by major Luxembourg-based Internet companies:
 - Cegecom, Datacenter Luxembourg, Global Media Systems, inexio, LuxConnect, P&T Luxembourg, root eSolutions
- Launch of Lu-CIX services: Q3/2009
