#### Why Advocate Freedom?

For thousands of years, freedom was not a value recognized in most civilizations. The condition of mankind was almost universally characterized by poverty, war, slavery, and tyranny. That some people could use force against others was accepted by the leading philosophers and religious leaders of the day.

Slavery was politically correct in its day. So was monarchy and killing witches. The idea that a better society could be built on the principle of individual freedom was simply unknown.

In 1776, when the founding fathers declared all men are created equal, and are endowed by their creator with certain inalienable rights, and that among these are life, liberty, and the pursuit of

happiness, they launched an intellectual, social, and economic revolution as well as a political revolution.

That same year, an amazing book titled *The Wealth of Nations* was published. It was written by a Scottish social philosopher, Adam Smith.

According to Adam Smith, "A nation is not made wealthy by the childish accumulation of shiny metals, but is enriched by the economic prosperity of its people." True wealth, he wrote, doesn't come from the wisdom or benevolence of a ruling class or even from access to natural resources. "It is the great multiplication of the productions of all the different arts, in consequence of the division of labour, which occasions, in a well-governed society, that universal opulence which extends itself to the lowest ranks of the people."

This singular idea – that men and women should be free to choose, to engage in free trade, and to keep the product of their labor – changed human history.

And it's been under attack ever since.

Freedom suffers from what economists call the free-rider problem. People benefit from freedom even if they don't invest in its preservation. So the defenders of freedom are always and everywhere outnumbered by its foes. Groups like The Heartland Institute do what they can to level the odds and preserve freedom.

Without freedom, the number of people in need of your help will forever grow larger. #### Freedom Is Under Attack in America

Freedom in America has been under attack since the day after the nation's founding. The institutional constraints the Founders placed on the size and power of government have been whittled away by generations of politicians seeking power and interest groups seeking privileges. Freedom's attackers have been bipartisan: Republicans and Democrats alike have sought to expand the government at the expense of our individual liberty.

Many people know Obamacare, Common Core State Standards, and some of the other things President Barack Obama and the Democrats are doing today are at odds with the American tradition of individual freedom and free enterprise. But few people understand how comprehensive and coordinated the Democrats' plan to transform America really is. To see that, you have to connect the dots.

The political Left is conducting a deliberate and carefully executed program to destroy the institutions of freedom that stand in the way of the transformation it seeks. Those institutions include families, churches, small businesses, private schools, doctors in private practice, manufacturers ... the list goes on.

Let's start with health care. The launch of Obamacare was a disaster ... but that was not an accident. The disaster was planned.

The purpose of Obamacare isn't to lower the cost of insurance or expand insurance coverage. It will not do either of these things and there are easier, better ways to do both. No, the purpose is to destroy the private health insurance industry and force consolidation of hospitals, to clear the path for a more centralized government-run health care system.

The failed launch of the insurance exchanges, low enrollment levels, rising premiums, and bankruptcy of some insurers and massive subsidization of others are all intended to coax and coerce the nation to adopt what once was called socialized medicine or single-payer health insurance. Today it is called "Medicaid for All."

Same thing with education. The purpose of Common Core State Standards isn't to improve the quality of K–12 education or to close the achievement gap. Common Core won't do this.

Everyone knows some states already had higher standards than Common Core. The achievement gap was closing already, thanks to some courageous governors (mostly Republicans) willing to take on teachers unions and expand school choice programs. The purpose of Common Core is to destroy private schools, end local control, and make school choice irrelevant because every school will teach the same left-wing curriculum.

Same thing with energy. Global warming isn't about science; it never was. Most scientists say climate always changes, the human impact is so small it's hard to detect against the background of natural change, and even if there is an impact, there's little we can do to stop or reverse it.

Obama and the Democrats (along with some confused Republicans) use fear of global warming to justify laws that destroy the entire fossil fuel industry in America, clearing the path for a new energy economy built by politically connected and highly subsidized solar, wind, and ethanol producers. The left supports this scheme because global warming is a handy justification for massive redistribution of wealth, population control, and other key elements of its political agenda.

Freedom clearly is under assault in America. Will you rise to defend it?


