#### Background

Brookside estate was sub-leased since 1<sup>st</sup> October 2005 by the BrooksRange Plantations (Pvt) Ltd. (BPPL). The Estate which was constructed in 1935 is situated in the district of Nuwara-Eliya at an elevation of 1,761 metres with a total extent of 385 Hectares.

The estate is located in Kandapola approximately 14 km from Nuwara Eliya. The estate has been divided into 4 divisions;

- Brookside
- Silverkandy
- St. John's, and
- Lower Division of Concordia.

We have an annual harvest of 1.7Mn kgs of Greenleaf and manufactured at Brookside factory with approximately 400,000 kgs of made tea per annum. Our workforce at the estate is approximately 650 employees who reside at the estate.

#### Factory and Manufacturing Process

The current capacity of the factory is to manufacture 13,715 kilos, and the factory is geared to manufacture both **leafy** and **Rotovane** type of manufacturing process. At present we are carrying on with Leafy type of manufacturing.

#### Type of Tea

The grades of tea manufactured at our estate is:

- *PEK*, *PEK1*
- *OP*, *OP1*
- FBOP
- *FF*, *FF1*

Out of the 10 months operation we have obtained 5 best prices award for the entire region.
