

FORMER PROVINCIAL HIGHWAYS

BY-LAW 97-62

A By-Law to remove roads from the County Road System and re-vest them in the local municipality in which they are situated.

WHEREAS by Order in Council Number OC1004/96 certain portions of highway in the Township of Marmora and Lake, under the jurisdiction and control of the Ministry of Transportation and shown as PART 1, on Plan P-2439-10 were transferred to The Corporation of the County of Hastings and were vested in and under the jurisdiction and control of The Corporation of the County of Hastings.

AND WHEREAS the said highway was added to the County Road System and designated as a County Road pursuant to the Public Transportation and Highway Improvement Act, (R.S.O. 1990, c. P-50 as amended).

AND WHEREAS by an Order made under the Municipal Act (R.S.O. 1990, c. M.45) The Corporation of the Township of Marmora and Lake is to be amalgamated with The Corporation of Village of Deloro as a new township, under the name, "The Corporation of the Township of Marmora and Lake";


AND WHEREAS pursuant to Section 44(9) of the Public Transportation and Highway Improvement Act, (R.S.O. 1990, c. P-50 as amended), the County may remove a road from the County Road System thereby vesting the said road in the local municipality in which it is situated;

THEREFORE the Council of the Corporation of the County of Hastings enacts By-Law No. 97-62 as follows:

1. The Roads shown as PART 1, on Plan P-2439-10 attached to the Order-in-Council registered as Instrument Number 529331 in the Land Registry Office for the Registry Division of Hastings, described in the attached Schedule to this by-law are removed from the County Road System and vested in the new township, The Corporation of the Township of Marmora and Lake.
2. This By-Law shall come into full force and effect on January 1, 1998.

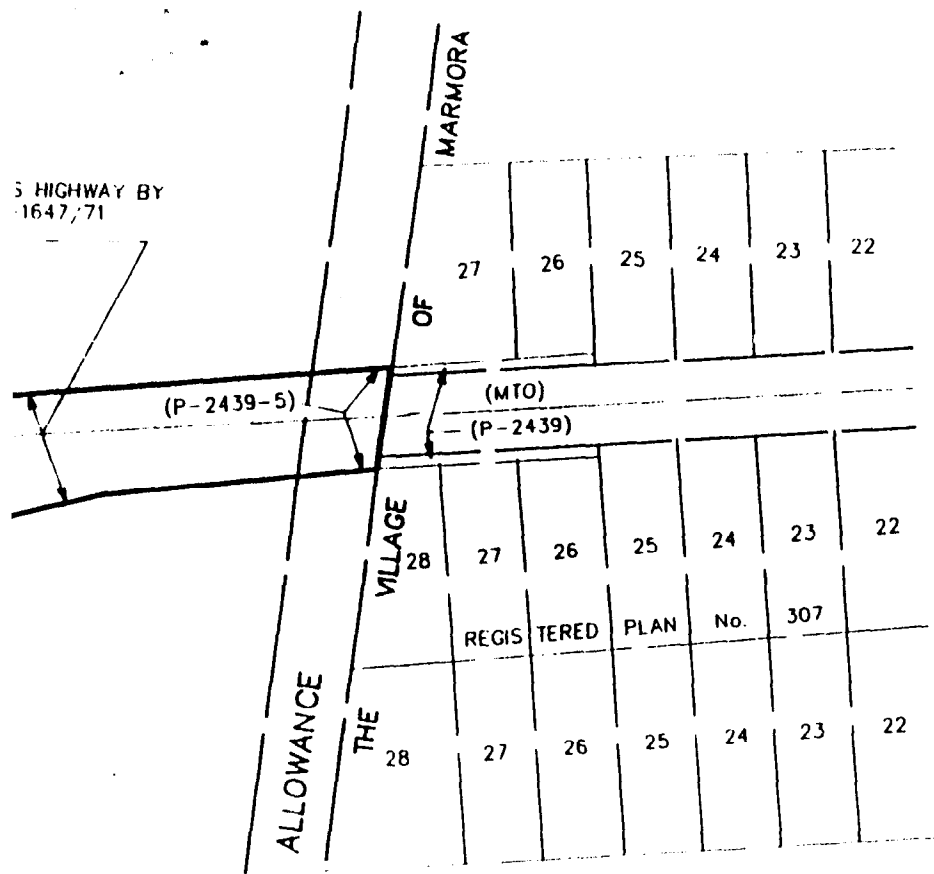

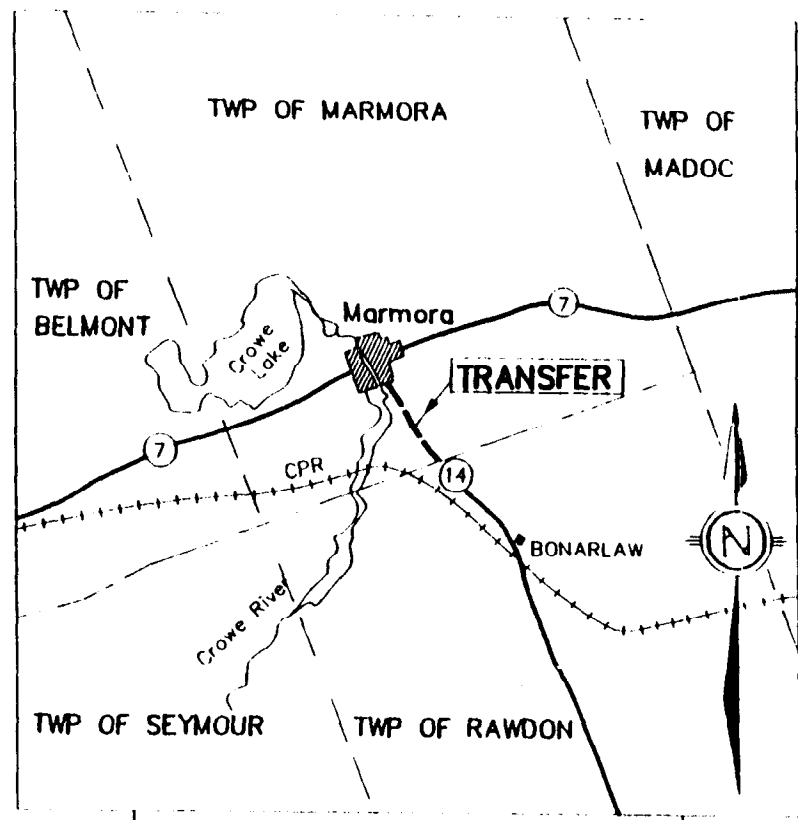

**VILLAGE OF MARMORA**

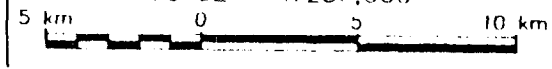
**LOT 6**

The Roads shown as PART 1, on Plan P-2439-10 attached to the Order-in-Council registered as Instrument Number 529331 in the Land Registry Office for the Registry Division of Hastings, described in the attached Schedule to this by-law are removed from the County Road System and vested in the new township, The Corporation of the Township of Marmora and Lake.
2. This By-Law shall come into full force and effect on January 1, 1998.
