The purpose of this transmittal is to provide guidance for the Child Protective Services Chapter of the Child and Family Services Manual. Unless otherwise stated, the provisions included in this transmittal are effective upon release.

Throughout this manual, all references to links on the VDSS internal website (SPARK) have been eliminated and replaced with links to the VDSS public website. Some minor reformatting was done in sections 4 and 5. As a result of reformatting, section numbers may have changed.

Several enhancements were made in section 4 regarding identifying and locating relatives prior to an emergency removal. One significant change in this release is a change in guidance for making referrals for Part C Early Intervention services. In addition to children under the age of 3 in founded investigations, LDSS should refer any child who is identified as affected by illegal substance abuse or withdrawal symptoms resulting from prenatal drug exposure (substance exposed infants).

Another significant change is the update of all regulation citations in Section 5, Out of Family Investigations, due to revision of Virginia Administrative Code 22VAC40-730. It has been posted on the Virginia Administrative Code page of the <u>Legislative Information System</u> (LIS) and became effective January 1, 2014. In addition to technical changes throughout the regulation, several changes were made to the definitions used in Out of Family investigations.
