The use of the term “Broadcaster” within this agreement refers to the affiliate station call letters identified above.

For purposes of this Agreement Infowars or Free Speech Systems LLC shall be referred to below as “FSS”, and the Recipient shall herein after be referred to as “Broadcaster.”

*Program(s) will refer to FSS radio and video content made available to Broadcaster for redistribution. The terms and conditions of this Agreement are set forth below:

- (a) Broadcaster will provide a signed and dated copy of this agreement to FSS prior to redistributing Program(s).
- (b) FSS provides and allows Broadcaster to share and redistribute FSS's radio and TV Program(s) content.
- (c) Broadcaster will not modify the Program(s) audio or use FSS content in any defamatory manner.
- (d) FSS is purely the syndication platform and provides content to Broadcaster for redistribution.
- (e) FSS will not be held liable for any legal issues concerning the Broadcaster's affairs, actions, associations, or transmissions.
- (f) FSS reserves right to terminate agreement with 30 day notice.
- (g) Agreement is effective upon Broadcaster's receipt of counter-signed agreement from FSS.
- (h) FSS understands that Broadcaster can redistribute Program(s) at any local time slot, and grants rights to use Program(s) content for promotional uses, overnight filler, and for any temporary broadcasts, and has rights to carry or cancel at any time.
- (i) Broadcaster will disclose to the best of their ability to FSS accurate redistribution run-time information and/or any termination notices.
- (j) Broadcaster is allowed designated amount of local inventory minutes specified on the program clock for Program(s).
- (k) FSS reserves rights to use Program(s) talk segments to float limited amount of network promotional spots.
- (l) FSS will provide FCC compliant Program(s) to Broadcaster for redistribution.
