# THE TRADING POTENTIAL OF CRYPTO

# CURRENCIES :-

The value of a digital currency depends on several factors simultaneously, the most important of which are the demand and supply of this currency.

The value of a crypto currency as a trading instrument depends on its ability to change its value over time. And that is what distinguishes crypto currencies advantageously from other market values.

While the Blockchain-based economy is still developing, the volatility index of crypto currencies will be significantly higher than that of fiat currencies. The next few years will therefore be the "golden era" of crypto currency trading.

There are more than 200 crypto currency exchanges worldwide for buying, exchanging and trading coins. Depending on the crypto currency exchanges, you can then trade different coins or FIAT currencies with each other. The crypto currency exchanges have significantly improved the usability of buying and selling crypto currencies. Well-known crypto currency exchanges are Coinbase, Binance, Kraken, Bitfinex, Bittrex, Bitstamp.

It should be pointed out separately that the lack of a

global infrastructure, the lack of networking of exchanges and the rapid changes in the current situation lead to different offers for the same crypto currencies at different trading exchanges. Basically, crypto currency exchanges function similarly to normal exchanges. The difference is that traders on an exchange buy and sell assets - stocks or derivatives - to benefit from their price changes, while traders on crypto exchanges use crypto currency pairs to benefit from the very volatile exchange rate.

Since there is no official exchange rate for individual crypto currencies and the crypto currency

exchanges are not interconnected, there are price differences between the currencies and the various crypto currency exchanges.

Each crypto currency exchange calculates the price of the individual crypto currencies on the basis of its own trading volume and the supply and demand of its users. There is no "stable" or "fair" price for the individual coins. This is always determined by the market. Many news and media agencies use a total price of individual coins to determine the current price they have published. Your price index for the individual currencies is calculated as an average value based on the prices of certain crypto currency exchanges. All these things, when combined with powerful software, make it possible to easily earn

with the knowledge of this price difference- this principle underlies trading and arbitrage trading. Trading and arbitrage trading bring profit if the price difference exceeds the amount of commissions and other related costs. Therefore, this is practically impossible in manual crypto currency trading there are too many variables to consider at the same time.
