RE: COMMUNITY CAPACITY BUILDING AND RETENTION OF TALENT- FEBRUARY 7, 2019

*Dear Committee:*

*Since leaving INAC as acting senior scientific Advisor Ontario Region, I have been supporting on behalf of our Principal Clan Mother, the development activities of our family, clan, community and NATION since 2004. The Government of Canada has failed in its fiduciary duty to consult and accommodate our Nation.*

*Our comprehensive claim was submitted to HRH the Queen the Crowns of Canada and to the United Nations February 11 2009 and again in 2015. The Queen instructed the Governor General to instruct the Government of Canada to resolve the issue under simple signature, through the UN process of Treaty. The Government of Canada only, it appears only deals with surrendered indigenous groups that they fund (service providers) and has no process to deal with un-ceded un-surrendered Indigenous Nations such as ASMIN .*

*It appears you only deal with service providers NFP Corporations which in fact the governments own. NFPs are not aboriginal but can have aboriginal members, which can have the provisions of benefits, for which governments are to provide to all Canadians. WE have never been the recipient of benefits and we have had to go internationally to create economic prosperity for our people. The issue to taxation to our people the mud sills of the Canadian economies when it's our lands is an major issue. To this date Canada has throted any attempt for our Nation for community development and economic prosperity and is still refusing the Queen's instruction to deal with our claim.*

*Our G7G railway from Alaska to Alberta, was not supported by this Government, while it was totally funded and approved by all Indigenous Nations along the proposed corridor. Our other community members have had to develop projects in the USA and internationally as we get no traction from the Crowns of Canada.*

*I task you how you are going to address or discuss Community Capacity or retention of talent if you do not talk to and address constitutional issues now made Law by the Daniel's vs. Canada, Supreme Court decision, wherein the Royal Proclamation was upheld re: the requirement of Treaty or bring those people (the government agents) before the crown for charges of treason. It's your laws. WE have solutions. Talk to us. We are available to meet with you tomorrow.*
