Dear Ms. Best:

This is a final response to your 3 January 2018 Freedom of Information Act (FOIA) request for records pertaining to **a website maintained by open government groups and FOIA advocates to spot developments that affect CIA's public access programs as well as CIA's monitoring of it, as officially disclosed in Central Intelligence Agency 2017 Chief Freedom of Information Act Officer Report for Fiscal Year 2016.** We processed your request in accordance with the FOIA, 5 U.S.C. § 552, as amended, and the CIA Information Act, 50 U.S.C. § 3141, as amended.

Please note that the website referenced in the report refers to the American Society for Access Professionals. As stated in the report, CIA FOIA professionals "follow" the site for FOIA developments in furtherance of improving CIA's public access programs. This is distinct from "monitoring."

We did not locate any records responsive to your request. Although our searches were reasonably calculated to uncover all relevant documents, and it is highly unlikely that repeating those searches would change the result, you nevertheless have the legal right to appeal the finding of no records responsive to your request. As the CIA Information and Privacy Coordinator, I am the CIA official responsible for this determination. You have the right to appeal this response to the Agency Release Panel, in my care, within 90 days from the date of this letter. Please include the basis of your appeal.
