This is in response to your 12 December 2011 Freedom of Information Act (FOIA) request for a copy of all files from 2011. We received your request on 16 December 2011 and we assigned the local tracking number 2012-FOIA-[REDACTED] to your request. This letter supplements our 9 January 2012 letter of acknowledgement to you.

Information from AFOSI criminal investigative records are exempt from release under the Privacy Act, United States Code, Title 5, Section 552(a)(J)(2). In order to provide you with the maximum amount of releasable information, we are processing your request under the Freedom of Information Act.

Portions of the information requested are exempt from disclosure to you. We have inserted notations in the attached documents to identify the portions deleted and the reasons for doing this. The notations are explained as follows:

a. "b1" indicates the withholding of national security information concerning the national defense or foreign policy that has been properly classified in accordance with substantive and procedural requirements of a presidential executive order (currently Executive Order 13526, dated December 29, 2009). The authority for this exemption is United States Code Title 5, Section 522(b)(1) and in the federal court cases interpreting that statute. The deleted information is denied because it is currently and properly classified in accordance with Executive Order 13526 Section 1.4 paragraph (c) which related to intelligence activities (including covert action), intelligence sources or methods, or cryptology.

b. "b6" indicates the withholding of information contained in personnel, medical, and similar files or information that applies to a particular individual for which we have determined there exists a privacy interest that generally and categorically outweighs any public interest in disclosure that the Freedom of Information Act would authorize. As recognized in federal statute and case law, the type of information that this generally requires to be withheld includes the names of government employees and law enforcement agents; personal data information such as Social Security Numbers, signatures, personal addresses (including email), and telephone numbers; medical and criminal history information; and most identifying information on persons forward deployed, overseas, or assigned to sensitive or routinely deployable units. The authority


for this exemption may be found in United States Code, Title 5, and Section 552(b)(6) and in the federal court cases interpreting that statute.

c. "b7C" indicates the withholding of information contained in law enforcement records, the disclosure of which could reasonably be expected to constitute an unwarranted invasion of personal privacy. As recognized in federal statutes and case law, the type of information that this generally requires to be withheld includes the names of subjects, witnesses, and "non-confidential" informants of law enforcement investigations; the personal data or identifying information of any third party that is detailed within a law enforcement investigation; and the names of law enforcement personnel unless it is determined that there is a public interest in the release of a particular law enforcement individual's name with respect to a particular law enforcement investigation. The authority for this exemption may be found in the United States Code Title 5, Section 552(b)(7)(C) and in the federal court cases interpreting that statute.

Should you decide that an appeal to this decision is necessary, you must write to the Secretary of the Air Force and it must be postmarked within 60 days from the date of this letter. Include in the appeal your reasons for reconsideration and attach a copy of this letter. Your letter and envelope should be clearly marked "Freedom of Information Act Appeal." This investigation was initiated on 21 July 11, based upon information from Classified Investigative Information System (CIIMS) Developmental Case File # [REDACTED] in which SUBJECT allegedly visited the website WikiLeaks in violation of a Memorandum from the Undersecretary of Defense, dated 11 Jan 11, which violated Article 92, Failure to Obey, UCMJ.			
On 25 April 11, AFOSI Det [REDACTED] was notified that SUBJECT had an emotional breakdown and while speaking to Lt Col [REDACTED] [b6 b7c] UK, SUBJECT stated she had been meeting with an anti-US and/or anti-military group in London, UK.			
On 27 April 11, MSgt [REDACTED] [b6 b7c] First Sergeant, [REDACTED] UK, was interviewed and related the following information: SUBJECT was seen for depression at the [REDACTED] UK, where SUBJECT made an utterance that she had been in contact with an anti-military/anti-war organization that shared the same anti-military views as her. SUBJECT stated she did not have a desire to be in the US military anymore, adding that she did not agree with what the military does.			
On 27 April 11, SrA [REDACTED] [b6 b7c] UK, was interviewed and related the following information: In February 2011, [REDACTED] took SUBJECT to the train station so she could take the train to London to attend the extradition trial of JULIAN ASSANGE, founder of the WikiLeaks website that posted classified U.S. information. SUBJECT claimed she met some "friends" who shared the same beliefs as her. [REDACTED] described SUBJECT as "obsessed" with ASSANGE and "Googled" him frequently on the Internet. [REDACTED] knew SUBJECT sympathized with PFC BRADLEY MANNING, US Army, who was suspected of leaking classified information to WikiLeaks. SUBJECT had a Twitter account where she posted lots of material concerning WikiLeaks and ASSANGE. SUBJECT thought WikiLeaks was a good thing and some things should not be kept a secret.			
On 28 April 11, SSgt [REDACTED] [b6 b7c] UK, was interviewed and related the following information: After watching a skit about ASSANGE, SUBJECT began to do online research about ASSANGE (cont'd)

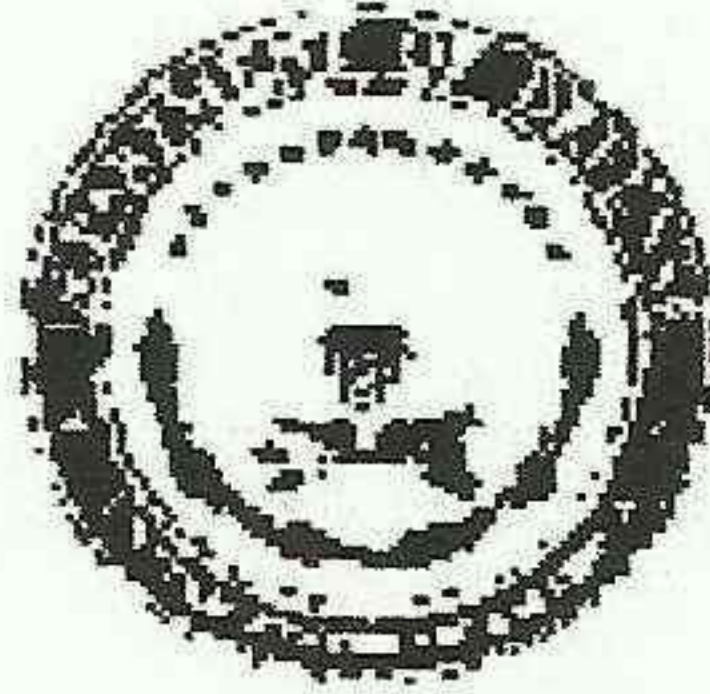

and the WikiLeaks group. SUBJECT was adamant that a lot of classified information did not need to be classified and thought it should be unclassified. In January 2011, SUBJECT attended the extradition trial of ASSANGE in London. Upon returning from the trial, SUBJECT informed [REDACTED] that she agreed with ASSANGE and MANNING's actions in releasing the classified materials.

On 27 Jul 11, SA [REDACTED] Deputy Director, AFOSI Region J, Ramstein AB, GE, directed SA [REDACTED] AFOSI Det [REDACTED] UK, to administratively close this investigation in WIZMS.]

(U) This investigation was initiated on 25 Apr 11, based upon information from Lt Col [b6 b7c] [b6 b7c] Commander, [redacted] United Kingdom (UK) that SUBJECT had a emotional breakdown and while [b6 b7c] was inquiring what was going on with her, SUBJECT stated she had been meeting with an anti-US and or anti-military group in London and she could not take it anymore.

~~(S//NF)~~ Financial and Leave paperwork was obtained from [redacted] United Kingdom, which revealed SUBJECT took leave on 7 Dec 2010, 8 Feb 2011, and 25 Feb 2011, in the local area. Leave address was documented as Bldg [redacted] Room [redacted] United Kingdom, SUBJECT's residence. As information was reviewed pertaining to SUBJECT's financial institutions it was discovered that SUBJECT banked with the following: USAA Federal Savings Bank, Department of Defense Overseas, and Bank of America. No other pertinent information regarding this investigation was discovered.

~~(S//NF)~~ provided a signed, sworn statement detailing the following: In Feb 11, [redacted] met SUBJECT after he returned [redacted] and worked in the same office and became friends. SUBJECT had just [redacted] and seemed depressed. SUBJECT and [redacted] began hanging out [bl b7c]

[blc b7c] While together, SUBJECT and [blc b7c] discussed a variety of topics to include her liberal political views such as her sympathizing with the wikileaks founder, JULIAN ASSANGE. In Feb 11, [blc b7c] drove SUBJECT to the train station in [blc b7c]. SUBJECT told [blc b7c] she planned on attending the extradition trial of ASSANGE in London, UK. SUBJECT claimed this was her second time going to the trial. The first time led [blc b7c] between SUBJECT and [blc b7c]. While in London, UK, at the first trial SUBJECT met some "friends" who shared the same beliefs as her. SUBJECT stayed at a hostel while in London, UK. SUBJECT visited London, UK, at least one other time to meet the unknown friends she told [blc b7c] about. On approximately 1 Apr 11, SUBJECT and [blc b7c] friendship deteriorated [blc b7c] and had little to no contact with SUBJECT. [blc b7c] believed SUBJECT would not divulge any classification to any unauthorized individuals because she would be afraid of getting into trouble.

(S//NF) In addition to the written statement, [blc b7c] verbally provided the following information: [blc b7c] described SUBJECT as depressed. SUBJECT was obsessed with ASSANGE and "googled" him frequently. SUBJECT has a Twitter account where she posts lots of material concerning wikileaks and ASSANGE. SUBJECT goes under the penname [blc b7c]. In addition to ASSANGE, SUBJECT also sympathizes with PFC BRADLEY MANNING who was suspected of leaking classified information. SUBJECT did not agree with what the US Government was doing to MANNING. SUBJECT believed the US Government was keeping MANNING in Guantanamo Bay, Cuba, and was torturing him. SUBJECT thought wikileaks was a good thing and some things should not be kept a secret. SUBJECT had access to SIPR information but [blc b7c] did not believe SUBJECT looked on SIPR often. SUBJECT watched a video of a helicopter supposedly shooting an unarmed man which bolstered her beliefs. SUBJECT has an account for a tube pass so she does not need to pay each time she goes to London. SUBJECT was also upset on one occasion because she could not protest while in the US military. [blc b7c] and SUBJECT's friendship deteriorated [blc b7c]

 (U) Agent(s): [blc b7c] (LEAD); SA [blc b7c]

(S//NF) [blc b7c] provided a signed, sworn statement detailing the following: In Sep 10, [blc b7c] met SUBJECT at FTAC. SUBJECT was attending FTAC [blc b7c] and SUBJECT did not communicate often while she was in FTAC. After SUBJECT graduated from FTAC, she added [blc b7c] as a friend on Facebook (a social networking site). [blc b7c] and SUBJECT [blc b7c] shortly after they began communicating on Facebook. [blc b7c] described [blc b7c] as "ok" but the status declined due to SUBJECT's constant depressed state. SUBJECT would be depressed for no reason, cried "for hours", and showed no emotion. SUBJECT never allowed [blc b7c]. In Jan 11, SUBJECT and [blc b7c] were watching Saturday Night Live when a skit came on about ASSANGE. SUBJECT thought the skit was very funny and soon began to do online research on ASSANGE. SUBJECT became infatuated with ASSANGE and his Wikileaks group. [blc b7c] believed it was a phase and would stop researching the topic after a short period of time. On one occasion, SUBJECT and [blc b7c] argued about ASSANGE and the Wikileaks topic. SUBJECT was adamant that a lot of classified information did not need to be classified and thought it should be unclassified. After that argument, SUBJECT did not mention the topic again. Also in Jan 11, SUBJECT planned on attending the extradition trial of ASSANGE in London, UK. [blc b7c] told SUBJECT it was a bad idea to attend the trial and possibly illegal for military members to attend. SUBJECT did not care and was not afraid of being arrested. [blc b7c] then told SUBJECT if she attended the trial he would [blc b7c] also urged SUBJECT not to attend, but she told [blc b7c] if she did not attend the trial she would "kill herself". SUBJECT left for the trial on a Friday and returned on a Sunday. [blc b7c] texted SUBJECT during the trip to make sure she was safe. After SUBJECT returned from the trip, [blc b7c] picked up SUBJECT from the Bury St. Edmunds, UK, train station and took her back to RAFM, UK. SUBJECT agreed with ASSANGE and MANNING's actions in releasing the classified material.

(S//NF) In addition to the written statement, SUBJECT also verbally provided the following information: SUBJECT has an X-Box Live account under the name [blc b7c]. SUBJECT also has an email account under the name [blc b7c]. After SUBJECT returned from London, UK, she added at least one other person as a friend who is a British citizen and [blc b7c] thought was in attendance at the trial. [blc b7c] believed SUBJECT

had the potential to leak classified information, because she was not afraid of being arrested. SUBJECT thought PFC MANNING was being held and tortured in Guantanamo Bay, Cuba, and was angry about it. SUBJECT also has a friend she was in Tech School with, who is now stationed in [REDACTED]. This unknown person and SUBJECT are friends and SUBJECT claimed the unknown male was also depressed and could relate to SUBJECT. SUBJECT has a netbook, laptop, and a red thumb drive with stickers on it.

(S//NF) Lt Col [REDACTED] verbally related the following information: Lt Col [REDACTED] SUBJECT's commanding officer, knew SUBJECT from approximately 22 Aug 10 to present and described her as a timid, quiet and shy individual who was an introvert with no known friends on or off duty. SUBJECT did not socialize at squadron events and was known to shrug off any attempts from co-workers to attend social events. SUBJECT was known to travel around the United Kingdom; however, SUBJECT traveled alone and relied on public transportation when travelling. Lt Col [REDACTED] explained SUBJECT often travelled to the city of London and frequently stayed there on weekends. Lt Col [REDACTED] was unaware as to where or with whom SUBJECT stayed. Lt Col [REDACTED] explained that on 25 Apr 11, SUBJECT reportedly came to work distraught and in tears. SUBJECT was referred to the [REDACTED] Medical Group (MDG) where she was seen by a mental health care provider with whom she spoke to about her condition. Lt Col [REDACTED] stated he had SUBJECT brought to his office where he attempted to ascertain what problems she was experiencing and to determine if there was anything SUBJECT wanted to discuss. SUBJECT related that she did not want to remain in the USAF; however, did not reveal anything else about her situation or why she was upset. Lt Col [REDACTED] explained SUBJECT's duties as a network operations manager granted her remote access to (Secret Internet Protocol Router) SIPR. Lt Col [REDACTED] added SUBJECT had "higher level" privileges on SIPR and possessed the ability to remotely access any SIPR terminal on the network (NET) for diagnosis or repair. Lt Col [REDACTED] explained that in light of SUBJECT's related feeling towards the USAF and military service, he intended to suspend SUBJECT's access to SIPR on 26 Apr 11.

(U) Agent(s): SA [REDACTED] (LEAD) [REDACTED]

(S//NF) [REDACTED] verbally related the following information: [REDACTED] has known SUBJECT from approximately August 2010 to present and had daily contact with her as a supervisor. SUBJECT was described as a smart but impressionable individual who was an atheist with strong liberal political views. [REDACTED] explained that on the morning of 25 Apr 11, SUBJECT came to work "holding her stomach" while crying uncontrollably. SUBJECT told [REDACTED] "I can't take it anymore" and continued to explain that she felt depressed all the time. [REDACTED] referred SUBJECT to the [REDACTED] MDG Mental Health Clinic where she was later seen. After SUBJECT's appointment she appeared to be in better spirits; however, [REDACTED] explained SUBJECT often appeared depressed. SUBJECT related to [REDACTED] she did not agree with military values as they were incompatible with her personal beliefs. SUBJECT cited the US Military was engaged in acts such as torture which she believed to be contrary to what she stood for. Additionally SUBJECT cited negative news reports regarding the US Armed Forces as why she did not desire to be in the military anymore. SUBJECT disclosed she had been involved with a local organization that shared her beliefs. [REDACTED] asked SUBJECT if the organization was comprised of military reformists and SUBJECT explained they were not radical, but believed the US Armed Forces needed to change how they conducted business. SUBJECT added she was only able to associate with older people, which was a reason why she did not socialize with her peers at work. She stated that one of the members of the organization she socialized with was [REDACTED] old woman who worked at either ITV or BBC in London. SUBJECT spent most weekends with the woman whose identity she declined to disclose. [REDACTED] explained SUBJECT did not have a personal automobile and relied on public transportation to travel around the United Kingdom (UK). [REDACTED] was unaware if SUBJECT traveled outside the UK, citing she has rarely taken any vacation time and spends at least two weekends per month in the City of London. [REDACTED] was unaware of any additional foreigners SUBJECT associated with, with the exception of her unidentified female friend whom SUBJECT has only disclosed as a UK national. Prior to SUBJECT's disclosure of her anti-military

associations. [b6, b7C] though SUBJECT merely had a mental breakdown which may have been associated with a rumored relationship break up she had with a coworker, SrA [b6, b7C] did not think SUBJECT was a National Security risk; however, that AFOSI needed to know about the incident. Additionally, as a precaution SUBJECT's access to classified information has since been revoked.

(S//NF) MSGT [b6, b7C] verbally related the following information: [b6, b7C] SUBJECT's First Sergeant, has known SUBJECT from approximately December 2010 to present and described her as a quiet and shy individual who did not appear to fit into or with the other Airmen in her tier. [b6, b7C] explained that the Airmen within the [REDACTED] have had a reputation of being a tight knit group to which SUBJECT did not appear to fit in. [b6, b7C] explained that on 25 Apr 11, he received a text message from TSgt [b6, b7C] SUBJECT's supervisor, that related SUBJECT came to work visibly upset, emotionally distraught and crying uncontrollably. [b6, b7C] thought SUBJECT may have been suffering from depression and recommended SUBJECT seek counseling from a mental health care provider at the [REDACTED] MDG. SUBJECT was seen by DR [b6, b7C] who later related SUBJECT made an utterance that she had been in contact with an anti-military/anti-war organization that shared the same anti-military views as her. SUBJECT stated she did not have a desire to be in the US military anymore, adding that she did not agree with what the military does. SUBJECT did not provide any details about the organization or who they were affiliated with.

(U) On 10 Jun 11, SA [b6, b7C] coordinated with [REDACTED] for ICON analysis of SUBJECT's mental health records prior to SUBJECT interview, based on reported suicidal ideations noted in the records.

(S//NF) [b6, b7C] Civ AFOSI [REDACTED] reviewed the case file in conjunction with associated mental health records which revealed the possibility SUBJECT may have already disclosed classified information and as a result, desires to be discharged from military service before its discovery. [b6, b7C] further opined SUBJECT's youth, choice of online names such as [REDACTED] her fascination with WikiLeaks, ASSANGE and MANNING, her isolation from her peers in the unit in conjunction with SUBJECT's insistence on attending ASSANGE's trial even if it could be a UCMJ violation and a negative impact on her relationship, all suggests SUBJECT may have already committed an offense.

(S//NF) SUBJECT was interviewed and verbally provided the following information: SUBJECT has a Twitter account which she utilizes to post her political views and to follow groups that appear to have an identical mindset and point of view. SUBJECT followed the following groups on twitter: Stop the War Coalition, Friends of Bradley Manning (FOBM) and Supporters of Julian Assange (SOJA). SUBJECT described Stop the War Coalition (SWC) as an anti-war group where she attended one meeting in February 2011. SUBJECT stated she did not follow the group closely and had not been to any additional meetings; however, SUBJECT frequently reposted SWC's twitter messages (Tweets). SUBJECT described SOJA as internet based group who she followed on Twitter but was not a part of and did not physically socialize with. SUBJECT routinely read and reposted SOJA's Tweets and closely followed SOJA's internet activities. SUBJECT explained she routinely traveled to London in order to attend

JULIAN ASSANGE's trial hearings and to meet with British National Civ [b6 b7c] FOBM. SUBJECT described FOBM as a group [b6 b7c] started to ascertain legal ramifications of the US detention of MANNING and to ascertain if MANNING could [b6 b7c] SUBJECT routinely met [b6 b7c] in London and consumed alcoholic beverages at London area pubs on the weekends. [b6 b7c] was aware SUBJECT was a member of the USAF; however, conversation never circulated around SUBJECT's job responsibilities.

(S//NF) SUBJECT explained that at no time was she ever asked to provide or supply any classified or FOUO information even though she was a supporter and/or follower of the aforementioned groups. SUBJECT stated that she was not subverted into any the organizations or their beliefs, but her beliefs were of her own manifestations based on what she had read publicly in the Guardian and New York Times newspapers. SUBJECT admitted to having an interest in the Wikileaks documents; however did not at any time violate the [redacted] policy letter or DoD directive on accessing and viewing Wikileaks. SUBJECT explained she only viewed what open news sources such as the Guardian newspaper had to say on documents that were disclosed. SUBJECT stated she did not have detailed information on what the documents contained therefore based her opinions on what news sources printed.

(S//NF) SUBJECT stated she accessed Twitter from her NIPR computer to post her opinions but was well aware that [redacted] had the Wikileaks website blocked. SUBJECT explained that even as a Computer Systems Administrator, she did not have the knowledge to defeat government systems to access the site. SUBJECT related she had a Top Secret Clearance but was only able to access the Secure Internet Protocol Router (SIPR) network (net) to perform updates in the form of uploading patches on the system. SUBJECT pointed out SIPRnet access was not closely monitored even though contractors worked in the room where the servers and SIPR computers were housed. SUBJECT stated SIPR machines had DVD drives, USB ports and network printers connected and if someone wanted to leave the room with classified information it could probably be done as no one was checked prior to leaving the room.


(S//NF) SUBJECT explained she loved the United States and always expressed that to anyone when the subject of US politics arose; however did not approve of the treatment MANNING received from the US Government by way of the harsh and inhumane conditions at the Quantico Virginia facility. SUBJECT reiterated she never disclosed any classified or for official use only (FOUO) information and was never approached to provide any military information as such. SUBJECT's main reason for her desire to separate from the USAF, was because of her mental illness coupled with depression. SUBJECT added she had not been able to make or maintain any relationships and did not have any friends in the UK; SUBJECT was also an atheist which in her opinion compounded her situation as no one understood her. SUBJECT added [redacted] UK, [redacted] due to their disagreements on political matters in addition to SUBJECT's obsession with MANNING and ASSANGE. SUBJECT explained it was because of a trip she desired to take to London for one of the ASSANGE trial hearings that [redacted] SUBJECT stated she would consent to a search of her media to include her mobile telephone, personal computer and NIPR desktop and added no data on the computers would indicated she violated any law or policies; however SUBJECT was apprehensive of her mobile phone as it contained personal information which she considered an invasion of her privacy. SUBJECT was aware AFOSI could seize her equipment therefore would not object to a search and seizure.
