



Three years ago, Citizens for a Healthy Community was formed to protect the Delta County region from irresponsible oil and gas development. In that short time, we've made great strides, which you can read

about in the 2012 Highlights section on the right. Perhaps one of our biggest milestones in 2012 came in March, when I began work as the organization's first full-time director. After nearly a year, I have come to know and appreciate what makes the Delta County region such a special place, and one worth the fight. At the close of an

eventful and productive year, I want to thank everyone who has contributed to our progress.

I get asked a lot, "what does irresponsible oil and gas development look like anyway?" It's making a decision to lease thousands of acres of public lands based on a report done a quarter-century ago. It's subjecting children and other citizens to an unacceptable risk by putting an industrial activity only a few hundred feet from schools and homes. It's allowing for one industry to be exempt from the nation's foundational environmental laws.

Citizens for a Healthy Community has become a leader in standing up to the powers that be – from the BLM and state regulators to the big energy companies – and you can count on us to keep up the fight. We recognize that fossil fuels aren't going anywhere anytime soon, but we will continue to work to ensure that every available precaution is taken to protect public health and the environment.

# 2012 Highlights

- Led the charge against the BLM's proposed lease sales, through our partnership with the Western Environmental Law Center, galvanizing the community to take action, and sending a group of residents to Washington, DC to urge government officials to protect our communities.
- Filed a lawsuit against the BLM to end the secrecy in the oil and gas lease nomination process on public lands.
- Worked with the Gunnison County Commissioners to enact more protective oil and gas regulations.
- Hosted a half-day forum with presentations from seven oil and gas experts from across the country.
- Helped convince a federal judge to reject a sweatheart settlement in the anti-trust case between the U.S. Department of Justice and Gunnison Energy & SG Interests.
- Testified before the Colorado Oil & Gas Conservation Commission to urge them to protect water and public health.
- Helped to convince the BLM to reject a request to drill in the Bull Mountain Unit, and to conduct a full environmental impact statement on the Bull Mountain Master Development Plan.
- Organized a community stakeholder group, with our conservation partners and community leaders, to draft a proposal for the BLM's upcoming Resource Management Plan revision. The draft proposal will offer management stipulations that protect the North Fork's many important resources.
- Received the Co-Non-Profit of the Year Award from the Paonia Chamber of Commerce.
