### BASIC NARRATIVE

### 1. COMMAND ORGANIZATION AND RELATIONS

While in EASTPAC, CAMDEN is assigned administratively to COMSERVGRU ONE and CTF 13. When deployed to the SEVENTHFLT West → 100 East, CAMDEN remains in the COMSERVGRU ONE administrative chain=of=command but reports also to COMSERVGRU THREE for administrative purposes and to CTF=73 operation=ally.

Captain Randall W. YOUNG commanded CAMDEN from 15 May 1969 until 19 August 1970 when he was relieved by Captain Wm. M. RUSSELL, CAMDEN's present Commanding Officer.

CAMDEN's home port is Long Beach, California.

CAMDEN embarked Helicopter Support Squadron THREE, Detachment 103, on 25 August 1970 prior to her deployment to the Western Pacific. Explosive Ordnance Disposal Team TWO embarked on 13 September after the ship's arrival in the Philippines. These units were aboard at the end of the year.

As of 31 December 1970, CAMDEN's on board count included 35 officers and 598 enlisted men, including embarked detachments.

### 2. OPERATIONS AND ACTIVITIES

CAMDEN completed her mid-deployment upkeep in Yokosuka, Japan on 3 January and proceeded to Subic for loadout; arriving 8 January. CAMDEN was back on Yankee Station on 14 January. During this line period, CAMDEN accomplished the first successful missile transfer by Stream since her arrival in WESTPAC.

From 3 through 7 February, CAMDEN visited Singapore where she enjoyed five days of well-earned liberty and relaxation. After crossing the Equator, CAMDEN arrived in Subic on 10 February with approximately 500 newly initiated Shellbacks.

After successfully completing her final line period of the deployment, CAMDEN departed Subic for Long Beach, via the San Bernadino Straits, on 10 March. CAMDEN arrived in Long Beach on 26 March. The next 30 days were occupied with routine upkeep and leave for all hands.

On 25 April, a Dependents Cruise was conducted for over 600 dependents and friends of CAMDEN, after which she entered a Restricted Availability status where post-deployment repairs were effected by the Long Beach Naval Shipyard.

Upon completion of the Restricted Availability, on 22 June, fuel was received from the Mobile and Union Oil Companies, San Pedro, and CAMDEN moved to Naval Weapons Station, Seal Beach, where service ammunition, missiles, and cargo ordnance were loaded. From 7 through 24 July, CAMDEN operated in the Southern California operations area where she underwent Refresher Training in preparation for her next WESTPAC deployment.

On 24 July, CAMDEN returned to Seal Beach and completed her ammunition loadout.

She then proceeded to Pier "E" where stores were loaded and final deployment preparations were made. On 19 August, Captain Wm. M. Russell relieved Captain Randall W. Young as Commanding Officer.

After embarking Helicopter Support Squadron THREE, Detachment 103, CAMDEN departed Long Beach for Subic Bay on 26 August. West of Hawaii CAMDEN received a request from COMPHIBRON ELEVEN for what became her first underway replenishment of the deployment. Several hundred combat Marines were returning home aboard USS JUNEAU and USS ALAMO. These ships had encountered three typhocus and were two days behind schedule with a low fuel supply. CAMDEN turned East and steamed with them along their course during the UNREP: permitting them to arrive in Long Beach on schedule.

CAMDEN departed for Yankee Station on 20 September for her first line period. This was to be a real test as over one-third of her personnel had reported aboard since the last deployment. She serviced 32 ships and never missed a committment. It was during this period that CAMDEN's motto "We're Number TWO; We Try Harder" was coined. Also, during this period, CAMDEN was visited by Rear Admiral BERGNER, Commander Service Group THREE: Vice Admiral-WEISNER, Commander SEVENTH Fleet; and Admiral HYLAND, Commander-in-Chief, U.S. Pacific Fleet. Upon her return to Subic Bay, on 9 October, she was visited by Rear Admiral O'BRIEN who had recently relieved Rear Admiral COMBS as Commander Service Force, U.S. Pacific Fleet.

After another successful line period, CAMDEN proceeded to Hong Kong for five days of R&R (19 through 24 October). Upon departure from Hong Kong, she proceeded to Yankee Station for her second line period (25 October through 7 November). She then proceeded to Subic Bay for load-out and returned for her third line period (21 November through 6 December).

Following this third line period, CAMDEN returned to Subic Bay where she off-loaded ammunition to bring her draft to 31 feet in preparation for entering India Basin in Sasebo, Japan. On 16 December, she arrived in Sasebo for her mid-deployment upkeep. During this period the crew enjoyed extensive liberty and had opportunities to sample the culture and beauty of Japan.

On 30 December, CAMDEN departed Sasebo and, at year's end, was enroute to Subic Bay.

### 3. SPECIAL TOPICS

#### a. Restricted Availability, Long Beach, California

CAMDEN was assigned a restricted availability from 27 April through 28 June at the Long Beach Naval Shipyard in Long Beach, California. After a year of continuous operation, the engineering plant was given a well-deserved rest and the "hotel" services of electricity, steam, and water were taken from the pier.

Essential repairs were made on cargo winches, elevators, and Stream heads as well as numerous vital pumps for the main engines. The ship's boilers

underwent overhaul and replacement of brickwork deteriorated by many thousands of hours of operation. The ship's crew utilized the time to renovate working and living spaces, conduct training, and normal routine maintenance.

### b. Mid-deployment Upkeep, Sasebo, Japan

From 16 December through 30 December, CAMDEN was assigned a mid-deployment upkeep period in Sasebo, Japan. The largest United States naval vessel to moor in Sasebo's India Basin, CAMDEN received vital assistance from the Ship Repair Department, Sasebo and the Repair Ship USS HECTOR (AR-7) in correcting problems and ensuring readiness to complete the remainder of the deployment. Several main engine pumps were overhauled and CAMDEN's cargo cranes were removed for a complete re-work.

The availability was an excellent rejuvination for the ship and an opportunity for the crew to enjoy Christmas in Japan.

### c. Personnel Matters

As of 31 December 1970 CAMDEN's on-board count included 35 officers and 598 enlisted men, including embarked detachments. 108 men earned advancement in rate and 28 re-enlistments were recorded.

### d. Awards and Commendations

Nine Officers and men were awarded the NAVY COMMENDATION MEDAL, 27 were awarded the NAVY ACHIEVEMENT MEDAL, and 12 received COMSEVENTHFLT Letters of Commendation.

### e. Communications

Communications recorded a total of 3,980 outgoing and 12,074 incoming messages for 1970.

### f. Helicopter Combat Support Squadron THREE, Detachment 103

Helicopter Combat Support Squadron THREE, located in Imperial Beach, California, provided the helicopter detachment for CAMDEN's third WESTPAC deployment. Detachment 103 was formed in July 1970 with LCDR Michael D. McClelland, USN as Officer-in-Charge. Five officers and 19 enlisted men flew and provided maintenance on two UH-46D helicopters.





In three line periods, during the months of September through December 1970, 9,933 tons of cargo and 296 passengers were transferred to ships on Yankee Station. 408.9 flight hours were accumulated. During this period, aircraft availability averaged 91.4%.

### g. Medical Activities

The Medical Department was manned by one Medical Officer, six Hospital Corpsmen, and four hospitalman strikers. During the year, there were 16 admissions to the Sick List. 336 injuries were treated. On 26 March, one UH-46D helicopter crashed into the sea and two survivors were rescued by CAMDEN. These men were treated in Sick Bay and were released with no apparent serious injuries. One man was air-evacuated during Refresher Training in July to the Naval Hospital, San Diego with a diagnosis of acute appendicitis. Two men were transferred to an aircraft carrier; one suffered a broken shoulder and the other suffered from amebic dysentery. There were no major outbreaks of disease. There were 8,604 Sick Call visits.

On numerous occasions, medical assistance was rendered to other ships in the form of consultations with CAMDEN's Medical Officer, medical supplies, or laboratory examinations.

### h. Chaplain's Activities

In addition to conducting Services aboard CAMDEN, the Chaplain was guest speaker in two civilian churches and one Navy Chapel. Arrangements were made for men of other faiths to worship aboardship and in Services ashore. Lay Leaders of ships without Chaplains were counselled and provided with taped religious music and religious supplies. An Ecumenical Thanksgiving Service was held with the Chaplain and the ship's religious lay leaders leading the worship. 516 men were counselled concerning personal problems. 46 Red Cross and 10 Navy Relief cases were handled.

The Chaplain co-ordinated three fund-raising campaigns in which \$5,725.44 was contributed to humanitarian agencies. Six sight-seeing tours of Singapore, the Philippines, and Japan were organized for 300 CAMDEN personnel. Three variety shows, utilizing shipboard talent, were presented for the enjoyment of the crew. A Christmas party/show was held enroute to Sasebo. At the party, every man aboard received a gift.

### b. Biography of Commanding Officer

Captain William Mason Russell, USN, was born in Fort Worth, Texas, on March 14, 1925. He attended the University of Texas for one year, after which he entered the U.S. Naval Academy where he graduated in 1946 with a Bachelor of Science degree in Electrical Engineering.

Captain Russell's initial assignment to duty in USS LEYTE (CV-32) was followed by flight training and subsequent sea duty assignments to Fighter Squadrons 702 and 22. He graduated as the outstanding student of Class 15, U.S. Naval Test Pilot School, in 1956 and was Project Test Pilot for various attack carrier aircraft at the Naval Air Test Center, Patuxent River, Maryland, until 1958.

In 1958 and 1959, Captain Russell served as Fighter and Ground Training Officer for VF-124 where he flew F8U Crusaders. From 1960 until 1961 he attended the Command Staff Course of the Naval War College. Upon completion of the course, he served as Executive Officer and Commanding Officer of VF-211 until 1963. Next he attended the Naval Post Graduate School where he earned a Masters degree in Management in 1964.

In July of 1964 Captain Russell was assigned as Personal Aide to the Vice Chief of Naval Operations. He was ordered to the USS KITTY HAWK (CVA-63) in January of 1966, where he served first as Navigator and later as Air Officer. In July 1967 he was assigned as Military Assistant in the Office of the Director Defense Research and Engineering, (OSD) and in August 1969 as a student in the Industrial College of the Armed Forces. He assumed command of USS CAMDEN on 19 August 1970.

Captain Russell is married to the former Billie June Hughes of Palo Alto, California.

### c. Biography of Executive Officer

Commander Raymond E. Helms, Jr., was graduated from the University of South Carolina in 1954 and entered the Navy in June of that year. His first duty assignment in July 1954 was as Communications Officer of USS WALDRON (DD-699). In April 1956 he was transferred to the Staff, Commander Destroyer Squadron TWENTY-TWO for duty as Staff Communications Officer.

Commander Helms' next assignment was as Executive Officer of USS WINDHAM COUNTY (LST-1170) beginning in February 1958. He continued to serve in WINDHAM COUNTY until February 1959 when he was transferred to the Staff, Commander Landing Ship Squadron FIVE, as Staff Operations and Plans Officer.

In June 1960, Commander Helms attended Navy Management School at the



Naval Postgraduate School in Monterey, California where he earned a Master of Science degree in Management. Upon completion of the course in June 1961, he attended the Transportation Management School, Naval Supply Center, Oakland, California until December 1961.

Commander Helms was next assigned as Executive Officer, Military Sea Transportation Service Office, Manila; a billet he held until January 1964. In February of that year, he was ordered to USS CHICAGO (CG-11) in San Diego as Navigator and served until detached in April 1966.

Commander Helms commanded the Military Sea Transportation Service Office, Long Beach from 30 May 1966 to 5 February 1968. From March 1968 until March 1969, Commander Helms served on the Joint Staff of Commander Military Assistance Command, Vietnam with headquarters in Saigon. He reported to USS CAMDEN (AOE-2) on 14 April 1969.

Commander Helms and his wife, the former Miss Marguerite Allmann of Waconia, Minnesota, together with their three children, Cynthia, Raymond, and Christa, reside in Garden Grove, California.

### d. Change-of-Command Ceremony

On 19 August 1970, Captain Wm. M. Russell, 485547/1310, USN relieved Captain Randall W. Young, 521989/1100, USN as Commanding Officer, USS CAMDEN (AOE-2).

The ceremony took place aboard CAMDEN at Long Beach Naval Shipyard, Long Beach, California.

The ceremony was attended by Captain John S. Oller, Jr., USN, Commander Service Group ONE and local military and civilian dignitaries.

A reception following the ceremony was held in the Wardroom and Crew's Mess aboard CAMDEN.
