

## CAMP LEJEUNE AND FIELD EXERCISE COMPLETE MILITARY TRAINING

On August 15, approximately 200 Seabees of NMCB-71 boarded planes at Quonset Point, Rhode Island for two weeks of crew served weapons training at Camp LeJeune, North Carolina. The Seabees arrived at Camp Geiger, a small world war II compound in the southern section of the world's most complete training facility.

Despite seven days of drenching rain, mud, bugs, and heat, SEVENTY-ONE's Seabees practiced the second half of their motto, "...We Fight". Sitting in open air classrooms, marching through the mud, living on C-Rations, the Seabees listened, watched, and occassionally outdid their instructors firing rockets, mortars, and bullets, anywhere from eight to sixteen hours a day.

When Friday, August 26 came around, the Seabees were looking forward to returning home to families and friends. However, tropical storm Doria had other ideas. All flights were delayed 24 hours. Spirits were dampened, but a well earned two-day weekend restored them when the men returned to Davisville.

To complete the homeport military training cycle,

the entire battalion participated in a three-day and two-night Field Exercise at Camp Fogarty. After a tactical march to their designated area, the men set up a temporary 360 degree perimeter while Alfa Company's Equipment Operators bulldozed a permanent perimeter. Barbed wire was strung on posts and concertina wire rolls made the area almost impenetrable.

The men dug fox holes, set up weapons, and prepared

for two days of "enemy" (military training instructors) harrassment. The heavily barbed wire perimeter and tight security paid off.

The general opinion was that this year's exercise was better planned and more realistic than past exercises. Camp Fogarty was, for many, the introduction to helmets, rifles, and fox holes. Much was learned about patrols and ambushes, excape and evasion, and, of course, cleaning weapons.

#### HISTORICAL SUMMARY

The month of August was characterized by involvement in predeployment planning. The Commanding Officer, Operations Officer, and Senior Enlisted Advisor completed a predeployment visit to Diego Garcia. Island Commander and Detail Chagos concept of operations was confirmed by joint letter of 16 AUG 1971. In homeport, project planning progressed to the point where project dependency diagrams, manday estimate work sheets, and material take offs for all Diego Garcia projects were submitted to COMCBLANT Diego Garcia Planning Staff for review and promulgation. This concept of deployment planning is a unique innovation, and will enable the COMCBLANT Diego Garcia Planning Staff to completely control the planning, estimating, material expedition, and execution of island jobs.

Antarctic planning and transportation scheduling of critical project materials also approached final phases of implementation, with all major problems resolved. Since this will be the first NMCB-71 deployment to the Antarctic Continent, command and support relationships with other Antarctic activities continue to be resolved.

Homeport training continued at high level of effort, marked by the two week deployment of a 220 man Det Lejeune for heavy weapons training. On the job training on a wide variety of homeport projects and fleet details enhanced skill levels of all rates. Formal NAVSCON schools and cross-rate training tailored to identified deployment rate/rating requirements has also brought up skill levels and contributed greatly to the Battalion's ability to respond quickly to any Seabee tasking.
