2017 Manufacturing Vote Record Key California Manufacturing Bills

The votes used in this record reflect the first time legislators voted on the substantive policy represented in a bill after having been informed of CMTA's position on the policy and its positive or negative impact on manufacturers and technology companies. In some cases, substantive amendments to the bill led to a change in CMTA's positions. The date of the vote used is noted for each bill.

AB 378 (C. Garcia/E. Garcia/Holden) Cap-and-Trade – OPPOSE

Extends a diminished cap-and-trade program without industry-supported reforms designed to prevent price spikes or support continued California manufacturing operations. Status: Failed Passage, Assembly Floor - Two-Year Bill

Vote record: Assembly

AB 398 (E. Garcia) Cap-and-Trade Extension/Sales and Use Tax Exemption – SUPPORT

Extends California's cap-and-trade program and implements positive reforms that include 100 percent industry assistance through 2030, a price ceiling and intermediate price controls (known as 'speed bumps'). Also extends the partial Sales and Use Tax Exemption for manufacturing and R&D equipment purchases from 2022 to 2030.

Vote record: Assembly & Senate Status: Signed by the Governor (Chapter 135)

AB 450 (Chiu) Employer Response to Immigration Enforcement Actions – OPPOSE

Requires an employer to demand a warrant or subpoena before allowing ICE access to their facility or employment records including I-9 Employment Eligibility Verification.

Vote Record: Assembly

Status: Signed by the Governor (Chapter 492)

AB 958 (Ting) Hazardous Materials – Per & Polyfluoroalkyl – OPPOSE

Requires DTSC to revise the 2015-2017 Priority Product Work Plan to include food contact substances containing fluorinated chemicals for consideration and evaluation under the Green Chemistry Program. Vote Record: Assembly **Vote Record: Assembly** Status: Held in Senate Appropriations – Two-Year Bill

AB 1209 (Gonzalez Fletcher) Perceived Gender Pay Differentials – OPPOSE

Requires employers to collect data related to the wages paid men and women within the same job classification or title and to submit that information to the Secretary of State to be publicly posted and attributable to individual companies. Vote Record: Assembly & Senate Status: Vetoed by the Governor

AB 1250 (Jones-Sawyer) Ban on Outside Contracting - OPPOSE

Effectively prohibits counties from contracting with nonprofits, licensed professionals and other providers for local services by imposing significant new restrictions. Manufacturers that provide vital services, such as operating and maintaining modern 911 systems, will be shut out of contracts.

Vote Record: Assembly

Status: Held in Senate Rules – Two-Year Bill

AB 1565 (Thurmond) Another Minimum Wage Increase – OPPOSE

Accelerates the minimum wage increase on exempt employees by requiring all employers to pay them at least \$47,472 starting January 1, 2018. Vote Record: Assembly Status: Senate Inactive File – Two-Year Bill

AB 1583 (Chau) Prop. 65 Enforcement – SUPPORT

Makes the factual basis discoverable and authorizes the Attorney General (AG) to respond to both the private enforcer and the alleged violator if the AG reviews the factual basis and believes there is no merit to the claim(s). **Vote Record: Assembly & Senate Status: Signed by the Governor (Chapter 510)**

SB 49 (de León) Blank Check for CA Environmental Regulators – OPPOSE

Creates uncertainty for California manufacturers by locking in federal air and water quality baselines for California agencies, regardless of whether the federal government rolls back or weakens those standards. Contains a private right of action with a one-sided attorney's fees provision.

Vote Record: Senate

Status: Held in Assembly Rules – Two-Year Bill

SB 63 (Jackson) Mandated Parental Leave – OPPOSE

Requires small employers (20-49 employees within a 75-mile radius) to provide up to 12 weeks of protected leave to employees for bonding with a new child within the first year of birth, adoption or foster care placement. **Vote Record: Assembly & Senate Status: Signed by the Governor (Chapter 686)**

SB 66 (Wieckowski) Prohibits tax deductions for punitive damage awards- OPPOSE

Prohibits tax deductions currently permitted as ordinary and necessary business expenses for money paid for punitive damage awards, beginning on January 1, 2018.

Vote Record: Senate

Status: Held in Assembly Revenue & Taxation – Two-Year Bill

SB 100 (de León) GHG Emissions – OPPOSE

Accelerates existing 50 percent Renewable Portfolio Standard (RPS) mandate to 2025 and adds a new 60 percent RPS mandate in 2030. Also requires that 100 percent of energy come from renewable resources by 2045.
Vote Record: Senate Status: Held in Assembly Utilities and Energy – Two-Year Bill

SB 258 (Lara) Cleaning Product Ingredient Disclosure – OPPOSE

Requires manufacturers of cleaning products to disclose ingredients on the product label and their website, including Prop. 65 chemicals down to 0 parts per million, exposing manufacturers to potential litigation and damaging baseless public accusations.

Vote Record: Assembly & Senate

Status: Signed by the Governor (Chapter 830)

SB 562 (Lara/Atkins) Single-Payer Healthcare – OPPOSE

Establishes the Healthy California Act, a government-run universal healthcare coverage program. Vote Record: Senate Status: Held at Assembly Desk – Two-Year Bill

SB 772 (Leyva) Cal/OSHA Regulations – OPPOSE

Creates a special exemption for Cal/OSHA from the cost-efficiency and accountability requirements currently in place for all California agencies implementing regulations with a yearly economic impact of \$50 million or more, resulting in less oversight for the most impactful regulations placed on manufacturers.

Vote Record: Senate

Status: Held on Assembly Floor – Two-Year Bill
