STORING YOUR PERSONAL DATA

We will only retain and use your personal information for as long as we need it for the purposes set out in this privacy policy or as otherwise required by law.

Unfortunately the sending of information via the internet is not totally secure and on occasion such information can be intercepted. We cannot guarantee the security of data that you choose to send us electronically and therefore sending such information is entirely at your own risk but once received, all information is stored on our secure servers and we have in place a level of security appropriate to the nature of the information stored and the harm that might result from a breach of security.
