## Loyola Law School Reaches Out

THE LOYOLA LAW COMMUNITY pulled together to assist those affected by Hurricane Katrina by welcoming students from New Orleans law schools; launching food, clothing and fundraising drives; participating in legal clinics; and even traveling to help with direct relief efforts.

Four students from New Orleans—three from Tulane University School of Law and one from Loyola New Orleans School of Law—joined the Loyola campus in early September. The students were welcomed to Loyola at an orientation session on September 6th, which was followed by an interfaith service in the Chapel of the Advocate and a school-wide barbecue. Additionally, an impressive number of alumni and students were quick to offer shelter, housing, transportation and financial support, and Los Angeles-area law firms also contacted the school with generous offers of support.

"In spite of being uprooted from the city that care forgot, Loyola Law School has been nothing short of phenomenal in this difficult time," said Amber Dattilo of Tulane. "The administration, faculty, staff and students have shown overwhelming support and encouragement."

In addition to opening classes to affected students, Loyola Law School faculty and students are working with organizations like the Los Angeles Pro Bono Counsel, Bet Tzedek and Public Counsel to provide legal assistance to those who were evacuated to Los Angeles. Also, long-time Loyola Law staff member and Mississippi native Art Rennick volunteered with the American Red Cross in the Gulf Coast.

Of the School's efforts, Dean David Burcham '84 said: "I am very pleased to welcome the students from New Orleans and I am very impressed with how our students, staff, faculty and alumni pulled together so quickly to help out. As always, they worked hard to put the School's ideals into action."



## Loyola JDs in Non-Legal Careers

Why attend law school if not to practice law? Law librarians, entrepreneurs, talent and sports agents, legal and executive recruiters and tax consultants are good examples of those who benefit from a juris doctor.

A legal education is both challenging and broadening. Research and writing, public speaking, critical thinking, attention to detail and understanding regulatory frameworks (like zoning and code requirements) are just some of the skills developed in law school that are transferable to non-legal careers. "The JD gives professionals credibility. Also, the ability to draft specialized business contracts for employment, leases and purchases and sales, for example, is a useful skill for an entrepreneur," said Graham Sherr, assistant dean for career services at Loyola.

Many Loyola Law School graduates chose non-legal careers, including **Christopher A. Calarco '97**, a special agent with the FBI in Los Angeles, and **Christopher W. Silva '89** (LMU '86), president and chief executive officer of St. Francis Winery & Vineyards in Santa Rosa.

Even while attending Loyola, Calarco hoped for a career with the FBI and interned with the Bureau. Following graduation, he worked as a deputy district attorney in LA and waded through the FBI's lengthy application process. He was later offered a position with the FBI and now serves on its Violent Crime Squad (VCS) and its eight-member, rapid deployment Art Crime Team (ACT).

Calarco's work with the VCS includes investigating kidnappings, extortion, murders-for-hire, major thefts and assaults against federal officers and judges. His assignments with ACT cover cultural property crimes concerning stolen artifacts, antiquities and fine art. One of his team's most recent accomplishments was recovering a \$40 million Rembrandt through a sting operation in Copenhagen.

myself leaving the law to help manage a winery, but this was an exciting opportunity in an area and an industry that I essentially grew up with."

"I put much that I learned studying and practicing law to use each day running a winery," said Silva. His new career involves reviewing contracts, maintaining compliance with state and federal regulations, minimizing exposure in personnel matters and maintaining a safe workplace. "Good executives, like good litigators, must be quick on their feet, communicate effectively and strategize quickly based on an efficient but careful review of the facts. I think we'll continue to see more lawyers enter the business world, particularly lawyers who study and represent businesses. I wouldn't trade what I am doing now for anything, but if it all ended tomorrow I would go back to practicing law and consider myself quite fortunate to do so."

## Loyola Law School Named One of Best Law Schools by *The Princeton Review*

Loyola Law School was named one of the nation's most outstanding law schools by *The Princeton Review*. Out of 159 law schools, Loyola ranked 3rd for "Best Overall Academic Experience," 3rd for "Professors Rock" and 6th for "Best Environment for Minority Students."

Additionally, Loyola Law School scored, out of 100, a 98 in the academic experience rating; a 98 in the professors interesting rating; and a 96 in the professors accessible rating. Also noted in the profile are Loyola's "great research resources," its "abundant externship, internship and clerkship opportunities" and that "diverse opinions are accepted in the classroom."

The profile also highlights Loyola's "reputation for producing renowned litigators," its "emphasis on practical application, skills classes and real-world experience," that it has a "great reputation among employers in the Southern California area" and "a large alumni network of successful and respected lawyers in California."

On being recognized as one of the country's outstanding law schools, Dean David Burcham '84 said, "We are very pleased to be included in this survey and that our profile recognizes so many of the terrific things happening on our campus."

The rankings are based on institutional data from the schools and on surveys of 15,000 students attending the schools. The survey asked students over 50 questions and was conducted during the 2004-05 and 2003-04 academic years.
