The Soccer 4 Pool Rules The Rules - Effective August 2011

The Soccer 4 Game ("**Game**") is operated by Phumelela Gold International Limited ("PGI"). PGI is registered in the Isle of Man (company number 109784C) and its registered office is at 19-21 Circular Road, Douglas, Isle of Man IM1 1AF. PGI holds an online gambling licence issued by the Isle of Man Gambling Supervision Commission.

The Football Pools Limited holds authority from PGI to place bets, on behalf of its customers, into PGI's pools and distribute any winnings to such customers. All bets in relation to the Game are placed directly with PGI into the PGI pools and a bet placed in relation to the Game is only confirmed once it has been accepted by PGI in accordance with the Game rules. In circumstances where bets do not reach the PGI pools (for any reason), customers will have their stakes refunded and The Football Pools Limited will not be liable for any loss of winnings that would have been due had the bet reached the pool.

If a customer has any queries or complaints regarding the Game, in the first instance, all such queries/complaints should be raised with The Football Pools Customer Services Department at help@footballpools.com or The Football Pools, Customer Services Dept, Walton House, Charnock Road, Liverpool L67 1AA.

Below is a summary of the rules relating to the Game. PGI's rules apply to any point not covered in the summary below. For further information about PGI and its rules, contact PGI at the address set out above.

1. General

1.1. By placing a bet in relation to the Game, a customer agrees to be bound by these Rules.

1.2. Appropriate steps will be taken to bring any changes to the Rules to the attention of customers. Any bets placed by a customer in the Game after such amendment and notification will be deemed to be its acceptance of the changes to the Rules. Any bets accepted prior to the time of amendment and notification of the changed Rules will be subject to the pre-existing Rules.

2. Customer representations

2.1. You are over 18 years of age.

2.2. You can enter into a legally binding agreement with PGI.

2.3. You understand that by using PGI's services you may lose money on bets placed and accept that you are fully responsible for any such loss.

2.4. You will not use PGI's services while located in any jurisdiction that prohibits the placing of bets.

2.5. You warrant that you are acting as a principal and not as an agent on behalf of a third party.

2.6. You shall ensure that your bet contains no ambiguity or difficulty in interpretation. You acknowledge that your bet may not be accepted if it is illegible or incomplete.

2.7. You acknowledge that PGI has total discretion to refuse to accept or to disqualify a bet if it is:-

- i. not accompanied by the correct stake,
- ii. not received and accepted in accordance with these Rules or the genuineness of the bet is doubtful,
- iii. sent in by a person under the age required,
- iv. incomplete, incorrectly completed, ambiguous, illegible or indecipherable; or
- v. in breach of any of these Rules.

Any stake received in respect of a disqualified bet will be refunded. Upon request, the customer shall promptly repay any winnings that have been paid to it in relation to a disqualified bet.

3. The Game

3.1. Purpose: The purpose of the Game is to select the result of four soccer matches as designated on the official match list for each event. There are six possible results for each match 1 - Team A to win by 1 goal, 2 - Team A to win by 2 or more goals, 3 - a no score draw (0-0 only), 4 - a score draw (example 1-1; 2-2) 5 - Team B to win by 1 goal and 6 - Team B to win by 2 or more goals.

3.2. Unit of Betting: Each bet placed by an authorised collector on behalf of a customer is converted to a number of units (the value of each such unit having been determined by PGI). PGI may (at its discretion) accept bets where the stake per bet is calculated at more or less than the full unit, save that any winnings paid in respect of such bets shall always be calculated in proportion to

PGI's full unit price.

3.3. Results: All results are based on the score at the end of the normal 90-minute playing period plus any injury time that may be played. It shall not include extra time or penalty shootouts.

3.4. Calculation and Declaration of Dividend: PGI will declare a dividend based on official results of matches as provided by official sources of all matches, e.g. Press Association and other designated official sources. The dividend shall be determined by dividing the net pool by the total number of unit bets on the winning combination/s. PGI's declared dividend will be based on its full unit price.

Please note that the declared dividend, as stated on authorised collectors' websites, shall be based on PGI's unit price as set out above converted and declared to a £1 entry stake (and, as such, shall differ from the dividend as stated on any PGI or PGI group company website).

3.5. Early Matches: In the event that a match started earlier than the advertised time, that is, before the close of the pool, and PGI was not in a position to close the pool at the start of such match, all possible results/combinations will apply as the final result for that purpose and for purposes of calculating a dividend.

3.6 Winnings: Winnings are awarded only in respect of bets accepted by PGI that have all four predictions correct.

3.7. Results: Official Super 4 payouts are declared as soon as the official results of all the matches are received by PGI (normally the day after the last matches in the pool).

3.8. Abandoned, Cancelled and Rescheduled Matches: Any match not completed by 9 am (South Africa time) on the day after the last day on which matches relevant to a particular Game were scheduled shall be deemed abandoned and all choices shall qualify for purposes of calculating a dividend and an entitlement to winnings. The times at which matches are completed will be as supplied by PGI's official source. PGI reserves the right to extend the time for a match to be completed if circumstances warrant and provided this does not unduly hamper the declaration of results and dividends.

3.9. Refunds: If all the matches, as designated in the official match listing, are abandoned, all stakes shall be refunded. If for any reason any bet, Game and/or pool is declared void, the relevant stakes will also be refunded.

3.10. Carry Forward: Should there be no winning bets on a Game, the net pool for that Game shall be carried forward and added to another Game's

pool, selected at the discretion of PGI, provided that such carry forward is made within one month of the original Game to which it related or, where a Game is the last event of a particular season, the pool shall be carried forward and added to another Game's pool within one month of the commencement of the new season.

3.11. Exchange Rates: The exchange rate will be set by PGI as soon as a Game opens and will be held at that rate until the prizes are calculated and declared.

3.12. Payment of Winnings: Winnings will usually be paid without the customer needing to claim and, where a bet is placed online, the winnings will usually be credited to the customer's account in accordance with the relevant website's terms and conditions. However if a bet is placed through an authorised remote terminal system which issues a printout with the details of the predictions, any winnings will be paid only as follows, unless the customer is notified otherwise:

- i. An authorised outlet will pay the winnings to whoever presents the winning printout if they are within the limits to which such outlet is subject and subject to validation; or
- ii. If the winnings are above the limits to which such outlet is subject, winnings will be paid upon receipt by the relevant authorised collector (in this case The Football Pools Limited) of a completed claim form from the customer as issued by an authorised outlet or the original printout.

Under normal circumstances (and save as set out above) the relevant authorised collector (in this case The Football Pools Limited) will endeavour to pay Winnings no later than seven days following the date of the last match played. Any query regarding winnings should be made within six weeks from the relevant Game date to which such query relates and directed to the relevant authorised collector (in this case The Football Pools Limited) in the first instance using the contact details set out in these Rules.

3.13. Integrity: Winnings may be withheld and/or any individual bet or Game may be declared void, or any individual match may be declared a void match if it is reasonably believed that:

- (i) The integrity of a match has been called into question;
- (ii) The pool has or may have been manipulated or its integrity has otherwise been called into question; and/or
- (iii) Match-rigging has or may have taken place.

Such belief may be based on the size, volume or

pattern of bets placed or any announcement, investigation, instruction or decision made by any competent authority, sports body or other relevant authority or body. The customer acknowledges that information (which may include customer personal information and betting history) may be shared with regulators, sports bodies and other authorised bodies (including the police) for the purpose of investigating fraud, suspicious betting activities, money laundering or sports integrity issues.

4. Errors and Discrepancies

4.1. In the event of any apparent discrepancy between any results in respect of any PGI service in which a customer participates as communicated to it and the corresponding results on PGI's systems, the results as they appear on PGI's systems shall take precedence.

4.2. Despite every effort to ensure complete accuracy, in the event of any typing, human or obvious error which leads to any errors or omissions, including in relation to the publishing of estimated prize funds and pools, announcing of dividends or results other than those intended, or bets being taken which contravene these Rules, the relevant bet shall be accepted (or disqualified) on the basis of the corrected information.

4.3. Submission of a bet will not be proof of receipt by PGI or acceptance into the relevant PGI pool. To constitute an accepted bet, such bet must be recorded on PGI's central computer system before the pool closes (which shall, subject to paragraph 3.5, be at the start of the earliest match). If for any reason a bet is not so recorded on PGI's central computer system before the relevant pool closes, the stake relating to such bet shall be refunded (and PGI's systems shall be deemed conclusive in this regard).
