## **AB 12 Success Story**

The Juvenile Unit was able to share an incredible life changing experience with one of our Foster Youth. This young lady has had to overcome and endure many personal and extenuating challenges. Despite the upheaval in her already chaotic life, she remained focused in school, volunteered in various employment opportunities and remained dedicated to her future plans toward independence. Upon her 18<sup>th</sup> birthday, she was faced with the harsh reality of attempting to establish her independence while attending school full-time and working a part-time job. She was provided AB12/212, Extended Foster Youth services and continued to move forward in her life. Further, she remained determined to complete high school, ultimately earning her high school diploma. Although, shortly after turning 19 years old, she found herself homeless and with no family to seek support from. Teaming together with some county and community agencies, she was able to locate a local family who was willing to take her into their home temporarily until a longterm or permanent placement could be found.

In doing so, this young lady not only found herself in a new place of residence, but also found her way into their hearts, soon becoming an integral part of the household, and more importantly, a member of their family. Not only did this young lady find a home, she found a family and her foundation. One year later, in the spring of 2014, this family completed an adult adoption, adopting her at the age of 20 years old! She has since blossomed into a vibrant and outgoing young adult whose ambitions now include obtaining a college degree. She continues to work two parttime jobs, one of which she receives fresh vegetables in exchange for her labor. Given her personal hardships and life experience, she will often seek out the homeless, giving the fresh vegetables she earned. When asked about her future plans, she states she will never forget where she came from, and despite life's bumps, she is capable of accomplishing anything she sets her mind to. But most of all, she is thankful for the loving family who embraced her as their own. She now has a family and a place to call "home"!

The recent expansion of the Juvenile Hall garden has proved bountiful! Under the direction of Juvenile Hall Cooks, Lynn Slay and Jessika Munroe, the incredible success of the garden and orchard has allowed the minors to enjoy a wide array of fresh fruits and vegetables in their meals, as well as the ability to assist in the planting, nurturing and harvesting of these foods.

The harvest has provided 8 different varieties of tomatoes, multiple varieties of peppers, squash, berries, apples, nectarines, pears and grapes. These fresh items are incorporated into many of the homestyle dishes that the minors and staff enjoy including; chili verde, chili relleno, salsa, tomato soup, fajitas, jalapeno poppers, smoothies, zucchini bread and peach pie.

In the coming years the hope is to expand the orchard and plant a wider variety of fruits and vegetables in the garden. With the spirit of community service that the department embodies, a plentiful harvest in the coming year would allow the Juvenile Hall to share the bounty with the local food bank.

#### MAMA TERESA'S KITCHEN



#### Yummy Gluten- and Sugar-Free Chocolate Coconut Cake

#### Ingredients:

2 cups packed almond meal (raw almonds whirred in food processor to a flour-like consistency...also, I've used pecans, too.)

4 + cup dark cocoa powder (use more if you like it chocolaty)

¾ tsp baking soda

½ + cup shredded coconut (use more if you like it coconut-y)

Pinch salt

2 cups packed pitted dates

¾ cups cold, strong coffee

4 eggs

2 1/2 Tbsp coconut oil

2 ½ tsp vanilla

Soak dates in the coffee for several hours (at least) to soften, stirring occasionally.

Preheat oven to 325 degrees.

Liberally grease 9" springform cake pan.

Mix dry ingredients and set aside.

Place dates/coffee liquid in food processor and process to a smooth paste.

Process date mixture, eggs, coconut oil and vanilla until smooth.

Add wet ingredients to dry ingredients and stir until smooth.

Pour into greased cake pan.

Bake 25 to 30 minutes. It will look undercooked but that's okay...you want it a little gooey.

Let cool before inverting pan and serving. I chill cake, dust with powdered sugar and serve cold with fresh whipped cream or ice cream, and garnish with fresh mint.
