

ELEVATIONS IN PENNSYLVANIA

THE following list has been prepared to answer questions regarding the elevations of cities, boroughs, lakes, and the high and low points of each county. Several articles have been published in the Department of Internal Affairs Monthly Bulletin (April 1936, pp. 16-22; August 1944, pp. 10-14) giving some of these statistics, but a complete list for each county was not possible until topographic mapping of the State had been completed. Revision of many of the older maps still is needed, but State coverage has been completed with the very accurate mapping of the north central counties within the past few years.

The elevations given in the list have been taken from these topographic maps, which show by contour lines, at intervals of twenty feet on most maps, the shape of the surface and its elevation above sea level. The exact elevation of a hill or mountain is sometimes given on the maps, but in many cases the elevation must be taken from the highest contour line. An elevation figure ending in zero on the list, therefore, may be exact, but, if not, is within twenty feet below the actual elevation.

The lowest elevation in each county is on a stream or river flowing out of the county. The elevation figure used is the lowest contour line crossing the river before the county boundary is reached. In almost every case, therefore, the low point will be within twenty feet below the figure given.

Lake and reservoir elevations are usually given in exact figures on the maps. Reservoir elevations not shown on the maps were supplied by the Division of Dams, Department of Forests and Waters.

City and borough elevations have been taken from the maps and from a report on elevations,² and the figures given are, in most cases, for a specific point or bench mark within the city. One elevation cannot, of course, represent an entire city or borough. The elevation of Harrisburg, for example, is listed as 357 feet, a bench mark in Capitol Park, but the elevation is approximately 300 feet on the Susquehanna River bank, and 320 feet at the Pennsylvania Railroad passenger station. When no precise elevation exists on the map or in the report, the elevation given often represents the general elevation of the central part of the city, the level of the main street, or the elevation of the river on which the city is situated.

The highest and lowest points in Pennsylvania are as follows:

High point: Mt. Davis on Negro Mt., Somerset Co., 3213.

Highest city: Hazleton, approx. 1700.

Highest county seat: Somerset 2190.

Highest borough: Berlin, Somerset Co., 2322.

Highest settlement: Pocohontas, Somerset Co., 2660.

Highest lake: Ganoga Lake, Sullivan Co., 2265. (There may be a few small ponds not noted on this list at higher elevations.)

Low point: sea level on Delaware River, Penna.-N. J.-Del. state line.

Lowest cities and boroughs: Bristol, Philadelphia, Chester, Marcus Hook, and other boroughs below Bristol on Delaware River all have land below 20 feet.

Twp., about one-half mile north of Cameron-Elk county line, south of Big Basin Hollow; many points over 2320 in Shippen, Lumber, and Grove twps.

Low point: 740 Sinnemahoning Creek, Cameron-Clinton county line.

Carbon County. Plateau (northeastern section of county) 1700-2000.

Ridge and Valley section—ridges 1500-1900.

High point: 2240 two points on Blue Mt., 1-2 miles northeast of Franklin-Perry-Cumberland county junction.

Other high points: 2100 Big Pine Flat Ridge, extreme southwest corner of county; 2080 Big Flat, north of Cumberland-Adams county line, Southampton Twp.; 1982 Flat Rock, Blue Mt., Lower Mifflin-Upper Frankford twp. line.

Low point: 291 Susquehanna River, junction of Cumberland, York, and Dauphin counties.

Dauphin County. Ridge and Valley section—ridges 1200-1700. General elevation of Appalachian Valley and Piedmont sections 400-700.

Reservoirs: Crum Creek Reservoir 112; Springton Reservoir 208.

Elk County. Plateau—Allegheny Mountains section 1600-2300.

High point: 2376 Wildwood Fire Tower, Jones Twp.

Other high points: 2360 Boone Mt. Fire Tower, Horton Twp.; 2340 northwest corner Benezette Twp., just south of Elk-Cameron county line; 2300 Red Hill and northeast of Red Hill, Jay Twp.; many points over 2300 in eastern part of county.

Erie County. Lake Erie Plain 600-900. Plateau 1000-1800. Land slopes from southeastern corner of county to Lake Erie.

Franklin County. Ridge and Valley section—ridges 1600-2400. General elevation of Appalachian Valley section 500-700. South Mountain section 1600-2050.

High point: 2440 Big Mt. on Tuscarora Mt., Metal Twp.
