# Summer 2003 Newsletter

“SUMMER TIME...AND THE LIVING IS (USUALLY) EASY,” to paraphrase a popular tune: warm, sunny days; picnicking; relaxing on the beach; and enjoying the cool waters of Lake Michigan. But last summer swimming came to a sudden halt when 69 people became ill after swimming at Nicolet Bay and several other beaches in Door County. Testing of the major beaches began immediately and continued throughout the summer with a number of additional beaches being closed periodically whenever an E. coli count reached 235 or more. This was a “first” for Door County; to anyone’s knowledge, there was no record of beach contamination or closings with which to compare. The E. coli count is important because it is an indicator of human or animal fecal contamination that can cause disease.

This year Door County Board of Health (BOH), Soil and Water Department (SWCD), and the Sanitarian’s office are collaborating on a program to protect our beaches and water resources. With Door County’s 250 miles of shoreline and 52 public beaches (more than any other County in the State), the potential for beach contamination is great. With a \$75,000 grant from the Dept. of Natural Resources (DNR), four trained student scientists from UW-Oshkosh began a standardized program of testing/monitoring and signage on May 19.

Thirty-one beaches with an existing record of contamination or the greatest vulnerability to pollution are being tested regularly: 13 (including Whitefish Dunes beach) will be tested daily; another 13, twice weekly; and two more, once a week. Three inland lakes, Clark, Kangaroo, and Europe, will also be tested regularly. A laboratory, certified/licensed by UW-Oshkosh, has been set up at Sturgeon Bay Utilities wastewater treatment plant for a quicker turnaround reporting time. Signs will be posted based on the E. coli count: if between 235 and 1000, an advisory sign will read

“Water Quality Is Poor—Don’t Swim”; with a count of 1000 or greater, the sign will say “Closed—Don’t Swim.” Accurate records are being kept to provide a benchmark for comparison.

Unfortunately little is known about the cause(s) of beach pollution. However prime suspects are human feces

and polluted runoff from pesticides, animal waste, oil and grease and construction sites; seagull droppings; and failing municipal and private septic systems. SWCD has been charged with researching the source of contamination. Funds from a grant will enable the department to gather a task force of experts to formulate a program to determine cause(s). The Sanitarian’s office is conducting a survey of sanitary systems throughout the County for failure to comply with state and local codes.

And what are some precautions each of us can take? Be alert for signs of pollution, report illness that appears to be connected with swimming to the County BOH; keep impervious surfaces clean of oil, grease; use pesticides, fertilizer very sparingly; put rubber pants on young children when swimming; keep beaches free of litter; take note of large flocks of seagulls, especially after a storm. In other words, ADOPT A BEACH!

## Dog Ordinances



All dogs in the Town of Sevastopol are required to be licensed. Licenses can be obtained through the town office with proof of vaccination and a small fee. Contact Linda Wait @ 746-1230.

Residents and guests alike are reminded that both Door County and the Town of Sevastopol have

specific Dog Ordinances that include: running at large or not under control of its owner or other responsible person except on one's own property, and vicious, howling or barking animals. Penalties are financial for each day's occurrence. In light of the beach water contamination problems we experienced last year and will likely see again, every dog owner is asked to pick up after their animals, whether on the beach or inland. While dog droppings are not the single cause, they are a contributor. Proper disposal is important. Burying on the beach is not an acceptable means of disposal.

## Personal Watercraft Laws

As the warmer weather approaches we are reminded of the Wisconsin Personal Watercraft (PWC) Laws. All residents, guests and renters should be aware that PWC regulations apply to our Lake Michigan waters. In addition to boating regulations, the following are some PWC laws:

- ⇒ No operation from sunset to sunrise
- ⇒ All persons riding must wear a Personal Floatation Device of proper size
- ⇒ Ignition safety lanyard must be attached to the operator
- ⇒ No one under age 12 may operate a PWC (Rental age limit is 16).
- ⇒ Operators age 12 to 16 must have a state-approved boating safety certificate.
- ⇒ Operation of a PWC within 100 feet of another boat, skier, public boat landing or PWC unless at no wake speed is prohibited.
- ⇒ PWC's are restricted to slow-no-wake speed within 200 feet of the shoreline.

Let's keep boating and Personal Watercraft use safe on Whitefish Bay.
