GMTAG campaigns for transport policies that reduce traffic, improve bus & rail services, promote walking & cycling, and make maximum use of rail & water for freight transport.

Ken Child was a founder member of GMTAG & led the group for many years. He campaigned tirelessly & expertly for better transport on behalf of people in Greater Manchester & further afield, right up until he died in early 2000. This archive represents most of the transport-related holdings that Ken acquired over the years.
