FIRST ENDORSEMENT on COMSTSLANT Orders Ser 256L11 of 30 December 1969

Subj: Release from Active Duty

1. Examined and found physically qualified for separation in accordance with article C-10409, BUPERS Manual.

2. As verified by your officers leave record (NAVPERS-329) your earned leave credit computed through the effective date of separation is thirty one (31) days.

3. Detached 1600, 2 January 1970. You are granted (1) one day travel time computed on the basis of the time required to travel by private conveyance in returning to your home of record when ordered to active duty, upon the expiration of which at 2400 on 3 January 1970 you will regard yourself released from all active duty and transferred to inactive duty in the U.S. Naval Reserve. Reimbursement for travel time subsequent to detachment will be in accordance with detailed instructions contained in the Navy Comptroller Manual.

4. According to your service record you were ordered to active duty from Groton, Massachusetts and your home of record at the time was Groton, Massachusetts. You have elected to receive mileage allowance to Groton Massachusetts in connection with these separation orders.

5. You have stated that upon release from active duty your "mailing address", the place at which you may be reached at any time by orders or other official communications, will be:

Inform the command having custody of your service record as set forth below of any change of "mailing address". Upon release to inactive duty your records will be forwarded to the Naval Reserve Manpower Center, Naval Training Center, Bainbridge, Maryland. Any questions regarding your status should be addressed to that command and should include your full name, grade, and service number, branch and class of service and mailing address.

6. You are advised that your release from active duty does not terminate your status as a member of the U.S. Naval Reserve. On the day following the effective date of your release from active duty as specified in paragraph 3 of this endorsement, you will assume the status of a member of the Naval Reserve on inactive duty. While on inactive duty you are subject to involuntary recall to active duty to the extent authorized by federal statute. Inform the command having custody of your service record, in accordance with paragraph 5 above, of any change in health which might prevent active service in time of war. You shall promptly answer all official correspondence addressed to you as such and shall promptly comply with instructions contained therein.

7. In the event that you plan travel or residence in foreign countries for a period in excess of 30 days, notice of intent will be submitted to the command having custody of your service record. Such notice should include destination, expected duration of travel or residency, and forwarding address.

1. I have recently been offered an opportunity to become a candidate for Congress from the Third Congressional District, Commonwealth of Massachusetts. 

7. Within three days prior to detachment complete applicable items on travel information card (NAVPERS 2850) and submit to OIC, Navy Family Allowance Activity (PCSVAD), Cleveland, Ohio 44199.
8. Travel via privately owned vehicle authorized.
9. Upon release you are urged to contact nearest Naval Reserve Training Center for information relative to Naval Reserve Training Programs. Participants in Naval Reserve Training Programs may earn retirement points, and drill pay if billet available.
