**Prof. Ivan Shearer** is Challis Professor of International Law at the University of Sydney. He is currently visiting the U.S. Naval War College as Charles H. Stockton Professor of International Law. He published *The International Law of Extradition* in 1971 and has continued to publish in the field of international criminal law. His other major interests are the law of the sea and the law of armed conflict.

Clive Nicholls QC is Head of Chambers at 3 Raymond Buildings. He is a Queen's Counsel and a Master of the Bench of Gray's Inn. He specialises in extradition law and mutual assistance and was leading counsel for Senator Pinochet.

Prof. Sharon Williams teaches International and International Criminal Law at Osgoode Hall Law School. In 1991 she received the David Mundell Medal for her contribution to law and letters. She served at the Permanent Court of Arbitration at the Hague from 1991 to 1997, and is a consultant to the Canadian Department of Justice on extradition. Christine van den Wyngaert teaches criminal law and procedure and international comparative criminal law at the University of Antwerp. She has been a visiting fellow of the Centre for European Legal Studies and of the Research Centre for International Law at the University of Cambridge.

**Sir John Nutting Bt.QC** is a member of 3 Raymond Buildings specialising in criminal law. His past cases include many IRA trials during the 1990s, various murder trials at the Central Criminal Court, prosecutions for War Crimes and treason, and serious corruption trials, including the largest case investigated by CIB2. He has also appeared at a number of disciplinary tribunals, inquests and inquiries including the Falkland's War Crimes Inquiry.

Norman Farrell is Legal Adviser to the Appeals Section of the ICTY, and former Legal Adviser to the International Committee of the Red Cross (ICRC)

Stephen Kay QC is a member of Three Gray's Inn Square chambers. He has wide experience in all areas of UK criminal law but now specialises in international criminal law. He was defence counsel for Tadic, the first defendant to be tried before the UN war crimes tribunal for Yugoslavia and the first international criminal trial since Nuremberg and Tokyo. He is also representing Musema, a defendant before the UN international criminal tribunal for Rwanda.

**Judge Richard Goldstone** is a Judge of the Constitutional Court of South Africa. He was Head of the Kosovo Commission, established after the recent conflict to investigate both its causes and the conduct of Nato during the period.

Judge Richard May is a Presiding Judge at the International Criminal Tribunal for the former Yugoslavia, in The Hague.

Christopher Murray is a Partner and Head of the Criminal Law department at Kingsley Napley. He specialises in mutual assistance and international criminal law.

**Paul Gully-Hart** is a Partner at Schellenberg Wittmer, Geneva. His areas of practice include international mutual assistance, white collar crime, corporate and financial compliance, international tracing of assets, banking and commercial law, litigation and international arbitration. He has published extensively in the field of international criminal law, is a regular speaker at international conferences, and is a Council Member of the ICLA.

Lorna Harris is SCS of Mutual Legal Assistance at the Judicial Co-operation Unit of the United Kingdom Home Office. She is co-author, with Christopher Murray, of *Mutual Assistance in Criminal Matters*.
