#### 1 CURRENT SITUATION

Goen Khame Gewog of Gasa Dzongkhag and Naro and Toebisa Gewogs of Thimphu Dzongkhag border Kabjisa Gewog. With about 405 households, Kabjisa Gewog is the largest gewog under Punakha Dzongkhag.

The Gewog has a very fertile land and all varieties of cereals are grown. Orange and sweet potato are grown as cash crops. Settlements are largely concentrated on the right bank of Mochhu river with altitude ranging from 1300-1800 m above sea level. Subtropical climate and favourable terrain offer tremendous opportunity for farm mechanization.

The Gewog is accessible by motor road. It has one Basic Health Unit (BHU), one Agriculture Extension Centre, one Animal Husbandry Extension Centre and one Primary School with 516 students.

#### 3 GEWOG DEVELOPMENT PROGRAMS

#### **Agriculture Programs**

#### a) Cereal and Cash Crops Development Activities

The focus of agriculture programmes during the Ninth Plan shall be on paddy, wheat, mustard and maize production improvement through farmers raining, promotion, field days and trials. Further more, technical support in terms of training and farm trials shall be organized for vegetable and cash crop development.

#### b) Construction of new Irrigation

The two villages of Wokhu Damchi and Dungkhor Rongchu with 65 households do not have proper irrigation channel. As such, about 4.2 Km of new irrigation channel with command area of 112 acres is proposed during the Nint Plan.

#### c) Renovation of Irrigation Channels

The existing irrigation channels of Zabesa, Chorten Ningpo, Upper Botokha, Sirigang (Zhakhu) and Pachekha are in dilapidated condition and therefore, a total of about 13.16 Km of irrigation channel are proposed for renovation during the Ninth Plan. The proposed renovation will improve farm water delivery for about 415 acres of wetland and enhance paddy and other crop production.

#### d) Supply of Farm Machineries

Since the Gewog has enormous potential for mechanization of farm works, farmers of the Gewog have requested for supply of 20 power tillers, 13 rice hullers, three corn-flake machines and two oil expeller during the Ninth Plan.

#### **Livestock Programs**

#### a) Cattle Breeding Programme

As per the choice of the farmers from Tongshina village, one Mithun bull shall be supplied at cost as a breeding stock to improve local cattle breeds as well as draught power. The choice is so made since the terrain does not favour mechanization.

#### b) Artificial Insemination (A.I) Programme

The villages near by the road have demanded artificial inseminations of Jersy and Brown Swiss breed to produce good offspring and enhance livestock products.

#### c) Dairy farm

Two farmers from Wokuna and Chorten Ningpo villages wish to establish dairy farm to enhance their income. Therefore, animal husbandry sector of the Dzongkhag will supply improved breed cows from the parent farm and provide dairy management training and study tours to the above farmers during the Ninth Plan.

#### d) Horse Development Programme

Many parts of Kabjisa Gewog are still not accessible by motor road and people use horses to transport goods. Therefore, people have requested for one half-linger stallion, one Boeta and a donkey for breeding purpose. Farmers will bear the cost of Boeta and donkey. Contract horse keeping allowances and incentives for progenies born shall also be provided.

#### e) Piggery Development Programme

Three farmers from Petari, Srigang and Pakhakha villages wish to establish piggery farm to enhance their income. Therefore, animal husbandry sector of the Dzongkhag shall supply improved breed piglets from the parent farm. The three interested farmers will be encouraged to breed, cross breed and to rear more pigs by providing piggery management training and study tours during the Ninth Plan.

#### f) Poultry Development Programme

Nine farmers have proposed to establish poultry farm to enhance their income. Therefore, animal husbandry sector of the Dzongkhag shall supply improved breed pullets from the parent farm. The nine interested farmers shall be provided poultry management training and study tours during the Ninth Plan.

#### g) Feed and Fodder Development Program

This Gewog has very limited dry land, sogshing and pangshing. It has about 5000 acres of tsamdro. To supplement fodder from grasses, farmers will be encouraged to plant and propagate fodder trees, develop pasture land and sow oat seeds.

g)	Animal Health Programme	

Vaccination and de-worming against major epidemic livestock diseases will continue to be provided. About three Village Animal Husbandry Workers (VAHWs) from different villages under the Gewog shall be given training in basic and simple animal treatment.

#### i) Extension Support Programme

The interested farmers in establishing enterprises such as dairy, piggery and poultry will be given short duration training. Interested progressive farmers short-listed will also be taken on in-country study tours to other Dzongkhags to meet farmers with successful ventures and similar interests and initiatives generating their household income.

Support in terms of equipment, information, training and quality control will be provided. Support for group formation and establishment of cooperatives of producer groups will also be provided. Effective processing tools and training will also be provided.

#### **Forestry Programs**

#### a) Private Forest

With increase in population, the pressure on forest for timber, fuel wood and other forest products is increasing. Therefore, the objective of the program is to encourage rural people to plant trees in their private registered land to meet their construction timber, fuel wood and small timber requirement and also to generate cash income in the long run.

#### b) Community Forestry

Community forestry shall be established in four suitable locations in the gewog during the Ninth Plan. This shall be so done by handing over patches of government reserve forest to communities with an objective of involving people in the use and management of wood and non-wood forest resources on sustainable basis.

#### **Health Programs**

#### a) Health Promotion Activities

In order to promote health and hygiene of the people, construction of latrines, footpath soling, garbage pits, separate animal sheds from houses and drainage around houses will be carried out during the Ninth Plan.

#### b) New Rural Water Supply Scheme

The Betokha village of Kabjisa does not have proper drinking water supply. Therefore, a new water supply scheme is proposed during the Ninth Plan.

#### c) Rehabilitation Schemes

The existing water supply schemes of Eusakha, Tongsina, Phulisu, Petari, Chorten Ningpo, Wokudamchi, Zhoshi of Wokudamchi, Sirigang, Zabesa and Zhoshi of Sirigang are in dilapidated condition and are proposed for rehabilitation during the Ninth Plan.

#### **Suspension Bridge and Mule Track Programs**

#### a) Construction of New Bridge

The existing wooden bridges of Pangcheyzam and Beltozam located upstream of Shoshichu are old and not very safe for travel. These two bridges serve as an important passage for Kabjisa people to travel to Thimphu. Therefore, the Gewog has proposed for steel decking during the Ninth Plan.

# **Gewog Administration Programs**

### a) Construction of Gup's Office

Since the Kabjisa gewog does not have a proper office for the Gup, the people have proposed to construct a Gup's Office during the Ninth Plan on a priority basis.

#### 5 PLAN IMPLEMENTATION, MONITORING AND EVALUATION

The GYT Chathrim 2002 delineates specific roles and responsibilities to all functionaries involved in development administration and management in the Gewog. It is, however, deemed necessary to underscore some essential processes that must be observed in executing the above roles and responsibilities.

The financial powers and authority of the Gewog Administration for the implementation of the planned activities are also enshrined in the GYT Chathrim 2002.

#### Plan implementation

The Gup, GYT *Tshogpas* and the community as a whole will take on full accountability and ownership of gewog development activities. The clear delineation of implementation time frames, responsibilities and contributions from the community should be developed for the effective implementation of gewog activities.

#### Annual and Quarterly Plans

Based on the Five-Year Plan, the Gup will prepare Annual Plans and Budgets (AP&B) in consultation with the gewog sectoral staff and submit it to GYT. After the GYT discusses and approves the Draft AP&B, it will be put up for approval to the DYT.

Once the DYT approves the AP&B, the GYT will develop a Quarterly Work Plan and Budget in consultation with the sectoral staffs and other functionaries in the gewog such as Mangmi, Chimi and Tshogpas. The implementation of the Quarterly Work Plan will be the responsibility of the Gup and the Tshogpas with technical support from the staff of the concerned sectors.

Based on the Quarterly Work Plan, the concerned sectoral staff responsible for the implementation of any planned activity will elaborate a detailed implementation plan and budget for approval and budget release by the Gup. Copy of this plan will be sent for information to the concerned sectoral heads and relevant agencies. Upon completion of the activity, the responsible person will submit a report to the Gup and the concerned sectoral heads and relevant agencies.

#### **Monitoring and Evaluation**

#### Monitoring

The GYT in the Gewog will be responsible for progress and performance monitoring of the planned activities. The GYT should convene monthly meetings with technical staff and other responsible persons for implementation to review the progress in the implementation of every activity and to take timely corrective actions when required. The Gewog will seek technical back-up services from the Dzongkhag Administration when necessary.

Based on the received reports and monthly meetings the Gup will submit a quarterly report to the Dzongkhag administration. Technical reports from the different sectors will be attached to the Gup's quarterly report.

The Gup will verify the travel claims of all sectoral personnel in the gewog so that the performance of the Gewog staff can be monitored.

#### **Evaluation**

To assess the impact and benefit of development programs and projects in the Gewogs, the Government will launch periodic evaluation missions in coordination with the Dzongkhag Administration.
