

| (Landover Hills and New Carrollton.) | Step 1 . Business completes the EZ Certification form and submits it to the Prince George's County EDC. |
| Cabin Branch * (Cheverly, Fairmont Heights, Glenarden, and Landover.) | Step 2 . The EZ Administrator will review the application and send certification letters to the applicant, the County Office of Finance, and the Tax Incentives Group at DBED. |
| Central Area * (Capitol Heights and Seat Pleasant.) | Step 3a. For Real Property Tax Credit: The State will |
| Southern Area * (District Heights, Forest Heights, Marlow Heights, Morningside, and Suitland.) | revise the eligible assessment after the improvements are done. The County will calculate the credit based on the revised assessment and send a letter to the property owner indicating the credit amount. |

International Corridor/ Gateway Arts District

Parts of Langley Park, and the Gateway Arts District communities of Brentwood, Hyattsville, Mount Rainier, and North Brentwood.

Port Towns

MD Rt. 450 from Eastern Avenue to Kenilworth Avenue including Bladensburg, Cottage City and Colmar Manor and Riverdale Park.

Annapolis Road Corridor

MD Rt. 450 (Annapolis Road) from Cheverly to New Carrollton.

Cabin Branch

Between Route 50 and Martin Luther King Jr. Hwy and west of the Capital Beltway covering Cheverly, Glenarden and Landover.

Central Area

Both sides of Central Ave including Capitol Heights, Seat Pleasant and the Hampton Business Park

Southern Area

Along Branch Ave. Marlboro Pike, Silver Hill Road, Allentown Road, Southern Ave. covering Suitland, Forest Heights and the Suitland Metro Station.
