Pursuant to General Condition 44 of the licence granted to NCAL on 1 April 2000, the Telecommunications Authority hereby directs NCAL, until further notice is given in writing, the General Conditions or any part thereof which impose the following obligations shall not apply to NCAL:

- (1) General Condition 20(4);
- (2) General Condition 21;
- (3) General Condition 22; and
- (4) General Condition 23.
