THE CHAPMAN UNIVERSITY SCHOOL OF LAW

The Chapman University School of Law is situated on the main university campus in Orange, California, some forty miles south of Los Angeles. The student body of 465 is taught by a full-time faculty of 26 persons, two of whom are former U.S. Supreme Court judicial clerks. The Law School offers curriculum emphases in Real Estate and Environmental Law, Advocacy and Lawyering, and Taxation. Students may also opt for the joint JD/MBA degree program. Clinical opportunities include the Elder Law Clinic, U.S. Tax Court Clinic, Ninth Circuit Appellate Advocacy Clinic, and Constitutional Jurisprudence Clinic.

CUMBERLAND SCHOOL OF LAW AT SAMFORD UNIVERSITY

Cumberland School of Law at Samford University is one of the oldest law schools in the country. Cumberland was founded in 1847 and moved to Birmingham, Alabama in 1961. The Law School has become nationally recognized for its Advocacy program, The Center for Biotechnology, Law and Ethics, and the use of technology in the classroom. The law faculty is composed of dedicated law teachers and scholars with rich experience gained from judicial clerkships, private practice, government service and corporate America. Cumberland is located in a thriving financial, legal and medical services center of Alabama. The Cumberland location offers students an opportunity to pursue a wide variety of academic, professional and social interests. Many students take advantage of the opportunity to broaden their perspectives through Cumberland's summer study-abroad programs and interaction with international

attorneys and jurists who study on campus in the Master of Comparative Law program. With its emphasis on the practical training for the practice of law, Cumberland prides itself in being a place "where good people become exceptional lawyers."

SOUTH TEXAS COLLEGE OF LAW

South Texas College of Law is Houston's oldest law school with 10,000 alumni scattered across all 50 states and seven countries. Located in downtown Houston, South Texas sits in the middle of one of the largest legal and international business markets in the U.S. South Texas has 1,200 students, 25% of whom attend classes in the flexible part-time program. The student body is nearly evenly split between male and female. Known for its outstanding Advocacy Program, South Texas trains students in the practical litigation and transactional skills needed to go to work immediately upon graduation. With a full-time faculty of 60 and an additional 40 adjunct professors, South Texas provides a well rounded, in-depth education that is forward thinking, nurturing and enriching.

PROGRAM LOCATION

Cambridge has a 2000 year history. During the first century the Belgic tribes established the first settlement at the location now recognized as Cambridge. The Belgic settlement achieved strategic significance when the Romans arrived in AD 43. Roman soldiers were stationed at the location, a ford for crossing the River Cam, a crossing point on the Roman Road connecting Colchester with Chester. Through the centuries the settlement grew from a village to a delightful town. In 1209 a group of rebel scholars arrived, having left Oxford after what is described as "violent quarrels" with Oxford residents. The first college, Peterhouse, was

established in 1284. Our residential college, the Cambridge college of Oliver Cromwell, Sidney Sussex College, was founded in 1596 by Lady Sidney, and built on the site of a Franciscan friary. The contemporary location is in the center of the beautiful and historic city and is truly outstanding. There are 10 museums and galleries which are within walking distance of Sidney Sussex. Cambridge is an excellent location for a study-abroad program. We, the sponsoring law schools, are privileged to offer law students the opportunity to study in Cambridge, as have Milton, Marlowe, Coleridge, Wordsworth and Byron before them.

PROGRAM DESCRIPTION

Cumberland School of Law at Samford University, South Texas College of Law, and Chapman University School of Law will conduct the **first annual** study-abroad program at the Sidney Sussex College, Cambridge, England, July 2 – August 2, 2006. A **reception** for arriving students and faculty will occur on the evening of **July 2**, at 6:30 P.M. The reception will include an orientation for students and faculty concerning both Sidney Sussex College and the Cambridge area. Cumberland conducted a study-abroad program at Collingwood College, University of Durham, England for 11 years. South Texas College of Law and Chapman University School of Law co-sponsored the Durham program with Cumberland during the past several years. The sponsoring law schools are very pleased to have the opportunity to relocate their study-abroad program for the United Kingdom of Great Britain at Sidney Sussex College, Cambridge, England, beginning in July, 2006.

Classes will be conducted Monday through Thursday of the first week of the program for the one-hour course treating the English Legal System and the European Union. The examination for this course will be conducted on Friday morning, July 7. The normal class schedule, offering classes Monday through Friday, will vary during the second week of classes to accommodate a field trip to the Royal Courts of Justice, lunch at the Middle Temple Inn of Court and a trip to Parliament following lunch on Friday, July 14. The program will provide bus transportation to and from London on July 14 for our visit to London.

The last day of classes will occur on **July 28** and **final examinations** will be conducted on **July 31 and August 1** for courses other than the one-hour course conducted during the first week of the program. Students, other than those who make individual arrangements with the program director, should plan to arrive at Sidney Sussex College, Cambridge, on **July 2** and depart prior to 10:00 A.M. on **August 2**. Exams will end by midday on August 1; hence, students may plan to depart in the afternoon of that day if they wish. A **closing dinner** will be offered for students and faculty on **Sunday evening, July 30**. A summary calendar of events and class schedule will be found following the program application at the end of this brochure.

Students may anticipate examinations for each course compatible to law exams administered in American Bar Association approved law schools in the United States. The professors responsible for each of the courses offered will both write and grade the applicable examination. Thirty-three J.D. students from Cumberland School of Law, one J.D. student from the Barry University School of Law, three J.D. students from the Chapman University School of Law,

three J.D. students from the South Texas College of Law, one J.D. student from the Thomas M. Cooley Law School, and five Master of Comparative Law candidates from the Cumberland School of Law MCL Program (having received their first degrees in law from four different Brazilian Universities) for a total of 46 participating students in the 2005 Durham Study-Abroad program conducted by the law schools sponsoring this program. The sponsoring schools anticipate increased student interest during 2006; hence, early registration is encouraged. The 2006 Cambridge program will be limited to a maximum of 35 students if additional lodging cannot be arranged.

ADMISSION CRITERIA

Program participation is limited to law students in good standing at an American Bar Association approved law school, graduates of approved law schools in their country of origin or residence, or members of the Bar. Samford University, South Texas College of Law and Chapman University are Equal Opportunity Institutions and welcome applications for employment and educational programs from all individuals, regardless of race, color, sex, disability, national or ethnic origin.

APPLICATION PROCEDURES

All applications for admission must be accompanied by a \$ 50.00 application fee which is non-refundable unless the application is rejected due to full enrollment, lack of sufficient student

interest, or domestic and/or international instability which is relevant to the program. Deadline for submitting applications is **April 15**, **2006**. Late applications may be arranged with the program director if space allows. The program director recognizes that financial aid for legal studies may not be available until either late May or early June; hence, *a deferred time-frame for payment, other than the application deposit, is satisfactory if the student has preregistered and informed the program director of an acceptable payment schedule.* Applications other than from South Texas College of Law students should be directed to the Director of International Programs, Professor Charles D. Cole, at the address provided on the application form. South Texas College of Law students should direct their applications to Assistant Dean Wanda Morrow at South Texas College of Law.

ACADEMIC CREDIT

Upon satisfactory completion of the required course-work, the sponsoring law schools, fully accredited by the American Bar Association, will provide transcript information necessary to facilitate credit to students at their respective law schools, consistent with the policy of their respective schools. It is unlikely that summer study-abroad programs will accelerate early graduation due to residency requirements established by the American Bar Association. Participants should, therefore, consult with their home law school to resolve this issue.

CANCELLATION OR TERMINATION OF PROGRAMS AND CONSULAR INFORMATION SHEETS

Registered students who withdraw before June 1, 2006, will receive a refund of all monies prepaid other than the non-refundable application fee. Students withdrawing after June 1, 2006,

and before July 1, 2006, will receive a fifty-percent refund of monies prepaid other than the application fee. Students withdrawing on or after the beginning of the program on July 2, 2006, will receive no refunds. In the event of cancellation of the program, the University will utilize maximum effort to refund all monies prepaid, including the application fee, within twenty (20) days after the date of cancellation. The program director will use his best efforts to make arrangements for each student enrolled to attend a similar program, if the student so desires, when cancellation occurs after a deposit has been paid.

Notwithstanding any information concerning program cancellation and refund policy to the contrary, if the U.S. State Department determines that the country and area of the country in which the program is or will be conducted is an "area of instability" students will be permitted to withdraw from the program upon learning that the site has been declared to be such an area. Students withdrawing under such circumstances shall be refunded fees paid except for room and board payments utilized prior to the date the site was declared an "area of instability." If the program is terminated due to "area of instability" reasons, students shall be refunded fees paid except for room and board payments utilized prior to the date the travel warning is issued. The Consular Information Sheet for England, issued by the U.S. Department of State, will be furnished to all students upon registration. An updated Consular Information Sheet will be provided to all registered students if, either prior to the program beginning or subsequent thereto, the program location is determined to be an "area of instability."

FINANCIAL MATTERS

Administration, Housing and Meals - \$2,730

Students will be housed in Sidney Sussex College. Breakfast and lunch are included in the housing and meal allowance for each registered student each day of the program, including weekends. Lodging will be provided from July 2 until August 2 (departure from Cambridge on August 2 must occur prior to 10:00 A.M.). Evening meals may be purchased in one of the many local restaurants convenient to the lodging. The evening meal will not, other than the closing dinner on July 30, be provided by the study-abroad program.

Tuition (Five Hours) - \$ 2,000

This tuition cost is a flat rate of \$ 2,000 for any hours undertaken. The maximum number of hours allowable pursuant to American Bar Association regulations for a program of this duration is five hours. The student will, therefore, be allowed to register for the one-hour course and two of the three two-hour courses offered. The payment schedule below is based upon the tuition plus the administration, housing and meal fees.

Special arrangements for students participating in loan programs may be made by informing the program director of the date when the loan proceeds will be available after student registration is completed.

Loans are available to students participating in this study-abroad program. Students interested in obtaining loans for the program should contact the Director of Financial Aid at the law school they are attending. The approved budget for financial aid for this program for Samford University students, including all required travel and miscellaneous expense is \$7,990.00. An itemized copy of the financial aid budget approved by Samford University Financial Aid is available on request from the Cumberland Director of International Programs, Professor Cole at his address on the application form.

PROGRAM LODGING AND ON-SITE ADMINISTRATION

This study-abroad program will be conducted at Sidney Sussex College, Cambridge, England. Cambridge is located in beautiful central England, a convenient location from which to travel and an ideal location for summer study. The accommodations at Sidney Sussex will be modern single en-suite bedrooms, i.e., a single bedroom with private bath, with linens and towels furnished. The en-suite rooms are new, with in-room internet connections available. Classes will be held in a modern and spacious classroom within the residential college. During the 2006 program the on-site directors' responsibilities will be shared by Professor Dr. Paul Kuruk, a Cumberland professor and Dr. James N. Lewis, Jr., the Vice Dean for Administration at Cumberland. The co-directors will maintain an office in a designated room within the dormitory

area of Sidney Sussex College and be available for student consultations each class day. The directors will also maintain a cell phone for emergency student contact every day, including weekends.

PASSPORTS

Passports are required for a trip to England. Participating students should obtain their passports at their earliest convenience. Passports may be obtained through contact with the nearest State Department Office or United States Post Office. The program director will provide each student traveling to England a letter explaining the nature of the program and duration of such to facilitate the necessary international travel. The letters will be available after the student has formally registered for the program or prior to the end of the 2006 spring semester.

TRANSPORTATION

Each student participating in the program will be responsible for arranging their transportation to and from England. Airlines provide a variety of reduced fare plans and early booking can create substantial savings. Summer flights to Europe are filled quickly; hence early travel arrangements should be made. One will fly into either Heathrow Airport or Gatwick Airport for the flight from the United States to London. Cambridge is about 55 miles north of London. One can take the train to Cambridge from either London's Kings Cross Station or Liverpool Station. The train ride typically takes 45 minutes and costs around 15 pounds. Trains depart about every half hour. The websites for train information are:

The Cambridge Train Station is south of the city center. The walk to the city center takes about 20 minutes. There are taxi stands at the train station and a bus leaves for the city center every 15 minutes or so. Our residential college, Sidney Sussex College, is delightfully located in the city center.

Bus service to Cambridge is also available from London's Victoria Coach Station with busses departing every 15 minutes or so. The cost of a one way ticket is about 8 pounds. If you decide to take the bus from London to Cambridge, be sure to check the bus schedules carefully so your journey takes 2 rather than 4 hours. Look for the 2 hour schedule; this faster bus only departs at certain times of the day. Refer to the website www.nationalexpress.com for bus schedules. The Cambridge Bus Station is centrally located in Cambridge.

Stansted Airport (STN) is located 25 miles from Cambridge. This airport is great for travel

Information concerning casebook materials for courses offered will be available in sufficient

time to allow some preparation by students prior to the summer semester. Individual students

who wish to have course materials for early preparation should request the necessary information

from Professor Cole at his address at the end of this brochure.

RESPONSIBILITY AND MODIFICATIONS

The sponsoring law schools will not be responsible for personal injury, medical expenses, or for

loss or damage to personal property. Students should maintain or obtain medical insurance

coverage for accidents or illness which may occur during their participation in this program and,

if deemed desirable, insurance covering loss or damage to personal property and trip

cancellation. The sponsoring schools reserve the right to change any aspect of the program

which circumstances make necessary or desirable. Participants will be notified promptly of material changes or cancellation of the program.

FACULTY AND COURSES TO BE OFFERED

Adrian Jenkala, Barrister-at-Law, London, England, will offer a course treating The English Legal System and European Union: A Comparative Overview (one credit hour). The course will provide materials concerning the English Legal System, the role of the judiciary, and the current interface of the English system with the European Union. The course will offer students a unique opportunity to enjoy the practical and academic aspects of the emerging constitutional basis for the European Union and the anticipated effect of such on the existing English system of justice. This course will be offered Monday through Thursday of the first week of classes, with classes scheduled at 8:45 A.M. - 10:30 A.M. and 10:45 A.M. - 12:30 P.M., commencing on July 3, 2006. The examination for this one-hour course will be administered on July 7. Professor Jenkala served on the faculty of the Durham study-abroad program for the eleven years it was offered at that location. He is a graduate of London University (B.S. and B. of Laws), University of Westminster (Diploma in Law), Inns of Court School of Law (Bar Finals), and a member of the Chartered Institute of Arbitrators. Professor Jenkala has served as a lecturer and examiner at the Inns of Court School of Law and taught in other institutions in England and abroad. He also has over twenty years experience of civil and commercial litigation with advocacy rights in all of the courts of England and the European Court of Justice.

Paul Kuruk, Professor of Law, Cumberland School of Law, will offer a course treating **International Business Transactions** (two credit hours). This is an introductory course focusing on the problems involved in international business transactions. Topics include: agreements for the international trading of goods; uses of letters of credit; international dispute resolution; tariffs; nontariff trade barriers; restrictions on exports; restrictions on technology transfers; foreign direct investments; expropriations; extraterritorial application of antitrust laws; and bribery of foreign officials. **The course will be offered at 10:45 A.M. – 12:30 P.M., commencing on July 10, 2006.** Professor Dr. Kuruk obtained his LL.B., *summa cum laude*, from the Ghana Law School, an M.A. and LL.M. degree from Temple University, and a J.S.D. degree from Stanford Law School. He currently teaches commercial transactions, international business transactions and international human rights at the Cumberland School of Law.

Scott Simpson, Attorney, Batchelor & Simpson, P.C. in Birmingham, AL, and V. Michelle Obradovic, Esq. will offer a course treating Alternative Dispute Resolution (two credit hours) to be offered at 2:00 P.M. – 3:45 P.M., commencing on July 10, 2006. This course will introduce basic processes of dispute resolution (negotiation, mediation and arbitration,) as well as other processes (such as neutral evaluation, mini- trials, and summary jury trials). By surveying the full array of processes, this course will enable students to analyze and compare the various processes' advantages and disadvantages. Students will also be introduced to process design to understand ways in which lawyers and parties can go beyond given procedures to create procedures suited to their interests. The professors for this course are adjunct professors of law and highly competent practicing lawyers. Professor Obradovic obtained her law degree

on an accelerated basis from Cumberland School of Law. She is a mediator and the owner of WiseResolution, LLC. She has mediated in excess of 755 cases involving personal injury, wrongful death, products liability, environmental issues and business torts, as well as over 145 complex cases, mass torts and class actions. Prior to law school Professor Obradovic obtained a B.A. from Trinity College, *summa cum laude*, and is an LL.M. candidate at Pepperdine University's Straus Institute for Dispute Resolution. Professor Simpson is a shareholder with Batchelor & Simpson, P.C., with practice areas including commercial and consumer litigation, general corporate, construction and real estate law, with special emphasis on arbitration and mediation. Professor Simpson obtained his J.D. degree, *magna cum laude*, from Cumberland School of Law, his B.A. from the University of Florida, graduating sixth in his class, and is currently a candidate for a Masters Degree in Business Administration at the University of Alabama at Birmingham.

Professor Geoffrey Steven Corn, South Texas College of Law, will offer a course treating **International Law** (two credit hours) focusing on the fundamentals of international law and the role of international institutions. Topics include: the nature of international law; treaties; customary law; the International Court of Justice; states and international law; individuals and international law; the United Nations; and the use of force. Professor Corn finished first in his LL.M. class at The Judge Advocates General's School, in the top two-percent in his J.D. class at the George Washington University Law School and *magna cum laude* in obtaining his B.A. degree at Hartwick College. He teaches classes and seminars treating public international law

and international humanitarian law at South Texas College of Law. This course will be offered at 8:45 A.M. – 10:30 A.M., commencing on July 10, 2006.
