THE ARBITER IN COUNCIL

By Francis Wrigley Hirst



Francis Wrigley Hirst was a prolific writer and skillful biographer who devoted his life to the cause of individual liberty at a time when collectivism reigned. As a stalwart advocate of free trade and the peaceful resolution of disputes during the first half of the 20th century (especially during World War I and its aftermath), Hirst advanced these principles through writings, which exposed how government policies that limited the importation of foreign goods and promoted warfare were severely detrimental to the overall well-being of the international community.

In 1906, Hirst sought financing from fellow anti-protectionist J. P. Thomasson and anonymously published *The Arbiter in Council*, **a truly original work** that analyzed the "follies of war" based primarily on economic grounds.

To distinguish *The Arbiter in Council* from other books of its kind, Hirst chose to compose it as a series of hypothetical conversations between a former associate of 19th century British politician Richard Cobden, a leading supporter of free trade and opponent of protectionism, and a number of other people.

In a concise and interesting fashion, the work explores **all** the relevant topics, including the causes and consequences of war, modern warfare, private war and the duel, the concept of perpetual peace, the political economy of war, and Christianity and war.

Today, Francis Wrigley Hirst is admired as a preeminent supporter of personal freedom and a valiant defender of the Cobdenite tradition of peace and free trade. While several of his works have survived, *The Arbiter in Council* remains the most influential example of his enduring legacy.
