
#### **CURRENT SITUATION**

The tropical storm watch for the Florida Panhandle and Northwest Florida has been upgraded to a tropical storm warning and hurricane watch from the Alabama and Florida Border eastward to the mouth of the Suwannee River. The State Emergency Operation Center is at Level 2 Activation (partially Activated). The State Emergency Response Team continues to monitor and

prepare for the impact of Tropical Storm Bonnie and Charley on a 24 hour schedule.

#### **WEATHER SUMMARY**

AT 4 PM CDT...2100Z...A HURRICANE warning has been issued for Portions of the Florida panhandle and northwest Florida from Destin eastward to the mouth of the Suwannee River. A hurricane watch and a tropical storm warning remain in effect for the western Florida panhandle with maximum sustained winds being near 65 mph with higher gusts. Additional strengthening is possible during the next 24 hours and Bonnie could become a hurricane later tonight or Thursday morning.



#### **CONSEQUENCES:**

- 1. Evacuation Status-
- **2. Sheltering-** Ten counties in central panhandle have shelters on standby. Three shelters open in Bay and Washington counties.
- **3. Hurricane Warning –** Remains in effect for Florida panhandle.
