Book Drive - So Many Helping Hands

All five Garnet Valley schools participated in the "Literacy Lifeboat Book Drive" to benefit schools devastated by Hurricane Katrina. The drive was organized by the Delaware County Intermediate Unit and the District Superintendents. Garnet Valley collected over 3,000 new books for the Franklin Upper Elementary School in Meadville, Mississippi for use in their classrooms.

The book drive was supported through very generous donations from Garnet Valley families, students, teachers, staff, and local businesses. Stover Printing, in Bethel, made bookplates that were personalized with a handwritten note from the student donating the book in Garnet Valley and affixed to the book. Heritage Moving Systems, based in Concordville, donated the boxes used to collect and ship the books. Shipping costs were funded through a doughnut sale held by the Garnet Valley High School French Club teachers and students. The Garnet Valley Maintenance Department provided "muscle power" to collect the boxes of books from all the schools and deliver them to the post office. It was truly a great community effort!

Dr. Loretta Scuderi

Dr. Loretta Scuderi, a Garnet Valley School Board Member since July 1998, passed away on September 29, 2005. Dr. Scuderi was a strong advocate for the education of young people in the district and stressed the need to balance costs within the budget.

Dr. Scuderi's career started as a teacher in the Philadelphia School District in 1958. She began teaching as soon as her sons, Joseph and Peter, started school. As her career as an educator progressed, she

became a principal and later was appointed Superintendent of Districts 3, 7 and 8 in Philadelphia. Dr. Scuderi and her husband, retired U.S. Magistrate Judge Peter B. Scuderi of the U.S. Court for the Eastern District of PA, moved to Glen Mills in 1992. Dr. Scuderi was the deputy chairperson for the Education Committee and a member of the Finance Committee. She provided a personal touch to the School Board, often writing notes to students congratulating them on their accomplishments.

Being a true proponent of quality education for everyone, Dr. Scuderi was deeply committed to the Garnet Valley community.

New Board Members in 2005



The two newest members of the Garnet Valley School District Board are Mary Kay Beirne, who replaced Jodi Dix in February 2005, and Charles Abel, replacing Dr. Scuderi in September 2005. The Board is excited about the fresh perspective the new members bring to the Board and look forward to working together for the best interests of the Garnet Valley community.

Differentiated Instruction A Customized Method of Teaching

Differentiated Instruction is a major avenue whereby teachers can meet the varying needs of their students. In Garnet Valley, Differentiated Instruction, or DI, as it is commonly called, is viewed as an important initiative and teachers are being trained in DI strategies to better customize instruction. "One size rarely fits all," DI consultant, Christy Doubet, shared with GV teachers at a recent in-service. "We need to identify what we want all students to know, understand and do as it relates to a unit and then vary our strategies." Ms. Doubet went on to say, "as educators, we need to identify the big ideas embedded in our content areas even before we begin to introduce a unit. If we do this, we will be able to keep our eye on the ball, and judge which students are in need of extra help, and which students need an alternate approach or to forge ahead at a more rapid rate."

Teaching in this fashion is a highly artistic act, and approximately thirty teachers have volunteered for extra training and coaching by Ms. Doubet, a doctoral candidate at the University of Virginia, and a colleague of the world renowned Dr. Carol Ann Tomlinson. This cadre

of GV teachers, in turn, serves as a resource to their colleagues as "trainers" of peers, presenting at faculty meetings, and collaborating on certain projects.

Special education and IST teachers have long served as a valuable resource to teachers of inclusion students. Teachers of the gifted, also, provide ideas for "ratcheting up content" within regular education classes. Several notable recent examples have been collaboration

between Mr. Tom Dame and Mrs. Karen Hansell at GVMS. Mr. Dame, seventh grade science teacher, also an experienced structural engineer, built a resonator and both he and Mrs. Hansell worked with both a gifted seminar and regular education science students to teach the principles of resonance as they relate to earthquakes and other natural disasters.

At Bethel Springs Elementary School, Mrs. Rebecca Brown and Mrs. Dee Contipederio collaborated to appropriately differentiate for students to approach a common theme through the use of diverse novels. Ms. Brown and Mrs. Bracalenti collaborated on a problem solving theme for regular education math classes. Similarly, at GVES Mrs. Jen Valerio and Ms. Laura Reisch collaborated to

bring differentiated strategies to a math problem solving unit. Ms. Cathie Cooper and Mrs. Carol Law, similarly work with colleagues at Concord School and GVHS respectively to fine tune regular education teaching strategies to meet individual needs.

Crisis Planning at Our Schools

The Garnet Valley School District continues its diligent efforts in the area of crisis planning. Refinements to the comprehensive plan are made on an ongoing basis, and these refinements are always based on state of the art research, training and feedback through building and district-wide crisis teams.

During this past year, key members from each department and school building participated in a series of Table Top exercises led by county and regional leaders. School officials, police, fire, township and emergency management personnel simulated a series of potential disasters, then critiqued our responses, communication systems and respective plans.

In the fall, Mr. Thomas Morgan, local crisis trainer/coordinator trained the district's administrative team in the various complexities of the incident command system and crisis response. Crises were simulated and the team's responses were analyzed. Building level teams will conduct similar drills throughout the winter and spring, emphasizing evacuation and lock-

presented on various aspects of the plan at local, state and national conferences, and maintain ongoing communication links with a plethora of agencies also committed to the well being of staff, students, and community. A number of competitive grants have been attained to assist in this ongoing endeavor.

down modes to assure best practices. Guides in the form of handbooks and videotapes are being developed to allow building principals (or their designated substitute) to easily navigate the intricacies of all their building's systems (e.g. HVAC, security, boiler, water, etc.) in the event of an emergency.

Additionally, Dr. Albert Villarin, MD, FACEP, consultant in bio-terrorism, will address administrators on this topic from the federal crisis planning perspective in March.

The Garnet Valley School District is committed to state of the art crisis planning, with one of the longest-standing refined plans. The implementation of the **Global Connect Communications Phone System** is the latest initiative to reach this goal. Administrators have

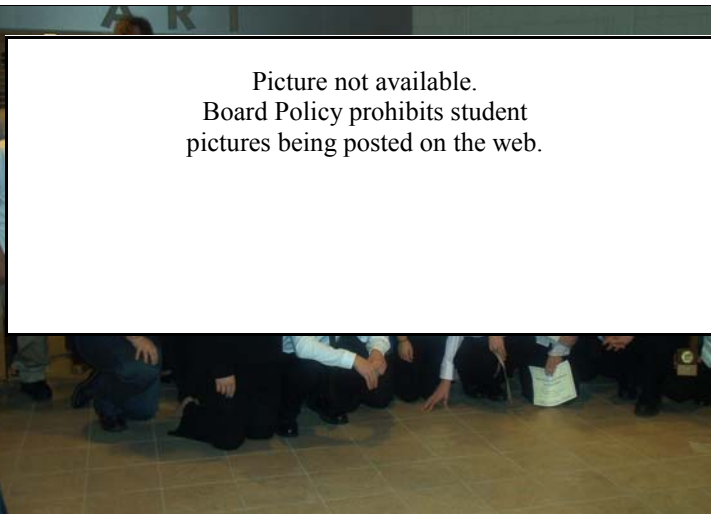

PANA = A NEW EMPHASIS ON HEALTHY LIFESTYLES

Research has long indicated that children who are active, fit, and eat nutritiously, focus better, and tend to perform well academically. Schools have always underscored that message too, and now the US Congress, with its reauthorization of the Healthy Meals for Healthy Americans Act, also reiterates its importance.

The Act mandates that school districts that wish to retain their school lunch subsidies must now adopt a wellness policy, and districts are also encouraged to establish health councils to address issues of nutrition, activity, and healthy living in an ongoing manner. Each of Garnet Valley's five schools now has such a health council, and they are expected to bring recommendations for a Wellness Policy to the board of school directors in February 2006. The School Board will then develop such a policy, to be adopted before July 1, 2006.

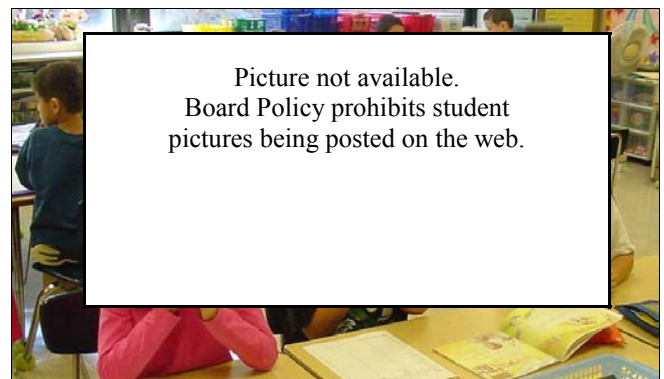
The Pennsylvania Department of Education has also introduced a new initiative related to wellness, PANA, (Pennsylvania Advocates for Nutrition and Activity,) and encourages all districts to participate

in wellness activities. Garnet Valley has enthusiastically responded—each building in its own way. The elementary schools have celebrated the Great Apple Crunch Day, Go for the Greens, and other "Fruit of the Month" Days. They've expanded involvement in the mileage clubs with teachers and students running laps together. The middle school students and staff have been working with Chartwells, our food service vendor, in refining healthy choices for meals and expanding curriculum to identify opportunities for students to make their own healthy choices. The high school will introduce a new elective course, *Eating Light*, for the 2006-07 school year, and has added a number of new clubs and co-curricular activities to involve students in a more active lifestyle.

Moving forward, staff, students, and parents will be asked to be more mindful of every aspect of the GV culture as it pertains to wellness—healthier choices in foods selected for celebrations, fundraisers, vending machines, etc, and activities that build strong bodies in healthy minds, ever ready to learn.

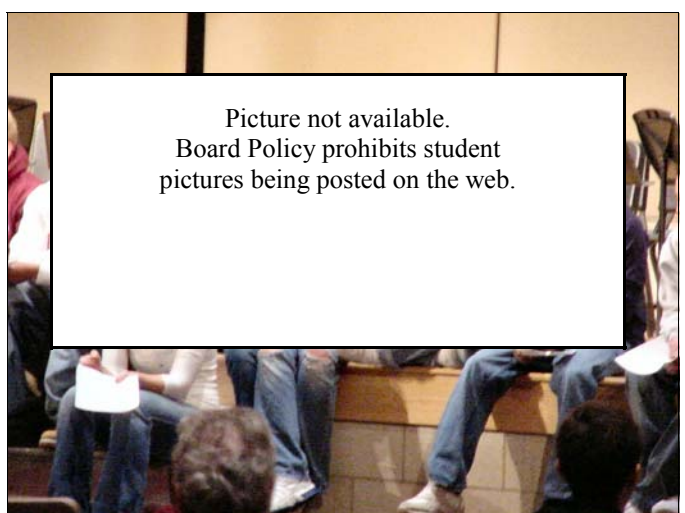

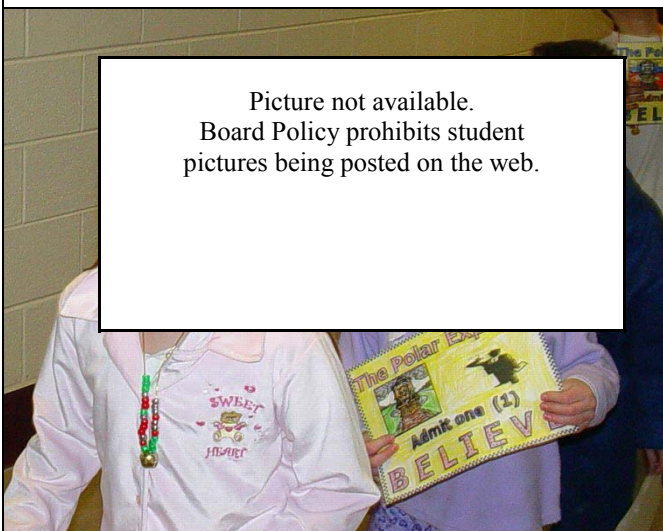
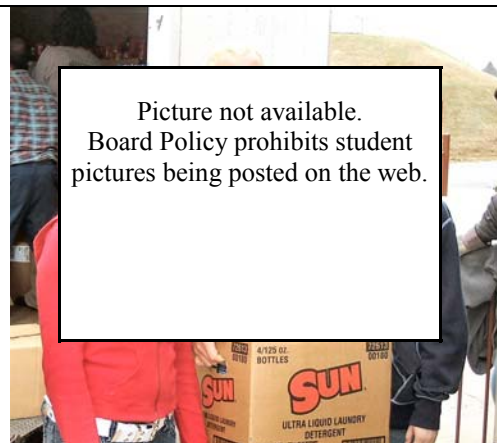
Garnet Valley Middle School Warm Clothing Drive

Construction Update

Garnet Valley Middle School Completed, Garnet Valley High School Renovations Accelerated, New Concord School Takes Shape

Garnet Valley Middle School: In late November, nearly two months ahead of schedule, Garnet Valley Middle School opened its new 14 classroom addition. The welcomed addition provided the Middle School with two state-of-the-art science labs and a beautiful computer lab in addition to the other 11 classrooms. GVMS houses 1,100 students. Although the building is significantly larger, the addition enabled the principals to schedule teams closer to one another. Prior to the new wing, several teachers "floated" from room to room throughout the day. The additional classrooms allowed for assigning teams in the same area. Most students now have only a short walk from one team room to another. The Garnet Valley Middle School administration, faculty, and students are certainly thankful for the new wing and are taking advantage of the academic opportunities that have resulted from its completion.



Garnet Valley High School: Students and teachers occupied part of the new second floor addition at the start of the new semester in late January. The rest of the second floor will be ready on President's weekend. GVHS construction is on an accelerated schedule so that HVAC renovations can be started in the oldest section of the building, the A wing. The high school renovations are scheduled for completion of Fall 2006. In January, the School Board approved the installation of synthetic turf on the GVHS athletic stadium field. The new turf, which will be supported by advertising, ticket sales, and other non-tax revenues, will allow more intensive field use and scheduling of the field with less deterioration and lower maintenance costs.



New Concord Elementary School: The new Concord School is scheduled to open in September 2006. The steel work will be completed by the end of February with the concrete block and wall work under way as the building takes shape. Concord School will utilize geothermal wells which will provide heating and cooling with state of the art methods while conserving energy. Ground has been prepared for storm water runoff and erosion. The 130,035 sq. ft. new building will house approximately 700 students in the fall of 2006.



Leesa Bucci Attends Educational Conference in Beijing China

Leesa Bucci, head of the GVSD Art Department and a GVHS art teacher, recently attended the US-China Joint Educational Conference in Beijing, China. Ms. Bucci was among 206 delegates who represented North America. She said that the conference allowed for an exchange of ideas between the two cultures as China is looking to expand their arts education. Since attending the conference, Mrs. Bucci has added a new dimension to her teaching and has already implemented a new practice into her classes. Mrs. Bucci stated, "This conference experience will no doubt be one of the highlights of my professional career."

Notice of Rights

The Family Educational Rights and Privacy Act (FERPA) is a Federal law designed to protect the privacy of a student's education records. The law applies to all schools which receive funds under an applicable program of the U.S. Department of Education. FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student, or former student, who has reached the age of 18 or is attending any school beyond the high school level. Students and former students to whom the rights have transferred are called eligible students.

- Parents or eligible students have the right to inspect and review all of the student's education records maintained by the school. Schools are not required to provide copies of materials in education records unless, for reasons such as great distance, it is impossible for parents or eligible students to inspect the records. Schools may charge a fee for copies.
- Parents and eligible students have the right to request that a school correct records believed to be inaccurate or misleading. If the school decides not to amend the record, the parent or eligible student then has the right to a formal hearing. After the hearing, if the school still decides not to amend the record, the parent or eligible student has the right to place a statement with the record commenting on the contested information in the record.
- Generally, schools must have written permission from the parent or eligible student before releasing any information from a student's record. However, the law allows schools to disclose records, without consent, to the following parties:
 - School employees who have a need to know;
 - Other schools to which a student is transferring;
 - Certain government officials in order to carry out lawful functions;
 - Appropriate parties in connection with financial aid to a student;
 - Organizations conducting certain studies for the school;
 - Accrediting organizations;
 - Individuals who have obtained court orders or subpoenas;
 - Persons who need to know in cases of health and safety emergencies; and State and local authorities, within a juvenile justice system, pursuant to specific State law.

Schools may also disclose, without consent, "directory" type information such as a student's name, address, telephone number, date and place of birth, honors and awards, and dates of attendance. However, schools must tell parents and eligible students about directory information and allow parents and eligible students a reasonable amount of time to request that the school not disclose directory information about them. Schools must notify parents and eligible students annually of their rights under FERPA. The actual means of notification (special letter, inclusion in a PTA bulletin, student handbook, or newspaper article) is left to the discretion of each school. Board Refinances Bonds to Save \$257K+



The Garnet Valley School Board refinanced \$8,650,000 in existing bonds to a lower fixed interest rate at the January Board meeting. This move is expected to save the district more than \$257,000 by locking in an interest rate that is near a record 40-year low point.

At the same Board meeting, Tom Delaney, GVSD Director of Business & Support Services, noted that Moody's Investor Service has upgraded the district's underlying bond credit rating from A2 to A1. This new rating will allow the district to obtain low interest rates and good refinancing terms. Mr. Delaney and Board member, Ed Plasha, went on to note, that the rating upgrade is like a "feather in the cap to the Board," since the basis for this upgrade is based, in large part, on the fact that the Board manages the GVSD budget and spending conservatively.
