



# Minimum Eligibility Requirements - College Baseball Hall of Fame

# Hall of Fame Enshrinement

**Players** become eligible 5 years after the student-athlete's final collegiate season, not to include any active player on a professional baseball team roster.

Players must have completed one year of competition at a 4-year institution. Players must have made an All American team (post-1947) or

All League team (pre-1947 or have earned verifiable national acclaim).

Veteran and Historical Committees will have the right to nominate individuals from pre-1947 era.

**Coaches** will not include any active coach on a professional baseball team roster. Coaches must have achieved 300 career wins or won at least 65% of his games.

Players and Coaches will also be evaluated for their citizenship both during and after their active career.

Teams of great achievement at a 4-year institution may be enshrined by year of competition.

## Hall of Fame Recognition

\*\*Individuals who did not play or coach may be reviewed by the CBF for Hall of Fame Recognition on a case-by-case basis. This group could include other athletic staff, administrators, teams, media and supporters who furthered the sport with their endeavors, and may be recognized within a designated area of the Hall of Fame building.

### Selection Process

The **Research Committee** will be comprised of members of the Veterans and Historical Committees with its' principal responsibility to evaluate and recommend to all voters those individuals worthy of induction.

**Paid Institutional Level Members** have the ability to officially nominate individuals from their university and forward directly to the Research Committee for consideration.

**Paid Individual Level Members** are also encouraged to make recommendations to the College Baseball Foundation for evaluation and consideration.

All nominations and recommendations must include support material stating credentials of the person recommended, background information to be considered, in addition to statistical and biographical data, if possible.

To be considered by the Research Committee, the College Baseball Foundation must receive all nominations and recommendations no later than **March 1st** of each year.

# Voting

#### Feb 1 -- March 1 - Nominations Opened and Accepted

Paid Institutions, individuals and all members of Hall of Fame Committees may submit nominations SID's are asked to submit support material for candidates during this time.

**March 1 - Research Committee** compiles first **elimination ballot** and forwards names of the selected nominees to the full **CBF Nomination and Voting Committee**. The twenty candidates receiving the most votes qualify for the final official ballot.

**March 15th – April 15<sup>th</sup> - Final Official Ballot** e-mailed - The voting deadline is April 15th of each year. The accounting firm of J. W. Anderson and Associates, Lubbock, Texas, tabulates ballots.

**April 16th - Ballots counted -**. Inductees are announced each year at the discretion of the College Baseball Foundation prior to the College World Series in June. Those nominees on the final official ballot that are not chosen automatically remain on subsequent final ballots for a period of five years.

#### Membership

**D-1 Institutional Level - \$300 –** Entire University coaching staff and administrative personnel has the ability to officially nominate individuals directly to the Research Committee for consideration.

### Mid Major Level; Divisions II-III and NAIA Level - \$175

**Individual level - \$35** – May make unofficial recommendations to the College Baseball Foundation for evaluation and consideration.
