



## Message From The Acting Director

This year the **Institute** received its forty-ninth (49<sup>th</sup>) class and we have begun to look forward to the preparation of the **Fiftieth Anniversary Celebration** which will take the form of a **Conference at McGill from Friday, September 21 to Sunday, September 23, 2001**. This will be a major conference devoted both to air and space law issues. Sister institutions and major personalities in air and space law and international law will be invited to participate. Above all, it will be an occasion to celebrate the achievements of those who have taught and studied at the Institute over the years. I hope that a great many Institute graduates will attend. Please block off this date in your calendar.

The LL.M. class this year was a strong one with students from the usual variety of points of the globe. Basic courses in air and space law were given by **Professors Milde and Jakhu** respectively. **Professor Richard Janda** taught his course on *Government Regulation of Air Transport*. **Adjunct Professors Weber, Bunker and Saba** taught their course on *Comparative Air Law*. Professor Jakhu also taught his optional seminar on the expanding subject of *Government Regulation of Space Activities*. A number of adjunct professors and visiting lecturers, including **Mr Jeffrey Wool**, enriched the teaching at the Institute with their lectures on a wide variety of important topics in both terms. **Dr. Saba** led a number of excursions to the offices of various organisations in Montréal and Ottawa concerned with aviation and space law activities. I wish to pay tribute both to my colleagues in the Faculty and to all who served as visiting lecturers. Through them the Institute continues to offer the most complete programme of instruction in air and space law in the World.

As a result of the **Report of the Committee** chaired by former Dean **Roderick Macdonald** and its endorsement of the work and mission of the Institute, the University's *Vice-Principal Academic* and *Dean of Law* appointed a *University Search Committee* to recommend a candidate for the position of the Director of the Institute. As a mark of its confidence in the Institute, the University has also agreed that the new director shall be the holder of the **Tomlinson Chair in Global Governance in Air and Space Law**. The Committee began its work this Spring and I am hopeful that there should be a recommendation by the time of the 50<sup>th</sup> Anniversary Conference in September.

I have agreed to continue serving as Acting Director until the appointment of the Director.

## *IN MEMORIAM*

**ARNOLD W. G. KEAN, CBE**  
(1914 - 2000)

**Arnold Wilfred Geoffrey Kean, CBE** died on 18 January, 2000 at the age of eighty-five. On that day, the world lost one of the leaders of a generation that witnessed dramatic technological progress in the field of civil aviation and actively helped to advance its international regulation.

**The Institute of Air and Space Law** lost in him a great friend, visiting Professor and enthusiastic member of the Advisory Committee. He touched the lives of thousands of friends, colleagues and students around the world, in the **International Civil Aviation Organization (ICAO)** and the **United Nations**. He was a brilliant lawyer, scholar, author, civil servant and representative of the **United Kingdom** at many international law-making conferences.

He attended his first session of the ICAO Legal Committee in 1953 (and eventually became its Chairman) and over the years contributed significantly to the unification of international air law. In 1977, he was appointed **CBE**. In 1993, he became the laureate of the prestigious **Edward Warner Award** granted to him by the ICAO Council "for eminent contribution to the development of international air law." He served as member and later President of the **United Nations Administrative Tribunal**.

He will be remembered for his intellectual leadership, warm personality, tolerance, humility and a delightful sense of humour. His friends around the world treasure his memory and feel privileged to have known him and to have learned from him.

### New book by IASL Alumnus

The latest work of **Dr. Ruwantissa Abeyratne** (DCL, 1996) is entitled "*Frontiers of Aerospace Law*" and will be published by Ashgate of London in February 2002.

In this, his 7<sup>th</sup> book, Dr. Abeyratne introduces issues in aerospace law that are likely to continue to be challenges to be addressed into this the new millennium. There is a broad spectrum of issues that he handles including: space law issues, such as, legal liabilities pertaining to extra-terrestrial intelligence, environmental pollution in outer space, the conduct of persons in outer space and cyber-crimes affecting outer space activities; air law issues like aircraft noise, economic trends of airports and air navigation services, funding for aviation safety projects, emergent aero-medical problems and privacy issues pertaining to airline pilots.

Professor **I.H.Ph. Diederiks-Verschoor** observes with respect to the book that it "fills a great *lacuna* in the legal literature pertaining to current and future issues in aerospace law that have thus far not been given sufficient attention. It also emphasizes the growing links between air and space activities and attempts to find solutions to problems of great actuality and impact. This is a fascinating, original book and an asset to the existing literature".

### Coming to the Institute in 1956

Today, long distance travel has become a routine and frustrating experience. It no longer has the romance or excitement of many decades ago.

Forty-five years ago, I traveled to Montreal to join the **Institute of Air and Space Law**. This was an "adventure". I had not planned to leave *Australia* -- that was the stuff of wild dreams! The only exception would have been departing for a short-time on a troopship in the manner other members of my family had toured the world.

I left *Melbourne* in late July 1956, by a *Convair CV340* in first class (there was no economy class), to join my overseas transport at *Brisbane*. I went from a cold rainy winter to a warm tropical climate in a different Australian environment. What an improvement! I hoped that this was a symptom of what was coming.

I boarded the *Pioneer Star*, an American registered and manned cargo vessel of 15,000 tons. It cruised at fifteen knots and would take forty-two days to reach *Boston* its home port. It had accommodations for twelve passengers.

On the first night on board the ship the Chief Executive Officer gave me a tutorial on the rules of discipline of this ship. Male passengers were not allowed to berth on the top deck; they lived with the engineering crew on the lower deck. The top deck was reserved for female passengers and officers of the sail. Indeed, three ladies were on board our ship destined for Hamilton, Ontario, after living in Norfolk Island (once the most brutal convict settlements in the British world) for eight years. On the other hand, the only other male passenger was a priest returning to Boston after ten years in the British Solomon Islands Protectorate (this was not the best posting since his principal companion was his pet python that lived in the rafters of his residence).

In fact, only the segregation rule was observed. Other rules were systematically violated including the prohibition of not only the purchase and serving of liquor but also gambling. Ironically, at the first dinner, the CEO plied me with extra dry martinis, an experience which gave me an enduring loathing of gin and a passion, likewise abiding, for olives. Everyone bought liquor aboard. The Chief Engineer was the ship's bookmaker.

Our ship departed from Australia a couple of days later. The first five days were a "dud", because of the stormy weather that is commonly encountered in the *Tasman Sea*. The lower decks were frequently awash. Thereafter, for the next sixteen days on the Pacific the sea was smooth, the weather was fine, the skies cloudless and the nights were filled with stars. Apart from human beings, the sole living creatures we saw were a few seagulls and an albatross that accompanied the

ship for twelve days. The only land we saw crossing the Pacific was *Pitcairn Island*.

This should have been the most boring time. It was not. The apparently limitless sea engenders in one, not apathy, but a sense of timelessness and relaxation, a feeling enhanced by isolation. Nothing intruded on our privacy or the pleasant feeling that flowed out of the sea and sky.

On the 21<sup>st</sup> day we arrived at the spectacular and beautiful *Panama Canal* where I acquired a supply of liquor to return hospitality. We participated in parties every night on the engineering deck; and I still have an enduring admiration for the engineers.

Next we cruised through the Caribbean Sea, a warm benign sea in contrast to the Pacific Ocean. We docked at *Galveston*, Texas a rather rough and dilapidated town. With two passengers(ladies) from the upper deck I went to Houston. We saw on a wide screen the musical hit-of-the-year "Oklahoma".

*New Orleans* was the next port-of-call. The delta of the Mississippi sunset was a sight worth seeing. *New Orleans* was vivacious and quaint with extraordinarily large oysters and a thieving barber.

We finally arrived in *Boston* a few days later. Sadly, I had to leave my new friends.

The overnight train from Boston took me to *Montreal*. I checked in at a gracious hotel that no longer exists. I walked around the city on a glorious August Sunday. I located the Institute; and then just drifted until tired and hot. I sought refuge in the *Church of Mary Queen of the World* - it was being reconstructed at that time, but a master organist was practicing and filled the place with inspiring yet restful music.

I returned to the hotel and slept that afternoon. On the next day I reported to the Institute. But that is another story.

I had my time out. It was a wonderful experience and a prescient and necessary overture to the next twelve months of study.
