PERSONS, WILTON B., Deputy Assistant to the President and Assistant
to the President: Records, 1953-61

These records were received at the Library in 1961 along with other White House Files. As received, the records were marked and identified as the records of Wilton B. Persons and consisted solely of the 3 x 5 card index of office meetings and mimeographed sheets titled below an "Notes from Congressional Record, "Legislative Notes," and Fact Paper "Quotes". However, a bundle of General Persons' papers had been sent to Central Files by his office at the close of the Administration, arriving too late to be filed into Central Files. These papers remained with the unorganized material identified as "too late to process" material.

In February 1969, for convenience, and to hasten retrieval of these valuable papers, they were returned to and associated with other papers identified as General Persons' records. A staff archivist devised folder titles for these papers and they are listed below alphabetically by subject.

Additionally, other papers of General Persons may be found in Central Files, as filed there during General Persons tenure at the White House.

Eisenhower, 1960-61, pp. 348-352. In accordance with paragraph 7 of that letter, approximately 12% of the records in this file have been closed to research at this time.

SCOPE AND CONTENTS NOTE

The “alphabetical-subject series” in Box I of this file is the most important of the three series, In this series there is important material on the 1961 Federal budget, including correspondence among Maurice Stans (Director of the Bureau of the Budget), the President, Wilton Persons, and heads of Departments concerning the allocation of funds. There is material on the draft interim report on the Interstate Highway System. There is valuable information filed under “Legislation (Overall Program)” such as summaries of the status of HEW legislative proposals advice and analysis concerning the Reciprocal Trade Agreements Act of 1958, and the determination of “essential” Presidential and Departmental legislation. Some of the material in this first box of the file reflects Mr. Persons' duties in legislative liaison and shows the roles played by the Bureau of the Budget and the Departments in the formulation of legislation.

The series “index to office meetings” indicates the date and time of various office meetings attended by Maj. Gen. Persons and others in the White House” the names of persons attending the meeting and the subject (title) of the meeting.

The series Congressional Record Notes, Legislative Notes and Fact Paper “Quotes” constitutes the remainder of the file and consists of mimeographed narrative summaries.

The “Notes from Congressional Record” are brief summaries extracted from the Congressional Record and mimeographed for information of the White House Staff. The “Legislative Notes” are brief narrative reports of progress of legislation, activities in Congressional committees and public statements by members of Congress. These mimeographed sheets were prepared to keep White House personnel informed of Congressional matters. The Fact Paper “Quotes” were prepared by the Executive Branch Liaison Office and were designed to provide the Administration's spokesmen with the facts on the outstanding achievements of the Administration, issues on which the Administration's view was misunderstood, and goals of the Administration.

- January 20, 1953 Appointed Deputy Assistant to the President
- October 7, 1958 Promoted to Assistant to the President
- January 20, 1961 Resigned from White House
