Management measures for Areas where hunting is allowed			
<ul style="list-style-type: none"> <li>• <u>Hudson Strait</u>: respect of the Total Allowable Catch (TAC). Reduction of the TAC for the following year will be imposed in case of over-harvesting;</li> <li>• <u>Ottawa Islands 2006 pilot project</u>: if all belugas caught are not sampled or if it is determined they are coming from Eastern Hudson Bay stock, no future hunting will be authorized in that Area anymore;</li> <li>• Protection of females, calves and juveniles;</li> </ul>		<ul style="list-style-type: none"> <li>• Control of netting;</li> <li>• Harpoon first;</li> <li>• Use appropriate rifles;</li> <li>• Use equipment to retrieve the whales;</li> <li>• No waste of muktuk and meat;</li> <li>• Sharing of edible parts;</li> <li>• Provide jaw and skin samples for each beluga harvested</li> </ul>
