I hope you all had a wonderful summer.

You will see from the Newsletter what an arduous few months we have had since May. First, the seminar programme: this continued to be active and the range of topics was as richly diverse as ever. Secondly, we continued to organise conferences with gusto!! In May we co-organised with the Universities of Kao-hsiung and Tam-shui a conference to review developments in Hong Kong five years after the Handover. We value Taiwan-Hong Kong links; moreover, keeping different parts of the world informed about and interested in Hong Kong is one of the major missions of the Centre. On a wholly different topic was the closed-door Conference on "Asia Confers 2 CAFO: Giving with a Difference in Asia" where Asian grant organisations exchanged views on the philosophy and practices of grant making.

June was mad! On 11th and 12th June, we held a conference "Repositioning Hong Kong and Shanghai in Modern Chinese History", followed later in the month by another major event, the "China-India Research Institutes Roundtable", both events bringing together some of the leading scholars in the field. As always, conferees learnt from each other at the panels, but many of the discussions were continued at coffee breaks and dinners, and we hope such intellectual relationships may be maintained long after the conference is over.

As part of the "Bridging China and India: Hong Kong as the Key Link" project, we were most happy to have two visitors join us as Research Associates, Professor B.M. Jain from the University of Rajasthan, and Professor Zhang Li from Sichuan University.

There have been a number of personnel changes. In particular, we welcome back Dr. Chin Kong, who has given up his teaching appointment at Singapore University to re-join us, this time as a Post-doctoral Fellow. Chin Kong is a historian whose main interest is Chinese migration.

May I draw your attention to the publications of the Hong Kong Culture and Society Programme. We are very glad that the Readers Series is proving to be very successful among scholars, teachers as well as students; clearly the Programme's objective to stimulate interest in Hong Kong society and culture at different levels is being met.

專題:香港大學鄧志昂樓的由來

鄧公志昂先生,字景雲,廣東省南海縣九江鎮人,生於1872年,卒於1939年,是本港素有慈善家富商之稱鄧肇堅爵士的父親。鄧公年青時來港經商,最初與人合夥經營鴻裕銀舖,由於經營得法,於二十世紀初獨資成立鄧天福銀號,其後業務不斷擴展。1905年出任東華醫院主席,由於熱心參與社會公益事業,香港政府授與太平紳士銜。

1912年,鄧公聯結數十位南海同鄉,籌組僑港南邑樂善公局 [1927年改稱旅港南海商會],並向香港政府註冊。1916年,又成立南華燕梳公司,為香港早期的華資保險公司之一,商會與保險公司於同址辦公。1919年,鄧公捐款為商會購置永遠會所。

1925年,鄧公與布政司卓文伉儷及何東、周壽臣、羅旭龢、李右泉等本港知名富商,前赴澳門考察當地兒童工藝學校,回港後大力向香港政府建議推動本港工業教育,設立香港仔兒童工藝院〔後改稱工業學校〕,使貧困和失學的青少年能得一技謀生。

香港大學鄧志昂中文學院是本港第一所研究中國語文及文學的專門學院,最初時由前清翰林賴際熙、區大典講授中文及經史。1935年由首任教授許地山接掌,實行大事革新,課程分中國文學、中國哲學三組。繼許地山之後,著名學者陳寅恪、馬鑑、賴歐〔J.K. Rideout〕、林仰山〔F.S. Drake〕先後任教於學院。數十年來,鄧志昂中文學院培養了不少學術精英和社會知名人士,包括馮秉華、劉殿爵、金應熙、劉唯、王煜等。1952年,增設中國美術考古課程,《東方文化》學報於同年創辦。

1929年鄧志昂樓開始興建,直至1931年9月 28日由當時的港督貝璐爵士為該大樓揭幕啟 用,至今已有超過七十年的歷史。1950年代初, 成立東方文化研究院 [Institute of Oriental Studies],中文系遷出鄧志昂樓。東方文化研究 院設立的目的是幫助來港的外國學者和滯港的 中國學者進行與亞洲、中國、香港有關的研究, 著名學者錢穩便曾於研究院作短期訪問。1960年 代曾有不少外交官和外籍政府官員於研究院學 習中文,其中包括港督衛奕信爵士。1970年代以 後,鄧志昂樓曾用作多種用途,但大樓名稱維持 不變,此樓現撥作亞洲研究中心之用。

鄧志昂樓雖然是一座西式三層高平頂建築物,但它有一個連接校外般含道的中國傳統式牌坊入口,是香港大學絕無僅有的中式建築。如果將英國文藝復興時期建築風格的大樓和中式牌坊欄柵入口相配合來看,便可發現鄧志昂樓的預裝築、完全反映了鄧志昂中文學院原來成立的目的。由於鄧志昂樓甚具歷史價值,於1995年與大學堂、陸佑堂同時被香港政府列為法定古跡,建築物受法例保護。

UPCOMING EVENTS

Joint Workshop on "Consortium for the Study of Asian Economies/Social Science Research Council", 11-13 September 2002

A joint workshop on new cooperative projects on the study of Asian economies will be held at the University of Hong Kong during 11-13 September 2002.

The purpose of the workshop is to define and launch an initial set of Consortium activities and explore possible collaboration with the Social Science Research Council (SSRC) on these projects. The Consortium is an international, interdisciplinary, web-based network of social scientists dedicated to the study of the Asian economies and emphasising an institutional approach of the region's economies. The

Consortium held its inaugural meeting on 4-5 May 2001 on our campus. Representatives and scholars from 12 different universities and research institutes attended the meeting. Some concrete plans of cooperation within the Consortium were discussed. This workshop is the second of the Consortium's conference series. Apart from exploring the possibility of collaboration with the SSRC, a few new research projects to push for broad and interdisciplinary cooperation within the group will be discussed during the workshop. "Fifth China-ASEAN Research Institutes Roundtable 2002", 17-19 October 2002

From 17 to 19 October this year, the Centre of Asian Studies will be convening its Fifth China-ASEAN Research Institutes Roundtable. Following the success of the China-ASEAN Research Institute Directors Roundtable in 1998. the China-ASEAN Economic Relations Roundtable the China-ASEAN 1999. Socio-cultural Roundtable Relations in 2000. and China-ASEAN Strategic and Political Relations Roundtable last year, we will this year be hosting a fifth gathering. This year's Roundtable, entitled Regionalism and Community Building in East Asia, will examine the issues relating to regional integration in East Asia. The aim of the Roundtable, like those in previous years, is to stimulate interchange and understanding between policy studies, strategic studies, Asian studies and other research institutes in China, ASEAN and other East Asian polities, as well as to promote research on the focus issue.

We inviting approximately 30 are representatives of research institutes in the PRC and ASEAN, as well as selected institutes in Japan and Korea to speak on various aspects of East Asia regionalism. While our earlier Roundtables have

concentrated on the China-ASEAN relationships, this year we shall be addressing broader issues of regionalism and community building in East Asia. The Roundtable will comprise nine panels, each of three to four presenters, and a concluding Overview session. The Roundtable will be conducted in two languages — English and Chinese — and simultaneous interpreters will interpret all proceedings. Selected papers will be edited into a volume to provide a useful overview of the current views on East Asian regionalism.

The programmed panels are: 1) From ASEAN to ASEAN+3; 2) Economic Cooperation in East Asia; 3) Financial Cooperation in East Asia; 4) Regional Security Issues; 5) Historical and Contemporary East Asian Networks; Environmental and Energy Issues in East Asia; 7) Subregional groupings: Catalysts for Community Building?; 8) New Regional Initiatives; 9) Challenges to East Asian Regionalism; 10) The Future of an East Asian Community: Roundtable and Overview.

NEW ACTIVITIES OF ONGOING PROJECTS

Bridging China and India: Hong Kong as the **Key Link**

Professor B.M. Jain, our newly recruited Research Associate, arrived at CAS on 19 June 2002. He is a Political Scientist at the University of Rajasthan, Jaipur, India. He has authored over a dozen books, and over seven dozen research articles in research periodicals of national and international repute.

Professor Jain will work on the China-India Project during his three month assignment at CAS. As a political scientist, he will study India-China relations from the politico-strategic point of view. Also, he will examine the role of cultural norms including domestic politics in shaping foreign policy behaviour of each country towards the other. His proposed study is also aimed at identifying

those correlates that might enable both countries to contribute to redesigning the post-Cold War international system on the basis of equity, equality and fairness. Professor Jain presented a paper titled "Global Governance and Multilateral Financial **Institutions:** Diagnosis Prognosis" at the World Congress of International Peace Research Association held in Seoul, 1-4 July 2002. He also chaired a session on Global Political Economy Commission at the conference. His recent articles include "Globalisation and Regionalisation in International Relations and Foreign Policy", Journal of Diplomacy and Foreign Relations (Kuala Lumpur, Malaysia), September 2001: and


"Ethno-political Conflicts in South Asia", Indian Journal of Asian Affairs, June 2002.

Professor Zhang Li, another Research Associate of the Project, arrived at CAS on 21 June 2002. He obtained the degrees of BA from Sichuan University (1982), and MA from the Chinese Academy of Social Sciences (1984).

Professor Zhang was visiting scholar/associate researcher at Oxford University (1987-89) and Jawaharlal Nehru University (1998-99). During the last few years, his major research interests and publications covered Sino-Indian strategic interactions in post-Cold War scenario, India's nuclear doctrine and nuclear diplomacy, re-shaping Indo-U.S. relations, sociocultural contacts between China and South Asia, and origin and development of the Tibet issue. He is currently involved in the China-India Project (HKU), India's National Security after the Cold War and Its Implications for China (SU), China-India Relations in the 21st Century (SU), and China's Western Development Strategy and Its Security Environment (Sichuan Academy of Social Sciences).

Early trained in history and comparative culture, Professor Zhang has expanded the range of interests to other fields including international relations and strategic analysis. As an experienced analyst in the field of South Asian international relations, he currently works on some major projects sponsored by the State and several prestigious institutes. He is the author of Jawaharlal Nehru as a Statesman and a Diplomat, which is among the initiative researches in this respect in China since the border war in 1962 and

from a very Chinese perspective. He came to CAS after attending the Conference on "The Cold War, Post-Cold War and the Tibet Issue" held at Harvard in May 2002, where he served as one of the discussants on the prospects of dialogue between the Chinese government and Dalai Lama. These



studies have benefited much from his personal experience of scholarly investigation along the Tibetan Plateau, the Takla Makan Desert, and the rural India as well as the recent adventured tours along the wild Sino-Indian borderline and through the Kashmiri valley during the Kargil conflict. Now a visiting fellow at CAS, he expects the 3-month collaborated programme to be a good chance to deepen his academic insight in general and facilitate the understanding of Sino-Indian relations in particular.

Music is one of her favourite hobbies, especially hip-hop and R & B. Her recommendation for recent released albums is Jay Chou's latest album, so great!






Hong Kong Reader Series

Being part of the "Creating Learning and Hong Kong Culture and Society Project" funded by the UGC Teaching Development Grants, the "Hong Kong Reader Series" aims at providing useful materials on Hong Kong studies facilitating teaching and learning at tertiary level. Broadening Course for the Academic Year 2002

A broadening course entitled "The Way We Grew Up – A Personal Study of Hong Kong Culture and Identity" was offered by the Centre of Asian Studies in Spring 2002.

It introduced students to Hong Kong culture and society through an interdisciplinary approach and fostered critical engagement with popular and academic narratives of Hong Kong's histories and identities. It encouraged students to attend to local experiences and voices and to relate those to broader processes.

Readings and lectures were complemented by videos and field visits. An oral history project was an integral part of the course. Besides helping to consolidate a heightened awareness of different strategies of representation and their implications, it gave students an opportunity to construct, in collaboration with other members of Hong Kong society, a personal version of Hong Kong history. Publication of selected project reports in electronic form is being planned, and the course will be offered for the second time in Spring 2003.

RECENT CONFERENCES AND SEMINARS

「五年來香港社會形勢論評」研討會-2002年5 月2-6日

亞洲研究中心與香港政策研究所於今年五 月初率領一代表團到台北及高雄參加與台灣淡 江大學及高雄大學合辦的「五年來香港社會形勢 論評」研討會。討論議題包括香港回歸五年的社會回應和適應、法律與管治、經濟、文化、中港關係、港台關係及台灣看香港回歸等。香港的代表團名單包括港大、理大學者、香港政策研究所成員、法律/經濟專家,以及文化、藝術與義務工作者。

Closed-door Conference on "Asia Confers 2 CAFO: Giving with a Difference in Asia", 8-11 May 2002

The Centre was host to this important event organised by the Conference of Asian Foundations and Organisations (CAFO), a major network of nonprofit organisations in Asia. Chairpersons and senior programme staff of leading grant-making foundations from 11 Asian countries and territories gathered to exchange views on topics of current importance in the grant-making world. included the role of Asian indigenous foundations in developments both at the regional and national They did in-depth analysis of case presentations on foundations from different backgrounds with various missions. From these they made observations about principles and modus operandi about grant-making practices peculiar to the Asian cultures which can be different from the West. Particularly interesting is the philosophy of philanthropy among the traditional Asian donors whose perspectives of accountability are different from what Western institutions advocate.

Participants also agreed that to maximise cost-effectiveness and for grants to go where they



should, mechanisms are needed to enable grant-makers to meet regularly with grant-seekers for better matches of demand and supply of philanthropy money. This will be the main pursuit of a further conference involving both parties probably to be held in Macau in May 2003.

International Conference on "Repositioning Hong Kong and Shanghai in Modern Chinese History", 11-12 June 2002

The conference brought together from around the world some of the world's leading scholars of Hong Kong and Shanghai. The conference was the third of a series of conferences on modern Chinese city, co-organised by Hong Kong Institute for the Humanities and Social Sciences and Centre of Asian Studies of the University of Hong Kong, New York University and Harvard University. These conferences aimed to provide a forum to assess and re-interpret the modern Chinese metropolis such as Shanghai and Hong Kong as social, political, cultural and economic space and reposition them in modern Chinese history. (The first was held in New York and hosted by NYU in April 2001, and the second was held at Harvard University and hosted by the Fairbank Center in November 2001).

Our conference was a big success, it drove home the point that the history of modern China is inconceivable without a thorough account of its metropolitan centres, Shanghai and Hong Kong in particular. As the leading metropolis in China and two of the biggest commercial, financial, and cultural centres in the world, Shanghai and Hong Kong lay claim on modern China's imagination and Not only has Shanghai and Hong creativity. Kong's socioeconomic energy provided a fertile ground for truly global forces of change; their everyday life, intellectual and artistic productions have also given rise to an urban landscape and cultural tradition that constitute a rich chapter in the history of cities and modernism. From this perspective, the history of global modernity is incomplete without including Shanghai and Hong Kong as an integral part of its narrative. placing Shanghai and Hong Kong in international league of cities, this conference facilitated a productive encounter between the local-historical studies on the two cities and the analytical and theoretical interest comparative urban-cultural studies.

The conference explored new issues and perspectives emerging from the rapidly changing realities (and thus the historical understandings) of Shanghai and Hong Kong today as well as those from the rapidly accumulating scholarship on the two cities. Thematically, the conference had its

dual focuses of 1) re-examining the city as a site for political consciousness and movements which, within the particular Chinese situation, place modern Shanghai and Hong Kong in the world-historical currents of ideology and politics; and 2) exploring the cultural experience of Chinese modernity as it is historically crystallised in the particular texture of Shanghai and Hong Kong's metropolitan culture. Conceptually, the conference aimed to search for a critical and constructive model beyond the old "Western impact/Chinese response" approach and its negation, namely the "China-centered" approach. Instead of viewing Shanghai/Hong Kong/China as a passive receiver of Western influences or as a self-evolving continuum of autonomous time-space, conference looked at China within the global force field of capitalism, treating the Shanghai and Hong Kong experience as a construct made possible by a wide variety of economic, social, political, and cultural factors that are often international in origin but local in their actualisation. As former treaty ports and the forerunners of socioeconomic, political, and cultural change in modern times, Shanghai and Hong Kong's metropolitan culture and political experience provide a rich urban text to a global perspective sensitive to the continuities and discontinuities of national and local histories. The discussion of these topics was facilitated by panel arrangements designed to bring together scholars of different disciplinary and cultural backgrounds to discuss concrete events in Shanghai and Hong Kong in reference to theoretical issues as general as

colonialism and semi-colonialism, cultural form and cultural image, and leisure and consumption or as specific as the Tongxiang networks, business communities and new urban space today such as Shanghai's "Xin tiandi".

China-India Research Institutes Roundtable 2002, 27-28 June 2002

Following the marked success of our Inaugural China-India Research Institutes Roundtable held in June 2001, the Centre of Asian Studies convened a Second China-India Research Institutes Roundtable in June of 2002. The aim of this year's Roundtable, like that in 2001, was to bring together representatives of research institutes and other bodies in India and China to meet each other and engage in deliberation on issues of common concern. This year the focus was on economic relations and comparisons between East Asia and South Asia.

We invited to Hong Kong 35 representatives from research institutes in China and India, as well as a smaller number from Japan, Korea, Taiwan and Hong Kong, to come together in a small conclave at the University of Hong Kong. The papers ranged from those which examined global issues, to more specific regional issues, to questions

of national economic development. The speakers included government representatives, think-tank members, research institute fellows, and members of business organisations. This ensured that a wide range of opinions from diverse spheres were heard and discussed.

Equally important was the fact that the Roundtable provided a venue for scholars from China and India to meet informally between sessions and learn more about their counterparts in the other country. The social interaction was promoted by an evening reception provided by Mr Ashok K. Kantha, Indian Consul General in Hong Kong at his residence. This provided one of the highlights of the Roundtable proceedings.

Given the burgeoning economic links between India and China and the many common problems faced by the two countries, this year's Roundtable was particularly timely, as well as being an informative and stimulating gathering. There are few opportunities for researchers and policy makers from these two regions to meet and interact on such issues and the role of the CAS in promoting such interaction appears to be increasingly recognised.

The Roundtable was kindly sponsored by the Japan Foundation Asia Center and the University of Hong Kong Foundation for Educational Development and Research, to whom our thanks are due.

《〈中國新音樂史論〉研討會論文集》是台北、北京和香港先後舉行"《中國新音樂史論》研討會"的論文和討論發言的結集。劉靖之教授著《中國新音樂史論》(1988年,台北燿文)論述了近百年來中國新音樂發展的歷史,使台海兩岸各執一詞的近現代新音樂史,增添了第三地的說法,因此引起兩岸三地音樂學術界的重視,分別舉行了研討會,參加會議的專家學者總計超過一百人,為近年來音樂史學界少有的盛事。會議論文及討論發言錄音記錄達六十餘萬言,無論正反意見,本書概作直錄,三地分為三卷,卷四為劉教授對三地研討會的總回應。
