- 1. <u>Background</u>. The Aircrew Program provides an opportunity for recruits and fleet personnel to become career enlisted aircrew. The Aircrew Program for recruits is a 5-year enlistment program that guarantees men and women a flying assignment in either fixed wing aircraft or helicopters and provides training via various Class "A" Schools. It also provides accelerated advancement to paygrades E-2 and E-4 for those who volunteer for rescue swimmer aircrew duties, and to paygrade E-4 for those selected for P-3 flight engineer duty. Applicants must volunteer for flying duty (see MILPERSMAN 1220-020), be capable of passing a Class II swim test, and pass an aviation flight physical.
- 2. <u>Qualifications Required</u>. New recruits must meet enlistment eligibility requirements specified in reference (a). Other selection requirements include the following:
- a. **Test Scores**. All recruits and nondesignated airmen must have minimum Armed Services Vocational Aptitude Battery (ASVAB) score of **AR** + **2MK** + **GS** = **196**. Upon reporting to the Naval Aircrew Candidate School (NACCS), applicants' ASVAB scores will be reviewed to ensure further qualification for a specific source rating. Fleet inputs and Navy veterans (NAVETs)/other service veterans (OSVETs) already designated in aircrew source ratings (e.g., AD, AM, AT, etc.) must meet the required **AR** + **2MK** + **GS** = **196** aircrew ASVAB score requirement.
- b. **Age**. Thirty years or less at time of enlistment or reenlistment. Waivers for Regular Navy fleet volunteers will be considered by Navy Personnel Command (NAVPERSCOM), Aviation Assignment Branch (PERS-404) or NAVPERSCOM, FTS Aircrew Assignments Branch (PERS-4012) for FTS fleet volunteers on a case-by-case basis.

- c. **Medical**. All applicants must meet medical standards as specified in reference (b).
- d. **Physical Conditioning**. The Aircrew Program is physically demanding and requires strong swimmer skills. Applicants must pass the Navy Physical Fitness Assessment (PFA) with a grade of "satisfactory-medium" in all categories within 90 days of transfer to NACCS. Nonswimmers cannot successfully complete the program.
- e. All applicants must read and sign the Aircrew Statement of Understanding, which outlines the physical requirements needed to commence and graduate from NACCS and Rescue Swimmer School (RSS). Rescue swimmer applicants must sign both the Aircrew and Rescue Swimmer Statements of Understanding.
- 3. Aircrew and Rescue Swimmer Program Statements of Understanding. New recruits must sign the applicable Statements of Understanding contained in reference (a) as part of their enlistment process. Fleet volunteers must sign the following NAVPERS 1070/613 (Rev. 10-81), Administrative Remarks entry:

- (3) In full flight gear, tread water for 2 minutes followed immediately by 3 minutes of drown-proofing.
- (4) 200 yards (50 yards each breaststroke, elementary backstroke, sidestroke, and American crawl).
- (5) Jump from a 12-foot tower and then swim 15 yards underwater wearing flight suit and boots using a modified breaststroke, immediately followed by floating using trouser inflation techniques.
- (6) 75-yard flight equipment swim; 25 yards sidestroke; 25 yards breaststroke; 25 yards elementary backstroke; and 25 yards American crawl.

#### Rescue Swimmer Program Statement of Understanding

NOTE: AIRR/rescue swimmer candidates must sign both the Aircrew and Rescue Swimmer Statements of Understanding.

"[DATE]: I [member' name] am /am not [circle one] volunteering for training as a helicopter rescue swimmer. I understand rescue swimmers may be required to risk their lives during a rescue at sea. They are trained to conduct rescues efficiently, effectively, and safely. In most rescue situations, the swimmer leaves the helicopter and enters the ocean. Upon reaching the survivor, the swimmer removes the parachute and prepares the survivor for hook-up to the rescue device. A survivor in a state of panic may force the swimmer underwater, but techniques taught to the swimmer will help to overcome this resistance. Once the swimmer and survivor are in the aircraft, the swimmer provides advanced first aid until medical assistance is available.

- 2. **To graduate** from Rescue Swimmer School, I must do the following during the course of training:
- a. 90 minutes of intensive calisthenics and 30-35 minute cross-country runs daily.
- b. 800M swim in 20 minutes wearing rescue swimmer equipment (mask, fins, snorkel, short wetsuit, and Search and Rescue (SAR) Harness with deflated floatation).

- c. 400M buddy tow in 16 minutes wearing rescue swimmer equipment.
- d. 2000M swim in 50 minutes wearing rescue swimmer equipment.
  - e. 4 pull-ups in a flight suit and boots within 2 minutes.
- f. Carry two 50-pound dumbbells 100 yards on flat terrain over 4 obstacles 12-14 inches in height within 2 minutes.
  - g. Walk 1 mile with a medevac litter within 16 minutes.
- h. Swim 500 meters in SAR gear immediately followed by 400 meter buddy tow within 27 minutes.
  - i. Weekly strength training with free weights and machines.

- 4. <u>Drop-On-Request (DOR)</u>. DOR at any time during training (Military Entrance Processing Station (MEPS), Recruit Training Center (RTC), NACCS, RSS, Class "A" School, Fleet Replacement Squadron (FRS)) is cause for disqualification and disenrollment from the Aircrew Program. Disposition of members disenrolled will be per para. 12 or this article.
- 5. <u>Disqualification Due to Drug Usage</u>. Due to the inherently hazardous nature of this program, use of illegal or controlled substances is grounds for application disapproval. Drug waivers (for cannabis only) will be considered on a case-by-case basis by NAVPERSCOM (PERS-4011D2).
- 6. <u>Security Clearance Required</u>. Applicants for the Aircrew Program must have citizenship and character requirements to be granted a minimum of a Secret clearance.
- 7. <u>Service School Assignments</u>. For strikers and new recruits, the Aircrew Program provides assignment to a Class "A" School in any of the career aircrew source ratings listed below. The specific Class "A" School to be assigned will be based on member's qualifications, personal desires, and needs of Navy.

- 8. <u>Training Cycle</u>. The normal training pipeline for aircrew candidates is:
  - a. Recruit Training Center (RTC)
  - b. Naval Aircrew Candidate School (NACCS) (Pensacola)
- c. Rescue Swimmer School (RSS) (Pensacola rescue swimmers only)
  - d. Class "A" School (Pensacola)
  - e. Fleet Replacement Squadron (FRS) (various locations)
  - f. Initial squadron assignment

NOTE: Designated personnel do not attend RTC or Class "A" School.

- 9. <u>Terms of Enlistment</u>. New accessions shall be enlisted in United States Navy/Full Time Support Program (FTS) for 4 years and concurrently execute a
- a. NAVPERS 1070/621 (Rev. 01-00), Agreement to Extend Enlistment for 12 months (Regular Navy Sailors), or
- b. NAVPERS 1070/622 (Rev. 01-00), Agreement to Recall or Extend Remain on Active Duty for 12 months (for FTS Sailors),

using appropriate narrative reason entry contained in the "Contents of NAVPERS 1070/621 or NAVPERS 1070/622" paragraph below. Fleet applicants must obligate per MILPERSMAN 1306-604 and 1306-908.

### 10. Apprenticeship and Paygrade

- a. New accessions accepted for the **Aircrew Program** shall be enlisted in paygrade E-1. This is not to preclude enlistment at paygrade E-2 or E-3 per reference (a). Fleet applicants are accepted in present paygrade.
- b. Individuals who enlist for rescue swimmer training as part of the Aircrew Program are authorized accelerated advancement to paygrade E-2 upon successful completion of recruit training. Accelerated advancement to paygrade E-4 is authorized for aircrew recruits and fleet volunteers only after completion of both RSS and Class "A" School, provided eligibility is maintained to continue in the Aircrew Program.
- c. Individuals selected for P-3 flight engineer (Navy Enlisted Classification (NEC) 8251) training as part of the Aircrew Program are authorized accelerated advancement to paygrade E-4 upon successful completion of FRS training and resultant NEC 8251 designation as a P-3 flight engineer.
- d. If a member is disqualified for aircrew duties because of disciplinary infractions prior to advancement to paygrade E-4, eligibility for accelerated advancement to E-4 is terminated. This shall not preclude an advancement to E-2 or E-3 based on normal advancement criteria.
- e. Accelerated advancement to paygrade E-4 requires a 5-year total active duty obligation. If a member is reduced in rate subsequent to accelerated advancement to E-4, there is no reduction in active obligated service (OBLISERV).

## 11. Disqualification and Disenrollment

- a. Those who fail to remain qualified for this program will be disenrolled from aircrew training.
- b. Cancellation of extension of enlistment because of disenrollment from the Aircrew Program shall be per MILPERSMAN 1160-040. Applicants must be specifically counseled if they attrite, DOR, request removal from flight status, or are found not desirable for continuation in the Aircrew Program, the extension agreement may or may not be canceled depending on manning requirements. Cancellation requests should be referred to NAVPERSCOM (PERS-4011D2).
- c. Applicants who accept accelerated advancement to E-4 and then attrite retain their extension obligation.

## 12. Disposition of Members Disenrolled

- a. The Aircrew Program is voluntary. Members may request to be disenrolled at any time. If disenrolled at any point during training, assignment to a Class "A" School is not guaranteed and is subject to needs of the Navy. Fleet personnel will normally be returned to their previous command.
  - b. Process disenrolled personnel as follows:
- (1) **RTC**. Per Navy Recruiting Command (NAVCRUITCOM) / NAVPERSCOM (PERS-4011E) quarterly reclassification guidance.
- (2) NACCS. Disenrollees may be reclassified provided they meet the provisions of MILPERSMAN 1236-020 and 1220-020; however, assignment to Class "A" School is not guaranteed and is subject to the needs of the Navy. If not approved for reclassification and follow-on Class "A" School, NACCS attrites will be made available for fleet assignment as a nondesignated airman.
- (3) RSS/P-3 Flight Engineer. Members disenrolled from RSS or P-3 flight engineer FRS training are not eligible for automatic advancement to E-4 and may not necessarily be retained in the Aircrew Program. For members disenrolled from RSS, reclassification, assignment to Class "A" School, or reassignment within the Aircrew Program is not guaranteed and is subject to needs of the Navy. NAVPERSCOM (PERS-4011D2) is final authority for determination of Aircrew Program and/or Class "A" School eligibility. If not approved to remain in the Aircrew Program,

RSS attrites will be made available for fleet assignment as a nondesignated airman.

(4) Class "A" School. Members who fail to complete Class "A" School for academic reasons may, if qualified, be reclassified to another Class "A" School that is a source rating for Aircrew. Inability to successfully complete Class "A" School may be cause for disqualification from the Aircrew Program and fleet assignment as a nondesignated airman.

### 13. Contents of NAVPERS 1070/621 or NAVPERS 1070/622

- a. NAVPERS 1070/621 or NAVPERS 1070/622 is required for enlistment in the Aircrew Program. It shall be prepared and signed by applicant on the day member is enlisted (new accession). Fleet applicants must obligate under MILPERSMAN 1306-604 and 1306-908. A minimum of 5 years total active service on current enlistment is required.
- b. Specific wording of the narrative reason for extension is as follows:

#### (1) Rescue Swimmer Volunteers:

Training in the Aircrew Program as a rescue swimmer and accelerated advancement to paygrade E-4 under MILPERSMAN 1220-010. Accelerated advancement to paygrade E-4 is authorized only after successful completion of both Rescue Swimmer School and Class "A" School. I understand this extension becomes binding upon execution and thereafter may not be canceled except as set forth in MILPERSMAN 1160-040.

### 14. Application Submission

- a. Fleet Aircrew Program applicants (less FTS) should send NAVPERS 1306/7 (Rev. 01-03), Enlisted Personnel Action Request to NAVPERSCOM (PERS-404) via (1) their commanding officer, and (2) NAVPERSCOM (PERS-404E), citing this article as reference.
  - b. FTS should send applications to NAVPERSCOM (PERS-4012).
  - c. Include in application package a certified copy of
    - (1) flight physical,
    - (2) second class swim qualification,
    - (3) last two evaluations
    - (4) ASVAB scores,
- (5) Signed copies of both the Aircrew and Rescue Swimmer Statements of Understanding,
  - (6) Satisfactory-medium score on most recent PFA, and
- (7) Secret clearance. If a secret clearance is not held, member's command must initiate prior to transfer to NACCS.
- (8) Member must have at least 3.0 on all evaluation/ fitness report (FITREP) performance traits and been recommended for retention with promotable or higher within the past 24 months.
- (9) No nonjudicial punishment (NJP), courts-martial, civil conviction, or significant involvement with civil authorities within the past 24 months.
- d. Aircrew Program volunteers may be selected on a returnable quota basis.

- 1. **Qualifications**. Qualifications for naval aircrewman (NAC) designation are as follows:
  - a. Be qualified as a crewmember per BUPERSINST 1326.4D.
- b. Maintain a consistent record of above average performance per MILPERSMAN 1220-010.
- c. Successfully complete a Chief of Naval Operations (CNO) approved aircrew training syllabus including prerequisite pipeline courses that award a distribution Navy Enlisted Classification (NEC) of 78XX, 82XX, 8401, or 94XX.
- d. Successfully complete positional qualification requirements for the respective aircraft within 18 months of reporting to the permanent duty station per OPNAVINST 3710.7S.
- e. Be assigned in a DIFCREW status with a distribution NEC of 78XX, 82XX (except 8201 NAC candidate), 8401, or 94XX, qualified and recommended for a crewmember NEC of 78XX, 82XX, 8401, or 94XX.
- f. Be detailed into a valid aircrew billet requiring frequent and regular flying duty, defined by billet special category (for all NEC 82xx, 78xx, and 94xx billets) or by billet NEC (for NEC 8295, 8296, and 8401 billets). Members of non-

aviation commands must still participate in frequent and regular flying in order to qualify for NAC designation.

## 2. Procedures for NAC Designation

- a. Commanding Officers (COs) shall certify in writing the member's qualifications in aircraft positions per this manual and OPNAVINST 3710.7S.
- b. Commands shall ensure the recording of the proper NEC. If it is not reflected on the Enlisted Distribution and Verification Report (EDVR), certification of the NEC shall be submitted via NAVPERS 1221/1 (Rev. 06-92), Navy Enlisted Classification (NEC) Change Recommendation as an enclosure to designation letter.
- c. COs of aviation units may award NAC designations after ensuring that criteria within this article, BUPERSINST 1326.4D, and OPNAVINST 3710.7S have been met. This authority may not be delegated "by direction." An aircrew designation letter should be prepared per BUPERSINST 1326.4D and presented to the member when the Aircrew Breast Insignia is awarded.
- d. Members of non-aviation commands who meet the requirements for naval aircrew designation will receive designation letters signed by the CO of the aviation command conducting the initial Naval Air Training and Operating Procedures Standardization (NATOPS) qualification. The CO of the non-aviation command should present the aircrew designation letter and Aircrew Breast Insignia to the member.
- e. A copy of the local aircrew designation letter and NAVPERS 1221/1 shall be forwarded to Navy Personnel Command (NAVPERSCOM), Aviation Assignment Branch (PERS-404E) (USN)/Naval Reserve Personnel Center (NRPC) (N4) (USNR/TAR) for review of requirement completion and for a record-entry certificate of designation as a NAC. Designations awarded in error will be revoked by NAVPERSCOM (PERS-404E) or NRPC (N4). Commands receiving notification of NAVPERSCOM revocation shall inform members of their lack of naval aircrew designation status and shall remove the member's authorization to wear the NAC Breast Insignia.
- f. Upon receipt and approval of an aircrew designation request, NAVPERSCOM (PERS-404E) shall issue a certificate of designation for initial qualification only.

- g. Only active aircrew, on and after 1 July 1997, are eligible for certificates of designation. They may not be awarded retroactively.
- 3. Revocation of NAC Designation. COs shall revoke the naval aircrew designation from any aircrew who is permanently removed from flying status per BUPERSINST 1326.4D; however, members who are permanently disqualified from flying due solely to medical reasons will lose their NAC designation but retain the eligibility to wear the NAC Breast Insignia. Any aircrew who are temporarily removed from flying status will also lose their NAC designation but retain the eligibility to wear the NAC Breast Insignia. All aircrew losing their NAC designation or eligibility to wear the NAC Breast Insignia shall be counseled by their CO regarding their specific aircrew status.
- 4. Reinstatement of Aircrewman Designation. If a previously-designated aircrewman is reinstated to duties involving flying per BUPERSINST 1326.4D, the member may apply for reinstatement of naval aircrew designation and eligibility to wear the Naval Aircrew Breast Insignia. Command-endorsed requests for reinstatement of the NAC designation or right to wear the NAC Breast Insignia shall be forwarded to NAVPERSCOM (PERS-404E) (USN) or NRPC (N4) (USNR/TAR) for approval. Members may not wear the Insignia until NAVPERSCOM approval is received.

## 5. Administrative Procedures

- a. Whenever a member qualifies as a NAC, an entry shall be made on the NAVPERS 1070/613 (Rev. 10-81), Administrative Remarks of the service record, indicating the date of qualification, type of aircraft in which qualification was received, the authorization from Chief of Naval Personnel (CHNAVPERS) for awarding the NAC designation, and the authorization to wear the Aircrew Breast Insignia. The NAC designator shall be affixed to the member's rate in the following manner: AMCS(NAC), etc. A personnel diary transaction shall be submitted reporting the change of enlisted designator to NAC (Code 6).
- b. Whenever a member is disqualified from aircrew duty, an entry shall be made on NAVPERS 1070/613 showing the reason for disqualification and rescinding of authorization to wear the Aircrew Breast Insignia (except in the case of physical disqualification). The NAC designator shall be canceled and a

personal diary entry to that effect shall be made as follows: "CH designator to NONE."

- c. The assignment or removal of Aircrew NECs shall be per NAVPERS 18068F and BUPERSINST 1326.4D.
- d. Proper entry of qualification or disqualification shall be made on special duty abstracts of the health record at the time of original physical examination and annual reexaminations thereafter. COs shall be informed of the results of all physical examinations.
- e. In all reports, records, or other correspondence concerning active NAC, the NAC designator and appropriate distribution classification (DNEC) shall be included after the rating abbreviation. For example: AMCS (NAC) (8211/8215) or AWCS (NAC) (7836). Correspondence concerning inactive aircrewmen does not require this identification.
- 6. <u>Service Record Entries</u>. The following service record entries are used in conjunction with various requirements of the NAC Program:
- a. "[DATE]: I, [Member's Name], volunteer for duty involving flying and understand that I must maintain those qualifications specified by Chief of Naval Operations and Chief of Naval Personnel during the periods I am actively assigned to such duties. This agreement shall remain valid until such time as it is rescinded by me or that I am no longer qualified for such duties."

- 7. <u>Service Record Entries for Reenlistment</u>. The following entries shall be carried forward on reenlistment of NAC as appropriate:
- a. "[DATE]: [Member's Name] volunteered for duty involving
  flying."

- b. "[DATE]: Awarded designation as a naval aircrewman.
  Authority [fill-in]."
- c. "[DATE]: [Member's Name] was disqualified from duty involving flying as a result of [reason]."
- d. "[DATE]: [Member's Name] has accumulated the following hours of training and operational flying:
  - (1) Total from previous enlistments [fill-in].
  - (2) Total on first past enlistment [fill-in].
  - (3) Total to date [fill-in]."
- 8. <u>Service Record Entry After Ground or Flight Training</u>. Upon successful completion of a ground or flight training course or syllabus, a service record entry shall be made indicating the following:
  - a. Date of completion of course.
- b. Title and or identification number of course or syllabus.
  - c. Type of equipment or aircraft (include flight hours).

## 9. NAC Insignia

- a. The NAC Insignia consists of a Breast Insignia as prescribed by NAVPERS 15665I.
- b. Designation as a NAC by NAVPERSCOM per this article carries authorization to wear the Aircrew Breast Insignia.
- c. The right to wear the Aircrew Breast Insignia shall be rescinded only when a member is disqualified for NAC duty for reasons other than physical disqualification and the aircrew designator is removed. Physical disqualification does not revoke the right to wear the Aircrew Breast Insignia.
- d. Authority granted under previous directives to wear the Combat Aircrew Insignia with battle stars remains in effect throughout a member's naval career.

## 1. **Policy**. Training for

static-line,	
military free-fall, and	
high altitude low opening (HA	LO) premeditated personnel parachute (P3)
operations	

is accomplished by successful completion of the prescribed course of instruction while attending the

U.S. Army Basic Airborne Course,
U.S. Army Basic Military Free-Fall Parachutist Course, or
other training certified by Chief of Naval Education and Training
(CNET) or approved by the Chief of Naval Operations (CNO).

2. <u>Definition</u>. The term "Competent Orders" as used in this article shall be construed to include orders to the commanding officer of an activity whose mission includes P3 operations. Commanding officers of units whose mission does not include P3 operations, but have jump qualified personnel in their command, are authorized to write permissive Temporary Additional Duty (TAD) orders for these personnel, to a unit whose mission includes P3 operations, to maintain qualifications.

- 3. <u>Static-Line Parachute Jumper</u>. A static-line parachute jumper is a member of any rating or grade who meets the following requirements:
  - a. Is a volunteer for parachute jumping duty.
- b. Is qualified according to the medical standards set by the Bureau of Medicine and Surgery (BUMED) at the time of designation and periodicity of physical thereafter.
- c. Successfully completed formal military static-line parachutist training at Ft. Benning, Georgia or at a formal interservice training site.
- d. Is authorized by competent orders to engage in P3 operations as an essential part of military duty.
- 4. <u>Free-Fall Parachute Jumper</u>. A free-fall parachute jumper is a member of any rating or grade who meets the following requirements:
- a. Is a qualified parachute jumper as defined in block titled "Static-Line Parachute Jumper."
- b. Is qualified for unpressurized high altitude parachute jumping according to the medical standards set by BUMED at the time of designation and annually thereafter.
- c. Successfully completes the prescribed program of instruction while attending a formal, interservice training facility including a minimum of 10 military free-fall parachute jumps, at least 2 of which must have been conducted carrying full combat equipment (1 day/1 night).
- d. Be assigned or attached, under competent orders, to a Navy organization whose mission includes the requirement for military free-fall parachute jumping or have a part of their military duty the authorization to engage in P3 operations.
- 5. <u>HALO Parachute Jumper</u>. A HALO parachute jumper is a member of any rating or grade who meets the following requirements:
- a. Is a qualified parachute jumper as defined in block titled "Static-Line Parachute Jumper."

- b. Successfully completes the prescribed program of instruction while attending a formal, interservice training facility including a minimum of 16 HALO jumps.
- c. Be assigned or attached, under competent orders, to a Navy organization whose mission includes the requirement for frequent and regular participation in HALO operations or have as part of their military duty the authorization to engage in P3 operations.

## 6. Requalification Procedures

- a. Requalification procedures are to perform one or more parachute jumps during any 3 consecutive calendar months, unless prevented from doing so by
  - (1) limited duty status for medical reasons,
- (2) military operations (including operations under other than combat conditions), or
  - (3) absence of jump equipment or aircraft.
- b. Whenever conditions are such that the required jumps cannot be made in every quarter, the minimum requirements may be met by performing 4 static-line, free-fall, or HALO jumps during a period of 12 consecutive calendar months, and such requirements may be met any time during that period.
- c. All officer and enlisted parachutist with an officer designator or Navy Enlisted Classification (NEC) associated with a Navy community whose mission requires static-line, free-fall, or HALO operations (i.e.; 1130/5326 SEAL, 1140/5337 EOD), should maintain qualifications when assigned to shore or neutral duties.

**NOTE:** Specific requirements for incentive pay for parachute duty are found in DoD 7000.14-R, volume 7A, chapter 24.

## 7. Disqualification from Parachute Duty

- a. Commanding officers shall disqualify a member from parachute duty and remove their parachutist designator whenever
- (1) after a medical examination they are found to be permanently physically or psychologically disqualified for parachutist duty.

- (2) after a technical examination the individual lacks the minimum operational qualifications for parachutist duty as specified in CNO directives.
- (3) an individual is no longer a volunteer for parachutist duty to which they may be assigned by proper authority and a statement to this effect, signed by the member, is entered in their service record.
- b. A member who has been disqualified for static-line, HALO, or free-fall parachute duty for medical reasons is eligible for return to such duty upon determination that qualifications for such duty, according to the manual of the medical standards published by BUMED, have been satisfied.
- 8. <u>Commanding Officer's Responsibility</u>. Commanding officers shall limit a previously HALO or free-fall qualified member to static-line whenever, after a technical examination, a member is determined to lack the minimum operational qualification for HALO or free-fall parachute duty as specified in CNO directives, but remains qualified to perform static-line parachute duty.

## 9. Recording and Reporting Parachutists

- a. The assignment or removal of parachutist NEC codes shall be per NAVPERS 18068F.
- b. Service record and personnel accounting entries are as follows:
- (1) Whenever an enlisted member initially qualifies as a parachutist, an entry shall be made on NAVPERS 1070/613, Administrative Remarks of their service record indicating the date of qualification, type(s) of aircraft in which qualified, unit at which the training was received, and the authority granting the right to wear the Basic Parachute Insignia. The parachutist designator shall be affixed to their rate in the following manner: PR2(PJ). An entry to this effect shall be entered on the personnel diary as follows: "CH designator to (PJ)."
- (2) Whenever an enlisted member is disqualified for parachutist duty, an entry shall be made on NAVPERS 1070/613 of the service record showing the reason for disqualification. The parachutist (PJ) designator shall be canceled and a personnel diary entry to that effect shall be made as follows: "CH PJ designator to NONE."

- (3) Whenever an enlisted member initially qualifies as a free-fall parachutist, an entry shall be made on NAVPERS 1070/613 of the service record indicating the date of qualification, type(s) of aircraft in which qualified, and unit at which the training was received. The entry shall also indicate whether or not the member is HALO qualified. The free-fall parachutist designator shall be affixed to their rate in the following manner: PR2(FPJ). An entry to this effect shall be entered on the personnel diary as follows: "CH designator to (FPJ)."
- (4) Whenever an enlisted member is disqualified for HALO or free-fall parachutist duty, but continues to be qualified for static-line parachutist duty, an entry shall be made on NAVPERS 1070/613 of the service record indicating the reason for disqualification. The HALO or free-fall parachutist (FPJ) designator shall be changed to static-line parachutist (PJ) and a personnel diary entry to that effect shall be made as follows: "CH designator to (PJ)."
- (5) Whenever an enlisted member is disqualified for HALO or free-fall and static-line parachutist duty, an entry shall be made on NAVPERS 1070/613 of the service record indicating the reason for disqualification. The free-fall parachutist (FPJ) designator shall be canceled and a personnel diary entry to that effect shall be made as follows: "CH FPJ designator to NONE."
- c. Appropriate entry of qualification or disqualification shall be made on special duty abstracts of the health record at the time of original physical examination and annual reexaminations thereafter. Commanding officers shall be informed of the results of all physical examinations.
- 10. <u>Basic Parachutist Insignia</u>. The Basic Parachutist Insignia consists of a breast insignia as prescribed by NAVPERS 15665I and MCO P1020.34E. The right to wear the Basic Parachutist Insignia is authorized for those who meet the qualification requirements, whose right to wear such insignia has not been revoked, and who have not subsequently qualified for the Navy and Marine Corps Parachutist Insignia.
- 11. Navy and Marine Corps Parachutist Insignia. The Navy and Marine Corps Parachutist Insignia consists of a breast insignia as prescribed by NAVPERS 15665I and MCO P1020.34E. The right to wear the Navy and Marine Corps Parachutist Insignia is authorized for those members who have previously qualified for

the Basic Parachutist Insignia; have, under competent orders, completed a minimum of five additional static-line or P3 jumps with a Navy or Marine Corps organization whose mission includes static-line or P3 jumping with verification of such jumps for enlisted members included on NAVPERS 1070/613 of the service record; and whose right to wear such insignia has not been revoked.

12. <u>Revocation</u>. In general, the provisions for revocation of Naval Aviator Insignia shall apply as related to revocation of authority to wear the Basic Parachutist Insignia or the Navy and Marine Corps Parachutist Insignia.

#### 13. Commissioned Officers and Warrant Officers

- a. Qualifications and instructions for commissioned officers and warrant officers assigned parachute duty are as specified for enlisted personnel.
- b. Parachutist qualifications attained while in an enlisted status shall be carried over to the officer's service record.
- 14. <u>Other Services</u>. Parachutist qualification attained while in another service shall be carried over to the member's naval service record.

## 1. Policy

- a. The designation "Qualified in Submarines" represents an intensive personal effort to meet the high standards and special requirements of submarine duty. Only volunteers will be assigned to submarine training under normal circumstances. Non-volunteers will be assigned only when sufficient volunteers cannot be obtained.
- b. Based on the investment of training costs and long planning time, assignment to submarine duty is not elective after issuance of a transfer directive leading to duty in submarines.
- 2. <u>Eligibility Requirements</u>. The specified eligibility requirements for submarine duty may be found in NAVPERS 15909G, chapter 5.

## 3. Training Requirements

a. Basic Enlisted Submarine School (BESS), a school for the basic training of enlisted men for submarine duty at Naval Submarine Base, New London, Groton, CT, is a prerequisite for qualification in submarines for all enlisted ratings with the exception of nuclear trained personnel. Commanding officers (COs) of submarines receiving enlisted personnel from this

school shall not consider them as "qualified in submarines" nor their training complete. Before being designated as "qualified in submarines", each individual shall pass an oral and practical examination that demonstrates sufficient knowledge of ships' systems and operating procedures pertaining to the submarine on which serving.

- b. Personnel not previously "qualified in submarines" are not eligible to be so designated by the CO until they have served, for duty, at least 6 months in operational submarines, with the exception that service in new construction submarines may be counted from the commencement of builder's sea trials. Amplifying details for qualification are issued by the submarine force commanders.
- c. Personnel serving in a non-submarine source rating or not assigned to a submarine for duty, serving in a temporary duty status onboard a submarine, who complete requirements for qualification in submarines must request a waiver of eligibility standards from Navy Personnel Command (NAVPERSCOM) (PERS-403) via the CO of the ship on which qualified, info the submarine force commander. If the waiver is approved by NAVPERSCOM (PERS-403), submarine designator 7 (SG) will be assigned.
- 4. <u>Physical Requirements</u>. Before being assigned to a submarine, each enlisted member must meet the physical standards specified in NAVMED P-117.
- 5. <u>Submarine Qualification Designations</u>. Submarine qualification designations are defined as follows:

Desig 1 (SS)	Designated "qualified in submarines."
Desig 2 (SU)	Designated "in training for submarine qualifications."
Desig 5 (SQ)	Designated "qualified for submarines," but not planned
	for future assignment to submarine duty.
Desig 7 (SG)	Designated "qualified for submarines," but not in submarine source rating or NEC; not detailed by the submarine community.
Desig 8 (SP)	Designated "previously assigned in submarines;" assigned only to those personnel disqualified for submarine duty and serving in a submarine support billet; detailed by the submarine community, but not to be reassigned to submarine duty without prior approval of NAVPERSCOM (PERS-403).

- 6. <u>Designation 5 (SQ)</u>. Submarine designation Desig 5 (SQ) will be assigned by NAVPERSCOM (PERS-403) to enlisted personnel in submarine source ratings who are qualified in submarines but not expected to serve again in the submarine force. Personnel assigned Desig 5 (SQ) designator are entitled to wear the enlisted submarine breast insignia. Personnel assigned Desig 5 (SQ) designator shall have the following service /record NAVPERS 1070/613, Administrative Remarks entry made:
- "(Date): Assigned enlisted submarine designation Desig 5 (SQ). Member entitled to wear the enlisted submarine breast insignia.

Authority: (Cite the source document notifying of Desig 5 (SQ) designation)."

**NOTE:** Personnel assigned a Desig 5 (SQ) or Desig 7 (SG) who desire to return to submarine duty must formally request reinstatement in accordance with the procedures in NAVPERS 15909G, chapter 5.

## 7. Designation 7 (SG).

- a. Submarine designation Desig 7 (SG) will be assigned by NAVPERSCOM (PERS-403) for the following reasons:
- (1) Conversion to a non-submarine source rating or to an NEC detailed outside of the submarine community.
- (2) Non-submarine source rating who is approved to be designated "qualified in submarines."
- b. Personnel assigned Desig 7 (SG) designator shall have the following service record NAVPERS 1070/613 entry made:

"Date: Assigned enlisted submarine designation Desig 7 (SG). Member entitled to wear the enlisted submarine breast insignia.

Authority: (Cite the source document notifying of Desig 7 (SG) designation)."

#### 8. Designation 8 (SP)

a. Submarine designation Desig 8 (SP) may be assigned by NAVPERSCOM (PERS-403) to personnel disqualified from submarine duty. Each person who is disqualified is normally assigned to a

submarine support billet for a 2-year tour of duty if a valid billet exists.

- b. Submarine nuclear trained personnel who are physically disqualified from submarine duty will be assigned as a surface nuclear operator. No formal notification of Desig 8 (SP) assignment is made by NAVPERSCOM (PERS-403) and service record entries are not required.
- c. Assignment of Desig 8 (SP) is for NAVPERSCOM assignment and tracking purposes only, but will reflect on a command Enlisted Distribution Verification Report (EDVR). Further guidance on Desig 8 (SP) may be found in NAVPERS 15909G, chapter 5.

### 9. Submarine Qualification Insignias

- a. The submarine qualification insignia represents the completion of prescribed training and the successful qualification for submarine service. The insignia shows that the wearer has qualified for submarine duty but does not necessarily indicate that the wearer is currently serving in the submarine force.
- b. Enlisted members who have been "disqualified" from submarine duty shall normally by the same authority have their privilege to wear the submarine insignia revoked. A member who has been physically disqualified for submarine duty may continue to wear the submarine insignia. Other unique circumstances may convince the submarine disqualification authority to leave intact a former submariner's privilege to wear this insignia.

#### 10. Use of Submarine Designations

- a. Submarine designations "SS" or "SU" shall be placed in parenthesis immediately after the member's rate or rating abbreviation, e.g., MM2(SS), SA(SU). All service record pages and all correspondence pertaining to the member thereafter, until such time as the submarine designator may be revoked, shall include the appropriate designation. In addition, the outside of the enlisted service jacket shall be stamped "Qualified in Submarines (SS, SG, or SQ)" as appropriate.
- b. A member who has received a submarine designator and is subsequently transferred from duty in submarines shall retain the designator unless it has been removed or changed due to

disqualification. Additionally, entitlement to wear the enlisted submarine warfare insignia remains until such time that entitlement is revoked.

- c. When a member has been examined and is qualified for submarine duty, an entry shall be made in his service record as follows:
- "(Date): Qualified in submarines this date and assigned enlisted submarine designation Desig 1 (SS)."

### 11. Authority to Assign or Revoke Designators

- a. Only NAVPERSCOM (PERS-403) and submarine force commanders have authority to remove submarine designators. Submarine force commanders will act only on the cases of those personnel who are under their operational or administrative command. NAVPERSCOM (PERS-403) will act on all other cases.
- b. Authority for assignment of any enlisted submarine designator is NAVPERSCOM (PERS-403) with exception of the assignment of Desig 1 (SS) to those Desig 2 (SU) personnel who completed requirements for "qualification in submarines." The authority for this designator change is granted to the submarine force commanders.

# 12. Substance Abuse Policy

- a. The special safety and reliability aspects of operating submarines necessitates stringent substance abuse policies.
- b. For personnel with a history of pre-service drug abuse desiring entry into the Nuclear Field Program, waiver requests will be screened by CNO (N133D). Waivers may be granted only in cases of experimental use of marijuana.
- c. For personnel with a history of pre-service drug abuse (marijuana only) desiring initial submarine training other than the Nuclear Field Program, waiver requests will be screened by the appropriate command listed below.
- (1) Commander, Navy Recruiting Command, for personnel in that administrative chain of command as specifically outlined in COMNAVCRUITCOMINST 1130.8F. Admission of pre-service experimental use of marijuana while in the Delayed Entry Program (DEP) is not waiverable.

- (2) NAVPERSCOM (PERS-403) for personnel in all other commands. Waivers may be granted only in cases of experimental use of marijuana.
- d. Any time a waiver is granted for pre-service drug abuse, the following NAVPERS 1070/613 service record entry will be made:
- "(Date): A waiver of pre-service marijuana use for submarine duty has been granted by (cite authority). I understand any future drug abuse will result in permanent submarine disqualification and processing for separation from Naval Service.

MEMBER	WITNESS"

- e. Drug abuse waivers will not be granted for personnel with a history of in-service drug abuse desiring initial submarine training or for in-service drug abuse which occurs after commencement of initial submarine or Nuclear Field training.
- f. Personnel disqualified from submarine duty for drug abuse are not eligible for reinstatement at any time.
- g. Personnel disqualified for alcohol dependency may request reinstatement to submarine duty in accordance with OPNAVINST 5355.3B within 3 years of the disqualification date. After 3 years, reinstatement will not be considered.
- 13. Disqualification for Duty. A CO may, at any time, recommend to the appropriate disqualification authority, via the administrative chain of command, that any enlisted member serving under the CO's command be declared disqualified for submarine duty for any reason other than as a substitute for appropriate disciplinary action in the case of disciplinary offenses. Disqualification shall not be utilized in lieu of a recommendation for separation of a member from Naval Service when separation is warranted and appropriate; however, a person being administratively or punitively separated will be disqualified from submarines when such separation has been directed.

- 14. <u>Criteria for Removal of Submarine Designator</u>. There are two general categories of justification for removal of a submarine designator:
  - a. Physical disqualification, and
- b. All other reasons. This category may include, but is not limited to:
- (1) Inability or refusal to qualify or requalify in submarines.
  - (2) Substance abuse (alcohol or drugs).
- (3) Loss of or inability to acquire a required security clearance, NEC, or limited access authority.
- $\mbox{\ensuremath{(4)}}$  Removal from the Personnel Reliability Program (PRP).
  - (5) Conscientious objector status.
  - (6) Emotional instability.
- 15. NAVPERS 1070/613 Entry for Physical Disqualification. For personnel who are physically disqualified, the following NAVPERS 1070/613 entry shall be made:
- "(Date): Determined "physically not qualified" for submarine duty for reasons as stated in medical record. The enlisted submarine designator (SS)/(SU) is hereby removed. (Member's last name) is entitled to wear the submarine breast insignia (if applicable). (Member's last name) may reapply to NAVPERSCOM (PERS-403) for restoration of the (SS)/(SU) designator when he once again satisfies the physical requirements of the Manual of the Medical Department for submarine duty.

Authority: (Cite the source document approving disqualification.)"

16. NAVPERS 1070/613 Entry for Reasons Other than Physical. For personnel who are disqualified for reasons other than physical, the following service record NAVPERS 1070/613 entry shall be made:

"(Date): Disqualified for submarine duty by reason of (state reason). The enlisted submarine designator (SS)/(SU) is hereby removed. (Member's last name) is not eligible for return to submarine duty at any future date and is not entitled to wear the submarine breast insignia (if deemed appropriate by the submarine disqualification authority).

Authority: (Cite the source document approving disqualification)."

17. Reinstatement after Disqualification. Reinstatement to submarine duty after disqualification will be considered (with the exception of drug abuse and for alcohol dependency greater than 3 years from the disqualification date) in accordance with the procedures specified in NAVPERS 15909G, chapter 5.

- 1. **Policy**. Enlisted members may voluntarily obtain Enlisted Surface Warfare Specialist (ESWS) qualification while assigned to a surface ship or afloat staff.
- 2. Authority to Wear the Insignia. Achievement of qualification entitles the member to wear the ESWS insignia per reference (a), and to use the Surface Warfare designation. The Surface Warfare designation is an "SW" placed in parentheses immediately after the member's rate abbreviation, i.e., MM3(SW), BMCS(SW).
- 3. <u>Updating the Service Record</u>. When a member has been qualified as an Enlisted Surface Warfare Specialist, an entry shall be made in the member's service record NAVPERS 1070/613 (Rev. 7-06), Administrative Remarks as follows:

"(Date) Qualified as an Enlisted Surface Warfare Specialist (ESWS) this date and assigned the Enlisted Surface Warfare (SW) designator."

- 4. <u>Updating the Evaluation</u>. Once qualification has been approved, relevant comments should be made in the member's next evaluation.
- 5. <u>Disqualification</u>. An enlisted member previously qualified shall be disqualified by an appropriate qualifying officer if that member fails to continue to meet the requirements set forth in reference (b). Formal notification of disqualification shall

be recorded in the member's service record NAVPERS 1070/613 as follows:

"(Date) Failed to maintain qualification as an Enlisted Surface Warfare Specialist (ESWS) in that (include specific rationale for disqualification). Member has been informed that as of this date (he or she) is disqualified and is no longer authorized to wear the ESWS insignia or use the Enlisted Surface Warfare (SW) designator."

## 6. Wearing EAWS Insignia

- a. Achievement of qualification entitles the member to wear the Enlisted Aviation Warfare Specialist (EAWS) insignia prescribed in reference (a), and to use the Aviation Warfare designation. The Aviation Warfare designation is an "AW," placed in parentheses immediately after the member's rate abbreviation, i.e., AD3(AW), AMHC(AW).
- b. An EAWS qualified individual shall use "(AW)" after the rating title.

#### 7. Updating Service Records

a. When members have qualified as Aviation Warfare Specialist, an entry will be made in their service record as follows:

"(Date) Qualified as an Enlisted Aviation Warfare Specialist (EAWS) this date and assigned the EAWS (AW) designator."

- b. Once qualification has been approved, relevant comments should be made in the member's next evaluation.
- c. Members, once notified of their disqualification, shall have the specifics of this action entered in their service records with appropriate comments entered in the next periodic evaluation as follows:

"(Date) Failed to maintain qualification of an Enlisted Aviation Warfare Specialist (EAWS) by (include specific rationale for disqualification). - 1. <u>Policy</u>. Enlisted personnel can voluntarily obtain Enlisted Aviation Warfare Specialist (EAWS) qualification by meeting the eligibility requirements of and following the procedures prescribed in OPNAVINST 1414.2A.
- 2. **Qualifications**. General qualification standards for EAWS are as follows:
- a. Be professionally and militarily motivated as demonstrated by additional qualifications such as shipboard damage control, Personnel Qualification Standards (PQS), and Preventive Maintenance System (PMS) (where applicable).
- b. Be professionally qualified (i.e., specific PQS requirements to perform duties successfully completed, etc.) as required by their commanding officer (CO).
- c. Complete and qualify for all requirements as set forth in OPNAVINST 1414.2A.
- d. Be recommended by the chain of command and approved by the CO.

### 3. Disqualification

e. Personnel designated "Supervisory Status, Diving" or "Supervisory Status, Non-diving" will be limited to a maximum of 5 percent of an activity's onboard diving-related billet allowance, or less if the number may be detrimental to operational capability.

- f. Designation of personnel for "Supervisory Status, Diving" or "Supervisory Status, Non-diving" shall be made to coincide with required diving duty physical examination tenure. Extension of Supervisory Status must be requested to coincide with completion of diving duty physical examinations. Members designated "Supervisory Status, Diving/Non-diving" may retain that status, dependent upon the receiving command's requirements, if transferred during the normal tenure of diving duty physical examination.
- g. Members designated "Supervisory Status, Diving" are assignable to sea duty, eligible for diving pay according to their current NEC, and limited to performing supervisory, inspection, and requalification dives only, per 1220, Exhibit 5.
- h. Members designated "Supervisory Status, Non-diving" will not normally be assigned to sea duty, unless the number of divers in a full diving status at an activity is sufficient to conduct safe diving operations. Members assigned in a "Supervisory Status, Non-diving" shall not dive.
- i. Members not approved for "Supervisory Status" will not retain their NECs and will be made available for reassignment to billets not requiring a diving-related NEC.

All rating conversions should be coordinated with NAVPERSCOM (PERS-4011D7) and requested via NAVPERS 1306/7 (Rev. 1-03), Enlisted Personnel Action Request.

### 12. Minimum Performance Standards

- 1. <u>Background</u>. The Sea-Air-Land (SEAL) initial training pipeline qualifies personnel as Navy Enlisted Classification (NEC) 5320 (Basic Combat Swimmer) followed by NEC 5326 (Combat Swimmer). This may be followed by more specialized training for personnel ordered to SEAL Delivery Vehicle Teams (NEC 5323 pipeline), or SEAL Corpsmen (HM-8492 pipeline). Due to the nature of the training and the high initial pipeline attrition, the resultant obligated service is 51 months upon awarding of NEC 5326. This provides manning surety for the deployment cycles of this critical NEC Closed-Loop warfare community.
- 2. <u>NEC Requirements</u>. Graduates of Basic Underwater
  Demolition/SEAL (BUD/S) Training located at Naval Special Warfare
  Center (NSWC), Coronado, CA receive NEC 5320 (Basic Combat Swimmer).
  This is followed by Basic Airborne training at Fort Benning, GA and
  then SEAL Qualification Training (SQT) at NSWC. Graduates of SQT are
  awarded NEC 5326. Personnel with orders to a SEAL Delivery Vehicle

# 2. <u>Diver First Class Training</u>. Minimum requirements:

- a. Currently qualified as
- (1) **Diver Second Class** (NEC 5343), with at least 1 year of experience in an NEC 5343 billet;
- (2) Basic Underwater Construction (UCT) (NEC 5932), with at least 2 years experience in an Underwater Construction Team billet; or
- (3) Explosive Ordnance Disposal (EOD) Technician (NEC 5332-5337) who has completed requirements for Diver Second Class as a part of basic training, and has at least 2 years of experience in an NEC 5332-5337 billet.
  - b. Paygrade E-4 or above.
- c. Twenty-four months obligated service (OBLISERV) from class graduation date.

d. Completion of Personnel Qualification Standard (PQS) items as currently required. For a list of current PQS items required, the applicant for advanced training must contact the Training Coordinator, Naval Diving and Salvage Training Center (NAVDIVSALTRACEN), Panama City, FL.

### 3. Saturation Diver Training. Minimum requirements:

- a. Currently qualified as
  - (1) Diver First Class (NEC 5342),
- (2) Medical Deep Sea Diving Technician (HM-8493 or 8494/5342), or
- (3) Explosive Ordnance Disposal Technician (NEC 5332-5337), qualified as Diver First Class (NEC 5342) with at least 2 years of EOD experience in an NEC 5332-5337 billet.
  - b. Selected for paygrade E-5 or above.
  - c. No more than 10 years time in service.
  - d. Thirty years of age or less.
  - e. Satisfactory completion of dental examination.
- f. Twenty-four months OBLISERV from the class graduation date.

#### 4. Master Diver/Master Saturation Diver Course

- a. NAVDIVSALTRACEN conducts periodic Master Diver courses and is the only command authorized to qualify Master Divers. Commanding officers of diving activities may recommend **Diver**First Class (NEC 5342) or Saturation Diver (NEC 5311) personnel by endorsing their application for participation in the Master Diver course (see MILPERSMAN 1220, Exhibit 6), providing the candidate fulfills the following prerequisites. Recommendation should be based on leadership and supervisory abilities as well as technical expertise.
- (1) Served a minimum of 2 years from date of frocking or advancement to E-7.

- (2) Be a qualified
  - (a) Diver First Class (NEC 5342),
  - (b) Saturation Diver (NEC 5311), or
  - (c) Advanced UCT (NEC 5931).
- (3) Be qualified at the highest level of Diving Supervisor at present command.
- (4) No marks less than 3.0 on NAVPERS 1616/26, Evaluation Report and Counseling Record (E-1 E-6); or NAVPERS 1610/2, Fitness Report and Counseling Record (E-7 O-6). Must be marked **promotable for advancement**.
- (5) Have 36 months OBLISERV from class graduation date to fill a normal 36-month Master Diver tour.
- b. Successfully pass written Master Diver course pretest administered by NAVDIVSALTRACEN. (The validity of this test shall be for 1 year from the date of letter notification of test results. Failure to maintain eligibility by annual completion of the test will remove individuals from consideration for training.)
- c. The Master Diver candidate's CO will send the course request (MILPERSMAN 1220, Exhibit 6), to CO, NAVDIVSALTRACEN, via Navy Personnel Command (NAVPERSCOM) (PERS-401D), recommending candidate and enclosing the following:
- (1) Copy of service record NAVPERS 1070/613, Administrative Remarks entry(ies) indicating the individual's designation as a qualified Diving Supervisor.
- (2) Copies of NAVPERS 1616/26 or 1610/2 regular, transfer, and special evaluations/fitness reports for last 3 years.
- (3) Additional information as deemed appropriate for determination of the applicant's suitability for selection, including
- (a) local screening/training process letters of completion.

- (b) awards and letters of commendation/appreciation pertinent to determining performance, professionalism, potential, etc.
- (c) NAVPERS 1070/613, Administrative Remarks entry agreeing to satisfy 36-months OBLISERV from class graduation date.
- (d) special duty request (NAVPERS 1306/7, Enlisted Personnel Action Request) indicating a desire to participate in Master Diver course.

**NOTE:** Evaluations and other documents supporting an individual's request for training must be updated as events occur. Forward all updates to NAVPERSCOM (PERS-401D).

#### 1. Policies

- a. Members who voluntarily or involuntarily disenroll from initial training will
- (1) be made available for reassignment to their rating detailer and should contact their detailer as soon as possible; and
- (2) have a NAVPERS 1070/13, Administrative Remarks page entry made in their service record stating the reason for disenrollment and recommending suitability for the same or other Diver/EOD/SEAL/SWC, 6C/UCT training in the future.
- b. Members who voluntarily disenroll from initial training must serve a **minimum of 2 years** prior to reapplying for the same or other Diver/EOD/SEAL/SWCC/UCT training.

#### 2. Obligated Service (OBLISERV)

a. Members disenrolled where OBLISERV is required for instruction received, with approval of Navy Personnel Command (NAVPERSCOM) (PERS-814), may be permitted to execute a new

NAVPERS 1070/621, Agreement to Extend Enlistment, or NAVPERS 1070/622, Agreement to Recall or Extend Active Duty.

b. See MILPERSMAN 1160-080 for explanation of "instruction received" and follow the table in NAVPERS 15909F, Enlisted Transfer Manual (ENLTRANSMAN), article 7.03.

#### 3. New Extension Agreement

- a. Upon execution of an extension, the previously executed extension agreement for the course of instruction shall be canceled.
- b. For those members who accepted accelerated advancement, this OBLISERV will be in addition to the 1-year extension incurred for accelerated advancement.
- c. Obligated service for instruction cannot exceed the number of months of the original extension agreement. Obligated service requirements shall be executed from the date of disenrollment.
- d. Personnel attending Nuclear Field/Advanced Electronics Field/Advanced Training Field programs who are required to incur additional OBLISERV should refer to MILPERSMAN 1160-080.

Personal safety during hazardous operations is directly related to proficiency. Commanding officers are directed to afford every opportunity for maintaining individual qualification without lapse.
- 2. <u>Documentation of Requalification</u>. Documentation of diving operations is described in NAVSEA 0994-LP-001-9010.

## 1. Policy

- a. The term "diver," when used in context of requalification, refers to Diver/EOD/SEAL/UCT personnel.
- b. Standards for requalification are established in Exhibit 5.
- c. Diving qualification extends for a period of 6 months. When standards established in Exhibit 5 are conducted within the period of previous qualification, the member will be considered qualified for a 6-month period commencing at the lapse date of previous qualification.
- d. If requalification dives are conducted within 1 year of the date the previous qualification lapsed, the diver shall be considered qualified for a 6-month period extending from the date requalification is accomplished.

# 2. Requalification Period

- a. The 6-month requalification period is waived for diving personnel injured in the line of diving or related duties including involvement as experimental divers or test subjects for approved protocols. They shall be considered qualified with an indefinite lapse date and are entitled to diving pay. Requalification must be completed within 60 days after being returned to full diving duty.
- b. Personnel deemed Not Physically Qualified (NPQ) as a result of injuries sustained in the line of diving or related duties may apply for Supervisor Status/Non-diving. Waiver of Navy Enlisted Classification (NEC) and/or paygrade restrictions may be requested in conjunction and in support of such designation. See MILPERSMAN 1220, Exhibit 7.

- c. Personnel approved for Supervisor Status/Non-diving and assigned to a diving NEC billet shall have a qualification lapse date of "indefinite." Personnel not approved for designation will be made available for assignment to billets not requiring a diving-related NEC.
- 3. <u>Lapses Over 1 Year</u>. If diving qualification has lapsed for more than 1 year, but less than 3 years, the diver may perform the required requalification dives after successfully completing the physical screening test described in MILPERSMAN 1220-170, and commanding officer's approval. The diver shall be considered qualified for a 6-month period from the date requalification is accomplished.
- 4. <u>Lapses Over 3 Years</u>. When the member's diving qualification has lapsed for more than 3 years, the diver must successfully complete the physical screening test described in MILPERSMAN 1220-170 and successfully retake the following portions of the diving course that would bestow the diving qualification desired. All classroom
- a. portions relating to diving physics and/or general diving procedures,
  - b. portions relating to diving medicine,
- c. practical portions relating to recompression chamber operations, and
- d. practical portions relating to diving equipment in which the individual has not been previously trained (may be taken from courses other than that which bestows desired qualifications).

1. <u>Policy</u>. Commands with Diver/EOD/SEAL/UCT personnel assigned shall verify each member's Navy Enlisted Classification (NEC) by using Naval Military Personnel Enlisted Distribution and Verification Report (EDVR) and ensure NEC(s) are recorded on member's NAVPERS 1070/604, Enlisted Qualification History. Initial NECs are awarded by Naval Diving and Salvage Training Center, Naval School for Explosive Ordnance Disposal, or Naval Special Warfare Center upon completion of the respective "C" School.

**NOTE:** The member's NEC code will be retained regardless of qualification lapses unless NEC is otherwise removed due to voluntary request or disciplinary/administrative action.

2. <u>Designator "DV</u>." Enlisted designator "DV" shall be placed immediately after member's rating abbreviation in parenthesis and shall appear with the rating abbreviation on all service record pages and on all pertinent correspondence thereafter, as long as member remains a qualified diver. 3. <u>Designator "MDV</u>." The Master and Master Saturation Diver designator "MDV" shall be placed immediately after member's rating abbreviation in parenthesis and shall appear with the rating abbreviation on all service record pages and on all correspondence pertaining to them thereafter, unless revoked by Chief of Naval Operations (N132). This pertains to NECs **5341** and **5346**.

4. **Qualification**. When a member has been trained and qualified in a Diver/EOD/SEAL/UCT NEC, an entry shall be made on NAVPERS 1070/613, Administrative Remarks of member's service record as follows:

#### 1. Voluntary Removal

- a. Request Submission. Members assigned Navy Enlisted Classification (NEC) codes within Diver/EOD/SEAL/UCT programs may request removal of their NEC(s) by submitting, via their commanding officer (CO) to appropriate point of contact in Chief of Naval Operations (CNO) (N13),
- (1) NAVPERS 1306/7 (Rev. 1-03), Enlisted Personnel Action Request, and
- (2) EPMAC 1221/2, Navy Enlisted Classification (NEC) Change Request.
- b. Request Reasons and Statement. The request should include member's reasons for removing NEC(s) and the following statement:

"I understand removal of my assigned NEC(s) (fill in) will result in stoppage of special or hazardous duty pay and reassignment to a non-NEC billet, not necessarily at my present command."

c. Further Training/Assignment/Obligated Service (OBLISERV). Members who voluntarily request NEC(s) removal normally will not be approved for further voluntary training or assignment in other Diver/EOD/SEAL/UCT programs; however, member must serve remainder of original OBLISERV incurred as the result of initial training in a non-NEC billet, unless released at an earlier date by Chief of Naval Personnel (CHNAVPERS). Contact CNO (N13) for information on reverting to a component diving NEC.

- d. **Insignia**. Members who voluntarily request removal of their NEC(s) will **not** be authorized to wear applicable distinguishing insignia.
- 2. <u>Points of Contact (POC)</u>. POC for all Diver/EOD/SEAL/UCT designation questions is CNO (N13, specifically N131H/N132D7/N132D16).

# 3. <u>Involuntary Removal</u>

- a. **CO Determination**. COs of Diver/EOD/SEAL/UCT activities may recommend revocation of a member's NEC(s) by submitting EPMAC 1221/2 to appropriate POC in CNO (N13). This revocation shall not be used as a punitive measure, but based on CO's determination member is no longer suitable for assignment to billets requiring the NEC. EPMAC 1221/2 must substantiate that determination by providing sufficient background and reasonable justification for removal of member's NEC(s).
- b. **Insignia**. Members who have their NEC(s) involuntarily removed will **not** be authorized to wear applicable distinguishing insignia.
- c. First Class/Saturation Diver. CNO (N132D7) will remove NEC 5342/5311 of any First Class/Saturation Diver who has not been selected as a Master Diver (MDV) within 12 months of member's frocking to E-8, or attends and fails the MDV evaluation course. E-8 divers who attend and fail MDV evaluation may be held at the school with a positive recommendation until next available evaluation. After the second failure, or if a negative recommendation is received at the first evaluation, the diving NEC will be removed and members will be made available to their rating detailer.
- d. E-7 First Class/Saturation Diver. CNO (N132D7) will remove NEC 5342/5311 of any E-7 First Class/Saturation Diver who has not qualified as Diving Salvage Warfare Specialist (DSWS) up to and including watchstation 307 and 314 within 1 year of their frocking to E-7. Any waivers must be approved by CNO (N132D7).

#### e. E-9 UCT Divers

- (1) **NEC Removal**. It is the expressed intent that all E-9 UCT divers be qualified as a MDV or be selected for/serving as a chief warrant officer (CWO). As such,
- (a) CNO (N132D16) will remove NEC 5931 of any Advanced UCT Diver who is not an MDV, NEC 5341, at the time of their advancement/frocking (whichever occurs first) to E-9.
- (b) CNO (N132D16) will remove NEC 5931 of any Advanced UCT Diver who, within 12 months of member's frocking/advancement (whichever occurs first) to paygrade E-8, has not attended the MDV evaluation course.
- (c) CNO (N132D16) will remove NEC 5931 of any Advanced UCT Diver in paygrade E-8 who has failed the MDV evaluation course and asked not to return, or has failed the MDV evaluation course with a recommendation to return, but is not making satisfactory progress toward returning to the MDV evaluation course.
- (2) Waivers. Director, Naval Ocean Facilities Program Office (NAVFAC OFP), via the member's chain of command, must approve any waiver requests. Waivers will generally only be granted for, but not limited to, the following:
- (a) An E-8 Advance UCT diver, who at time of frocking/advancement (whichever occurs first) to E-8 is stationed at a non-diving command. This waiver will not eliminate the need to have the 5341 NEC at time of advancement or frocking to E-9. Further, it is expected that the E-8 will have 1 year after returning to a diving command to attend the first available MDV evaluation course.
- (b) An E-8 or E-9 Advanced UCT Diver has been selected for CWO.
- (c) Other waivers will be strictly on a case-by-case basis.
- (d) Advanced UCT Divers already advanced to paygrade E-9 at time of implementation of this change are waived for the 5341 requirement, and may retain their 5931 NEC, unless revoked for other criteria listed in the MILPERSMAN.

- (e) Advanced UCT divers already advanced to paygrade E-8 at time of implementation of this change are waived for 12 months from the time of implementation of this change for the requirement to attend MDV within 12 months of their advancement/frocking (whichever occurs first) to E-8.
- f. Recommendation Statements. Recommendations to revoke NEC(s) shall include one or more of the following statements:

"The member is considered suitable for assignment to rate or rating billets not requiring NEC (fill-in). The member is suitable/unsuitable for duty in Diver/EOD/SEAL/UCT commands."

"The member may reapply for reinstatement of NEC (fill-in) after completing at least 2 years assigned to a non-NEC billet."

"The member is considered unsuitable for reassignment and will be recommended for administrative discharge by separate action."

- 4. **Reasons for Revocation**. General circumstances which warrant revocation of an NEC include
  - a. permanent physical disqualification;
- b. sustained low or erratic professional performance in NEC-related skills such as
  - (1) declining physical capability,
  - (2) culpable negligence, or
  - (3) breeches in diving, ordnance, or parachuting safety;
- c. failure or unwillingness to perform duties required of NEC;
- d. possession/sale of prohibited drugs or other controlled substances;
  - e. alcohol abuse; and
- f. significant medical or emotional instability which results in removal of member from the command's Personnel Reliability Program (PRP) (see SECNAVINST 5510.35).

- a. If a counseling/rehabilitation program appears likely to succeed, the member will remain assigned to the command in a non-Navy Enlisted Classification (NEC) status and will have a program developed per OPNAVINST 5350.4C. Upon successful completion of the rehabilitation program, the CO may return the member to NEC duty.
- b. If future alcohol abuse is considered likely, or the member fails rehabilitation treatment, the CO may certify the member has no potential for further useful service and must initiate separation procedures.
- c. Personnel who voluntarily refer themselves for treatment in the absence of either an
- (1) alcohol-related violation of local, state, or Federal law; or the Uniform Code of Military Justice, or

- 2. <u>Separated Personnel</u>. Personnel separated from Navy may request reinstatement of their former NEC by letter to CNO (N13) under the following:
- a. If qualified and recommended for reenlistment in the NEC at time of separation, the member may send the request for reinstatement directly to  $({\rm CNO})$  N13.

- 1. Designation. Upon completion of
  - Special Warfare Combatant-Craft Crewman (SWCC) Basic Crewman Training (BCT), CIN K-060-0030, and
  - Crewmen Qualification Training (CQT), CIN K-060-0032,

enlisted personnel are designated as **SWCC** by Naval Enlisted Classification (NEC) code 5352 and awarded SWCC warfare device. Qualification designator SWCC will be placed next to their source rating designator (e.g., BM1(SWCC)). Reference (a) further describes this NEC.

2. **Qualification**. NEC 5352 SWCC will be awarded upon completion of a SWCC BCT and CQT course of instruction certified by Naval Education and Training Command (NETC), and an entry shall be recorded in member's Navy occupational/training and awards history.

3. <u>Assignment Closed to Women</u>. The SWCC program falls under the "Ground Combat Exclusion Policy" and is closed to women.

### 4. Certification of NEC 5352 and Training

- a. Commands with SWCC personnel assigned shall verify each member's NEC and report subject NEC by using the Enlisted Distribution and Verification Report (EDVR), and ensure the NEC is recorded on member's Navy occupational/training and awards history. Member's NEC will be retained as long as he is capable of performing duties as a SWCC member.
- b. Graduates of SWCC CQT are awarded NEC 5352, receive SWCC warfare device, and shall be assigned to a naval special warfare command.

#### 5. Revocation of NEC 5352

#### a. Voluntary Removal

- (1) Members assigned NEC 5352 may request removal of their NEC by submitting
  - NAVPERS 1306/7 (Rev. 1-03), Enlisted Personnel Action Request, and
  - EPMAC 1221/2, Navy Enlisted Classification (NEC) Change Request

via their COs to EPMAC, via NAVPERSCOM, Enlisted Community Management Branch (PERS-4011D7). The request should include member's reasons for removing his NEC and the following statement:

"I understand removal of my NEC 5352 will result in assignment to a non-5352 NEC billet, not necessarily at my present command."

(2) Members who volunteer for NEC removal, or "Drop on Request" (DOR) from SWCC BCT or CQT, must serve remainder of their obligated service (OBLISERV) incurred in a non-NEC billet, unless released earlier by Chief of Naval Personnel (CNHAVPERS).

(3) Members who voluntarily request removal of their NEC will not be authorized to wear SWCC warfare device unless a wavier is submitted to Enlisted Placement Management Center (EPMAC), via Naval Special Warfare Group FOUR (NAVSPECWARGRU FOUR) and NAVPERSCOM (PERS-4011D7).

#### b. Administrative Revocation

- (1) Commanding officers (COs) of special warfare combatant-craft commands may recommend revocation of a member's 5352 NEC by submitting EPMAC 1221/2 to EPMAC, via NAVPERSCOM (PERS-4011D7). This revocation shall not be used as a punitive measure. It shall be based on CO's determination that member is no longer suitable for assignment to NEC 5352 billets, and must substantiate this assessment with sufficient background and reasonable justification.
- (2) Members who have their NEC(s) involuntarily removed will not be authorized to wear SWCC warfare device.
  - (3) Circumstances warranting NEC removal include
- (a) CO's lack of confidence in member's ability to conduct and perform NSW operations. Examples are:
- (b) breaches in operational, ordnance, or personnel safety, deficiency in leadership, lack of integrity, and reliability.
- (c) permanent physical disqualification or inability to maintain physical standards.
- (d) or the use of, possession of, or sale of, drugs or controlled substances.
- (e) significant medical, emotional, or moral instability that removes CO's faith and confidence in member's ability to successfully conduct special warfare missions.
- (f) members not assigned to a Naval Special Warfare 5352 billet in excess of 36 months.

- (4) Recommendations to revoke NEC shall include one of the following statements:
- (a) "The member is considered unsuitable for assignment to Naval Special Warfare (NSW) and should never be reassigned to NSW in the future; however, member is suitable for assignment to rate or rating billets not requiring NEC 5352."
- (b) "The member may apply for reinstatement of NEC 5352 after completing 2 years in a non-NEC billet."
- (c) "The member is considered unsuitable for reassignment and will be recommended for administrative discharge by separate action."

#### 6. Reinstatement of NEC 5352

- a. Members on active duty whose NEC was previously removed may request reinstatement by NAVPERS 1306/7 to NAVPERCOM (PERS-4011D7) via Commander, NAVSPECWARGRU FOUR.
- b. Personnel separated from Navy may request reinstatement of their former NEC by letter directly to NAVPERSCOM (PERS-4011D7) if qualified and recommended by Commander, NAVSPECWARGRU FOUR for reenlistment in the NEC at separation date. If not qualified or recommended at separation date, former members must meet eligibility requirements and reapply to the program.
- 7. Application Procedures. Active duty volunteers may apply for initial training and assessment. Because this program supports naval special warfare missions, it is essential applicants understand the nature of the training assignment prior to volunteering. Volunteers who satisfy entry requirements must be screened by a qualified screening official prior to submitting their applications as indicated below.
- 8. <u>Entry Requirements</u>. Male volunteers for initial training as SWCC must satisfy entry requirements listed below prior to assignment to training. Except where specified "no waiver," NAVPERSCOM (PERS-4011D7) may waive one or more entry requirements if applicant is considered otherwise qualified.
- a. Be 30 years of age, or less, as of date of application receipt at NAVPERSCOM.

- b. Be paygrade E-1 through E-5.
- c. Possess a minimum Armed Services Vocational Aptitude Battery (ASVAB) score of AR+WK=104, MC=50. (For ASVAB 5, 6, and 7, use WK score. For 8, 9, and 10, use VE score.)
- d. Have normal color perception, vision correctable to 20/25 and meet medical standards as specified in reference (b).
  - e. Possess 36 months OBLISERV as of class graduation date.
- f. Meet minimum performance standards. All enlisted personnel evaluation trait marks 3.0 or better.
- g. Pass physical screening test as outlined in MILPERSMAN 1220-340, Exhibit 1.
- h. Have a clear disciplinary record for previous 12 months (no nonjudicial punishment (NJP)/courts-martial or serious civil court convictions).
- i. Be eligible for SECRET clearance based on a National Agency Check.
- j. Be screened by a qualified screening official, per "Screening Procedures" below.
- k. Be recommended for initial training by member's current CO.
- 9. <u>Screening Procedures</u>. Potential applicants will request a screening interview through their current CO.
- a. **Interview**. The interview is conducted to ensure applicant understands the nature of initial training and assignment, to explain the program's entry requirements, and determine applicant's motivation and suitability for the program. The screening will be conducted by a qualified E-7 or above, 5352 or 5326, in the following manner:
- (1) Discuss the nature of SWCC training, duty assignment, operational employment, tour length, etc.

- (2) Determine applicant's reason for volunteering and assess his motivation to complete initial training.
- (3) Review entry requirements specified in this article with applicant to determine which requirements are met and which require waivers.
- (4) Sign NAVPERS 1070/613 (Rev. 10-81), Administrative Remarks stating:

"I have viewed the SWCC Recruiting Video and understand that SWCC Basic Crewman Training (BCT) and Crewman Qualification Training (CQT) are physically demanding, high risk courses of instruction."

- b. **Physical Screening Test**. The physical screening test is required to determine applicant's physical ability to undergo initial training. The test must be administered exactly as indicated. No waiver will be granted for failure to successfully complete the physical screening test. Applicants will be required to meet standards in reference (c).
- 10. Report of Applicant Screening. Upon satisfactory completion of the screening procedure, applicant will receive a letter from the screening official stating results of the screening. This letter will become an enclosure to member's application. The following format will be used by screening activities to report results of applicant screening (use proper letter format):

#### 11. Training

- a. Course description, prerequisites, class convening dates, and designated training activities for
  - Special Warfare Combatant-Craft Crewman (SWCC)
    Basic Crewman Training (BCT), CIN K-060-0030, and
  - Crewmen Qualification Training (CQT), CIN K-060-0032 course of instruction,

are contained in reference (d). This publication should be consulted for current course information, both at application time and prior to member's detachment from present command.

- b. Members who voluntarily drop, or are involuntarily disenrolled from initial training, will have a NAVPERS 1070/613 statement outlining reasons for disenrollment and recommendations for suitability for the same or other special warfare training programs in the future.
- c. Members who voluntarily disenroll from training must serve a minimum 2 years prior to reapplying for any special warfare programs.

# Assault Boat Coxswain Qualifications

- 1. **Eligibility**. All enlisted members, except Hospital Corpsman and Dental Technicians, are eligible for qualification as assault boat coxswain.
- 2. <u>How to Qualify</u>. Each command is responsible for developing an examination and observing practical factors from the following criteria: (NOTE: Landing craft is defined as a craft which is specifically designed for beaching, unloading or loading on the beach, and retracting.)

#### a. **Examination**

(1)	Nomenclature. Use of hull fittings/equipment. Capacity of cargo/personnel maneuvering and
	special hull characteristics. Fuel capacity and fuel endurance of landing craft.
(2)	Procedures for starting engine, normal/maximum safe motor temperatures. Stopping/securing engine. Operation of bilge pumps/sand traps.
(3)	Boat signals, identification flags and insignia. Boat identification paddles in connection with ship-to-shore movement. Control vessels signals/signal procedures. Debarkation communications/visual designations. Voice radio procedures.
(4)	Standard formations: Distance/speeds employed in assembly/rendezvous area/assault waves.  Procedures for boat group commanders and control vessels.
(5)	Special maneuvering rule and precautions observed during landing and retraction through surf. Procedures for rigging boat for salvage and maneuvering to avoid fouling of propellers with tow lines.
(6)	Identify beach markers and buoys.
(7)	Procedures for transferring personnel/equipment to LVT's direct or via transfer barges; procedures at transfer line.

#### b. Practical Demonstration

(1)	Perform coxswain duties, supervise boat crew in
	hoisting/lowering operation, rig/secure all gear
	in landing craft, follow procedure in handling
	all types of cargo.
(2)	Handle a landing craft in protected waters,
	coming alongside, casting off from a vessel or
	pier. Observe all safety measures applicable to
	operation of the boat/equipment.
(3)	Use and identify boat signals, boat
	identification flags, insignia in connection
	with ship-to-shore movement.
(4)	Maintain assigned station in all phases of ship-
	to-shore movement, employing knowledge of
	standard formations, distance/speeds in
	assembly/rendezvous area. Steer by
	compass/observe rules of the road.
(5)	Beach boat through moderate surf and retract,
	singly and in assault wave formation using
	proper rudder and engine procedure.
(6)	Rig, use, secure anti-broaching lines.
	Demonstrate how to rig a broached landing craft
	for salvage. Proper use of engines to avoid
	fouling tow lines in assisting salvage boat.
(7)	Render first aid, rig stretcher slings, and use
	other methods of hoisting casualties.

#### 3. Documentation

- a. Members who demonstrate proficiency in practical factors and pass the written examination will be qualified as an assault boat coxswain and assigned the proper Navy Enlisted Classification (NEC) code.
- b. Commands are to document the qualification on the NAVPERS 1070/604 (Rev. 7-91), Enlisted Qualification History of the service record and submit NAVPERS 1221/1 (Rev. 6-92), Navy Enlisted Classification Code Change Recommendation to the Enlisted Personnel Management Center (EPMAC) (Code 52) to record/remove the NEC.

#### 4. Requalification

a. Qualification shall continue in effect for 1 year from the date on which qualified. To avoid lapse of qualification upon expiration of 1 year, requalification may be accomplished at any time. Such requalification will supersede the previous

qualifications and shall be effective for 1 year from date of accomplishment.

b. Requirements for requalification shall be the same as for the original qualification.

# 1. Requirements

- a. All enlisted members are encouraged to qualify as damage control scene leaders. To qualify members must complete the Personnel Qualification Standard (Damage Control Emergency Parties Qualification Standard) NAVEDTRA 43119-I.
- b. Qualification of damage control scene leader shall be entered on NAVPERS 1070/604 (Rev. 7-91), Enlisted Qualifications History of the member's service record.

#### 2. Continuation

- a. The command is responsible for maintaining continued qualification. A member not assigned to or performing duties as a damage control scene leader for a period of 1 year, must be requalified before assignment as a scene leader.
- b. Requalification is subject to the same requirements as the original qualification.

- 1. **Policy**. Enlisted members E-5 and above shall obtain the Enlisted Expeditionary Warfare (EXW) Specialist qualification while assigned to a qualifying unit as outlined per reference (a). Enlisted members E-4 and below may voluntarily obtain EXW qualification while assigned to a qualifying unit and who meet eligibility requirements.
- 2. Authority to Wear the Insignia. Achievement of qualification entitles the member to wear the EXW insignia per reference (b), and to use the EXW designation. The Expeditionary Warfare designation is an "EXW" placed in parentheses immediately after the member's rate abbreviation, i.e., MM3(EXW), BMCS(EXW).
- 3. <u>Updating the Service Record</u>. When a member has been qualified as an EXW Specialist, an entry shall be made in the member's service record NAVPERS 1070/613 (Rev. 7-06), Administrative Remarks as follows:

"(Date) Qualified as an Enlisted Expeditionary Warfare (EXW) Specialist this date and assigned the (EXW) designator."

- 4. <u>Updating the Evaluation</u>. Once qualification has been approved, relevant comments should be made in the member's next evaluation.
- 5. <u>Disqualification</u>. An enlisted member previously qualified shall be disqualified by an appropriate qualifying officer if that member fails to continue to meet the requirements set forth

in reference (a). Formal notification of disqualification shall be recorded in the member's service record NAVPERS 1070/613 as follows:

"(Date) Failed to maintain qualification of an Enlisted Expeditionary Warfare (EXW) Specialist by (include specific rationale for disqualification). Member has been informed that, as of this date, he/she is disqualified and is no longer authorized to wear the EXW insignia or use the (EXW) designator as part of his/her rating."

Members, once notified of their disqualification, shall have the appropriate comments entered in the next periodic evaluation.

6. <u>Re-qualification</u>. Re-qualification shall be accomplished per policy guidance issued in reference (a).
