- **Finland acquires 10 Mt CO<sub>2</sub>e via Kyoto Mechanisms (2008-2012)**
  - Specified in Energy and Climate Strategy (2005)
- **Kyoto Mechanisms in the ministries**
  - Ministry of Trade and Industry: Coordination
  - Ministry for Foreign Affairs: CDM
  - Ministry of the Environment: JI and IET
- **Finnder buys carbon credits for Finland from JI and CDM projects**
  - Implemented by Finnish Environment Institute (SYKE)
  - Successor to Finnish CDM/JI Pilot Programme (2000-2006)

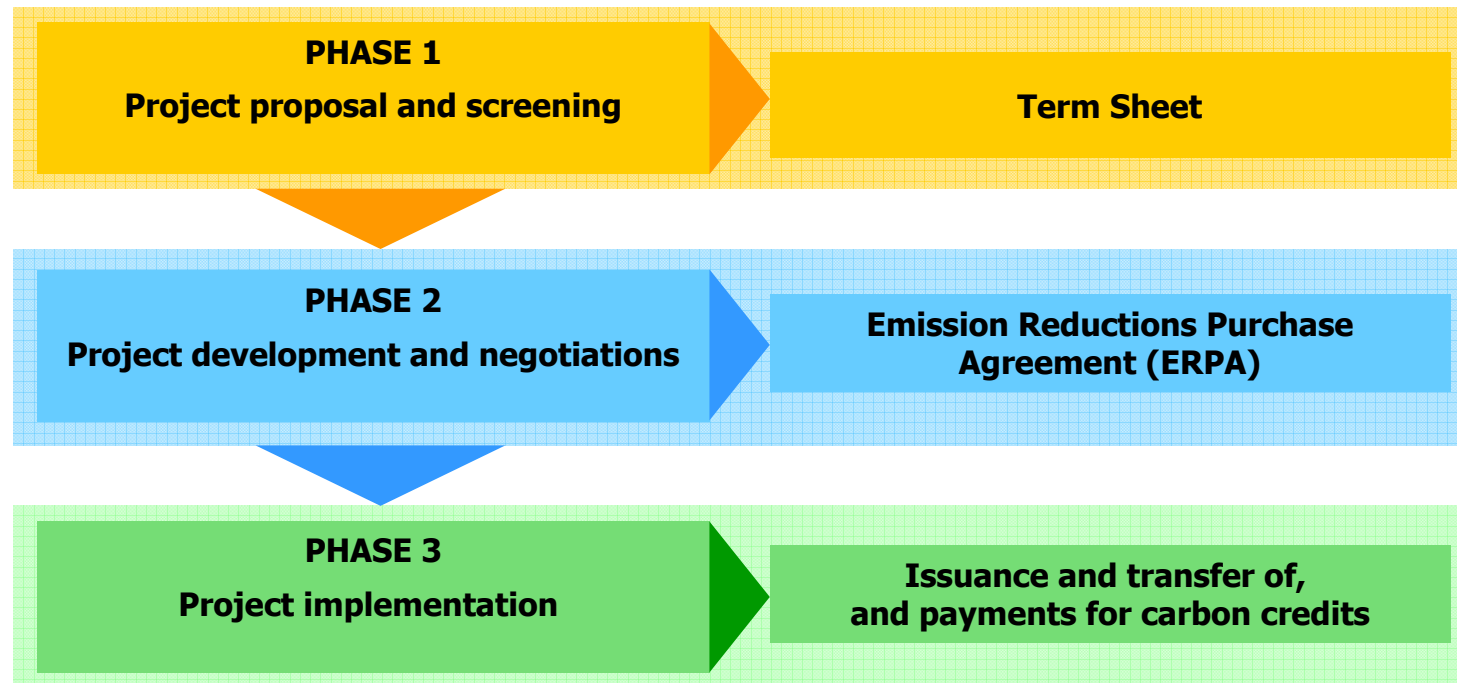


- **Key selection criteria: PRICE and RISK**
