NATIONAL AFRICAN AMERICAN HISTORY MONTH, 2007

By The President of The United States of America

A Proclamation

African Americans have been an integral part of America for generations, and our Nation is stronger because of their contributions. During National African American History Month, we honor the achievements of African Americans and recognize our continued responsibility to strive for equality for all our citizens.

With grace and determination, African-American men and women have shaped our Nation and influenced American life. Frederick Douglass, W.E.B. DuBois, Rosa Parks, and Martin Luther King, Jr., advanced the cause of civil rights for all Americans and helped change the course of American history. Educators Booker T. Washington and Carter G. Woodson helped break down racial barriers in education to provide opportunity for all people. Americans have benefited from the achievements of scientists like George Washington Carver. Artists such as Pearl Bailey, Ella Fitzgerald, and Louis Armstrong inspired Americans and created some of the most celebrated music this Nation has ever produced.

The theme of this year's National African American History Month, "From Slavery to Freedom: Africans in the Americas," recalls African Americans' long journey to justice and commemorates the courage and persistence of the heroes who called on our Nation to live up to its founding promise. A century after African-American soldiers fought for their freedom on the battlefields of the Civil War, African Americans struggled peacefully for their rights in the streets of Birmingham, Alabama, and on the Mall in Washington, D.C. Courageous civil rights leaders answered hate and discrimination with love and dignity, toppled segregation laws, and worked to make America a more just and hopeful Nation.

All Americans can be proud of the progress we have made, yet the work for a more perfect union is not done. As we celebrate National African American History Month, we reaffirm our commitment to build a society where every individual has the opportunity to achieve the promise of this great land.

NOW, THEREFORE, I, GEORGE W. BUSH, President of the United States of America, by virtue of the authority vested in me by the Constitution and laws of the United States, do hereby proclaim February 2007 as National African American History Month. I call upon public officials, educators, and all the people of the United States to observe this month with appropriate programs and activities that honor the significant contributions African Americans have made to our Nation.

IN WITNESS WHEREOF, I have hereunto set my hand this twenty-sixth day of January, in the year of our Lord two thousand seven, and of the Independence of the United States of America the two hundred and thirty-first.

Greetings Sister Links,

n behalf of the Membership Committee, the ambassadors of friendship let me extend heartfelt appreciation for your service and commitment to The Links, Incorporated. The work that we do on behalf of our communities makes a tremendous impact on the thousands of constituents and organizations we serve and support.

By now you know, the delegates to the 35th National Assembly overwhelmingly approved and for the second time affirmed the 48 hour service requirement for membership in our organization. This affirmation highlights the dedication that our members have for The Links, Incorporated and the confident we have in the difference we make on behalf of others.

Since the National Assembly and per the directive of our National President, Link Gwendolyn B. Lee, Ph.D., the Area Directors and a small team of Chapter Presidents have worked with me to develop a "user friendly" approach for chapter implementation of the 48 hour service requirement. A detailed report of the task force's recommendations has been prepared for the next Chapter mailing, but the following is a brief outline of the report approved by the Executive Council at its November 2006 meeting.

48 Hour Implementation Task Force Recommendations

Major Themes

- · The Membership Chair is responsible for uniform administrationand accurate record keeping of all service hours.
- · The process should be kept simple.
- · All service opportunities (projects) must be pre-approved by the chapter in order to be credited.

Breadth and Scope of Volunteer Involvement

· Member strengths and interests should be aligned with activities that can support service and program delivery. Volunteer opportunities should be flexible and creative to best utilize the strengths and abilities of members. Suggestions: develop PR assignments, chapter newsletters, ethics review, etc.

Data Collection

· Use existing tools developed and shared at the Area level or develop a chapter tool that facilitates data collection. Remember to keep it simple.

Community Partnerships

· Community organizations must recognize and give credit to The Links, Incorporated for collaborative efforts. Before program or project collaborations begin, develop a Memorandum of Understanding (MOU) and have a clear delineation of the role, recognition and expectations of the The Links, Incorporated.

Links in Demanding Professions

· As they are willing, leverage the access and connections of members with limited time, but considerable influence. Suggestions: legislative briefings, fund development, corporate relations, community partnerships, etc.

Members with Physical and Personal Limitations

· Utilize members with limited personal time or physical mobility as ambassadors of friendship. Suggestions: Establish a card and acknowledgments committee, phone trees, scheduling for events, mailings, etc.

Central Area HBCU Scholarship Challenge

The "Heart of Linkdom" has always been committed to taking care of its own. Thus, we are pleased to announce the creation of the Central Area HBCU Fund to assist historically black colleges located in our **chapter service communities**. This Area has an endowed scholarship of \$100,000 in support of scholars at **Fisk University**. During the 2005 Area Conference, we contributed \$10,000 each to the two HBCU's located in Ohio: **Central State** and **Wilberforce Universities**. We have also donated \$5,000 to **Tennessee State University**, with another \$5,000 pending.

There are ten other undergraduate HBCU's located in our chapter service communities, namely...

Our goal is to be equitable with our scholarship efforts. We hope that chapters and individual Link members will embrace this effort and consider a commitment to **The Central Area HBCU Fund**. If, for example, every active member participated at a \$50 level, we could easily surpass a minimum goal of \$10,000 per school. **In addition, the Area is committed to contributing** \$75,000 to these collective efforts.

Sisters, we can have a profound impact upon the lives of countless scholars who will be the professionals of tomorrow. Let us continue to reach out to our own and give our young people that necessary hand up that each of us has accepted in our own individual life journey. We will announce our success at the Area Conference.

National Headquarters Highlights of The Links, Incorporated

Website

The Members Only section of our website was launched on February 1, 2007. Note that there is a special section for Chapter Presidents containing various forms, Rituals, Manuals, and other important items. We will be posting documents to our website on an ongoing basis. Our next project is to establish a separate link on our site for each Chapter that will contain documents and forms that are Chapter specific (i.e., future Master Data Forms). We are also in the process of establishing email boxes for each Chapter that will enable Chapter Presidents to obtain important information on a timely basis.

In the coming months, we will be announcing additional capabilities such as an on-line directory, and the ability to update your contact information from your desktop computer.

We will, of course, send Chapter Presidents an email as each of these items are launched on our website.

Membership

We will begin moving our transferees into Chapters on May 1st. The Membership Department will contact Affiliate members to advise them of Chapters in their locale that have space available.

To date, we have approximately 700 names that have been submitted for membership. We are working closely with the Area Directors to return New Member Verification forms to the Chapter Presidents. Remember, Chapters may not send letters of invitation until the verification form has been signed by the Area Director and National Headquarters, and returned to the Chapter President.

We are also in the process of securing a new membership card for every Link. This newly designed card will contain a disaster relief telephone number that will enable us to stay linked together in the event of a national disaster.

Certification Letters and One-in-Five Compliance

The Membership Department continues to send certification letters to all Links who complied with the attendance requirements for the 2005 Area Conferences and the 2006 National Assembly. If you have any questions regarding your certification, contact Headquarters at membership@linksinc.org.

Please be reminded that the 2007 Area Conference is the last opportunity to satisfy the one-in-five requirement. In order to satisfy the requirement, you must attend the Area Conference in your Area, register for the Conference, and attend the requisite number of plenary sessions and workshops.


The Arts is Stirring It Up

It was a pleasure to serve as moderator of the discussion. An impassioned and sometimes intense discussion followed as the leaders examined the issues as they related to the various factions implementing the NCLB, specifically funding, its impact on the drop out crisis and the increasing rates of incarceration for young people of color generally and young men of color specifically. The role of educators, business, and policymakers was examined as they considered the importance of this legislation and its impact on implementers. Participants discussed possible modifications to NCLB to more effectively achieve its goals and objectives in minority communities. A brief Q and A period followed with insightful questions from the audience.

Participants in the roundtable forum included Dr. Gwendolyn B. Lee, National President of The Links, Inc.; the Special Advisor to the U.S. Secretary of Education, Dr. Henry L. In Diversity Push, Top Universities Enrolling More Black Immigrants Critics Say Effort Favors Elite Foreigners, Leaves Out Americans

The nation's most elite colleges and universities are bolstering their black student populations by enrolling large numbers of immigrants from Africa, the West Indies and Latin America, according to a study published recently in the American Journal of Education.

Immigrants, who make up 13 percent of the nation's college-age black population, account for more than a quarter of black students at Ivy League and other selective universities, according to the study, produced by Princeton University and the University of Pennsylvania.

The large representation of black immigrants developed as schools' focus shifted from restitution for decades of excluding black Americans from campuses to embracing wider diversity, the study's authors said. The more elite the school, the more black immigrants are enrolled.

"A lot of these institutions have been promoting the increase in their black populations, but clearly this increase reflects a growth in their black immigrant populations," said Camille Z. Charles, an associate professor of sociology at the University of Pennsylvania who co-authored the study.

Black American scholars such as Henry Louis Gates and Lani Guinier, two Harvard University professors, have said that white educators are skirting long-held missions to resolve historic wrongs against native black Americans by enrolling immigrants who look like them.

In an interview, Guinier said that the chasm has less to do with immigrants and more to do with admissions officers who rely on tests that wealthier students, including black immigrants, can afford to prepare for.

"In part, it has to do with coming from a country, especially those educated in Caribbean and African countries, where blacks were in the majority and did not experience the stigma that black children did in the United States," Guinier said. "The fathers of these students tend to be much better educated. This is not just true of immigrants from Africa and the Caribbean, this is true across the board. We have an admissions system that prefers wealth, that rewards wealth and calls it merit."

Officials at several top universities, including Harvard, the University of North Carolina and Princeton, did not respond to calls or e-mail messages seeking comment on the study.

The University of Pennsylvania's dean of admissions, Lee Stetson, said that although the university takes note of students' backgrounds, "we do not focus specifically on whether students are Caribbean American, African American or African. We do not involve ourselves with exact roots.

"They bring diversity to the campus," Stetson said. "We try to find students from all walks of life, including African American students who have their roots in the southeastern United States."

The study relied on data from the National Longitudinal Survey of Freshmen, which included 1,028 black students, 281 of whom were immigrants. Black immigrants were defined as students who emigrated directly from Africa or the Caribbean, including countries such as Guyana that are on the South American continent and nations in the black diaspora or their American-born sons and daughters.

Stanford, Duke, Columbia, Vanderbilt and Harvard universities had the highest percentages of black students in their fall 2006 freshman classes, according to the Journal of Blacks in Higher Education. The percentage of black freshmen at elite colleges and universities ranged from a high of 12.3 percent at the University of North Carolina at Chapel Hill to 1.4 percent at the California Institute of Technology.

The study's authors considered several possibilities to explain the large number of immigrant students. They noted that black immigrants tend to come from the uppermost classes of their native land and tend to be highly motivated to succeed. The authors also considered that black immigrants posted higher grades and test scores, and that admissions officers were impressed by their work ethic.

But the final theory, based on previous research by Nancy Foner and George M. Fredrickson, who co-wrote a 2004 study on immigration, ethnicity and race, was the most provocative.

"To white observers," they wrote, "black immigrants seem more polite, less hostile, more solicitous and 'easier to get along with.' Native blacks are perceived in precisely the opposite fashion."

On campus, native black Americans and immigrant students both embrace and wrestle with diversity. At the University of Georgia, native black American and African students met in the student union two years ago to discuss an emotional topic, "Where's the Africa in African American?" They were quiet at first, senior Oluwatoyin Mayaki recalled, but with some coaxing, the black American students spoke up.

"They were saying, 'I don't think it's fair that you get affirmative action like we do,' "said Mayaki, the American daughter of Nigerian parents. "'This country was built on my parents' backs, not on your parents' backs. You didn't go through the years of slavery, discrimination or the civil rights movement.'

Mayaki counts many black Americans as friends, but that was not always so. As a child, she was steered away from black Americans by her protective Yoruban mother, who emigrated from Nigeria in the 1980s.

"My mom wouldn't let me go next door for a sleepover with African American kids, but I could go five houses down to Asian houses. I kind of got along better with foreigners," she said. "You don't go to parties. You don't go to movies. You just study, stay at home, do your chores. My Indian and Asian friends got it. All my other friends, they never got it."

At Rutgers University in New Jersey, Ghanaian immigrant Abena Busia said that drawing distinctions between black Americans and Africans is divisive and dangerous.

"What disturbs me... is it immediately casts African Americans as unmotivated," she said. "It's like a good Negro, bad Negro syndrome and I reject it. It creates more problems than necessary. It's also a myth."

Busia grew up in Ghana's upper classes, was educated at Oxford University and received additional education in the United States. Regardless, she said, U.S. immigration laws were stacked against her and other ethnic immigrants.

"Look at me. Even with all my degrees, when I adopted my daughter in Ghana it took more than seven years to get her here," she said. "They lost my papers twice. I had my fingerprints taken three or four times. You have to do this and... that. This country... has always been an inhospitable place for Africans to enter."
