

Transgender Marriage Is Coming

Once same-sex marriage is formally legalized, transgender activists will demand the "right" to marry. It is already happening.

The faces of Georgi Somers and Sandy Gast (shown to the right) are a grim picture of our nation's future if homosexual marriage is legalized in the United States.

Somers and Gast are both male-tofemale transsexuals who are still in "transition." Both have male and female sexual characteristics and believe they should have the "right" to marry each other.

Somers and Gast are suffering from a serious mental problem called a Gender Identity Disorder (GID). However, instead of a counselor helping each of them to overcome their bizarre feelings of being members of the opposite sex, these men found a surgeon who was willing to mutilate their bodies so they can become fake women.

In February, 2004, Sandy Gast filled out a marriage license form in

Leavenworth (Kansas) County and claimed that he was a woman. He had a driver's license, social security card, and an amended birth certificate reflecting his sex change.

Somers' daughter Crytal Call, however, contacted Leavenworth authorities and told them that Somers was actually a man, not a woman. Thus, the marriage form was illegal and Gast was arrested for falsely swearing on the marriage license application.

Leavenworth County prosecuting attorney Frank Kohl told reporters that "The change of a driver's license, the change of name—even though they were done through legal channels, doesn't change gender." Kohl notes: "The

gender you're born with is the gender you remain for life."

Attorney Kohl cited a 2002 Kansas Supreme Court ruling involving a transsexual who had married a wealthy millionaire named Marshall Gardiner in 1998. When Gardiner died less than a year later, his transsexual "spouse" J'Noel, tried to collect his inheritance as his "wife."

When the case reached the Kansas Supreme Court, it ruled that J'Noel could not collect Gardiner's inheritance because he was a man—not a woman under Kansas state law.

The court stated: "The words 'sex,' 'marriage,' 'male,' and 'female' in everyday understanding do not encompass transsexuals. A post-operative male-to-female transsexual does not fit the common definition of a female."

The court continued: "...the validity of J'Noel's marriage to Marshall is a question of public policy to be addressed by the legislature and not by this court."

Gast and his she/male partner may very well use the ACLU to challenge Kansas state law defining the biological reality of males and females. Sandy Gast told <u>The Leavenworth Times</u> that he had talked to a transsexual with contacts inside the ACLU and that he and Somers were being denied "equal rights" to marry. TVC's special report, "A <u>Gender Identity Disorder Goes Mainstream"</u> provides more background on the political agenda of the transgender movement. Once homosexual marriage is legalized, she/males like Gast and Somers will line up to "marry" each other.
