1. Introduction

Coalition to Uproot Ragging from Education (CURE) started off as a web-based discussion group focussing solely on ragging and related issues in July 2001. The aim was to collect the available information and present it to people in a manner they can relate to and understand. We wanted to evoke public opinion against ragging.

But what came as a rude shock to us was denial, denial not only to the existence of ragging, but denial of any suffering/ills of ragging. We thus identified the most difficult problem attached with the social evil of ragging, *denial*. Over the years, we have counselled anxious freshers who are about to join college about the ways and means to tackle ragging in college. We have received hate mails from people who believe ragging is good for students. We have been confronted by alumni of colleges whom we have exposed during our research investigations. We have met college authorities and explained to them our stand and beliefs.

Very few people were ready to accept the reality and all of them wanted to offer explanations for ragging. However, we held our ground, our focus and direction. This close interaction with all stakeholders in this phenomena has strengthened our belief and mission. CURE has grown both in terms of numbers as well as in our understanding of the phenomenon of ragging.

Today, CURE is at the forefront of ragging research in the country. CURE members spend several hours each week to brainstorm on ragging related issues, organise public awareness campaigns and activities. We have organised seminars, given talks and provided expert inputs on several talk shows in the media. CURE research is widely respected often referred to during ragging discussions, even on news channels.

This report is the essence of our understanding of ragging as a phenomenon and its possible solutions as we see them today. This is in no way complete and ragging continues to fascinate us as a psychological and social problem. However, even as a work in progress, this report raises several questions and directions to pursue in order to find a lasting solution to this problem.



2. Ragging: The Definition

The term "ragging" means different things to different people. To some of us it constitutes just "fun and frolic" including "singing and dancing" in front of seniors. To some others, it means working on assignments for seniors and doing their daily chores. For many others it constitutes physically tiring, verbally abusive or even sexually assaulting acts.

However, there is a general agreement that there must be a line defined which should not be crossed. Who should define the line and how should it be measured is the next question that arises. Again there are conflicts and several opinions on the same.

Ragging is an act of aggression committed by an individual or a group of individuals (say A) over another individual or a group of individuals (say B) where A, by virtue of their being senior to B somehow get the authority and audacity to commit the act and B, by virtue of their being new to the institution are automatic victims.

The term "aggression" again is debatable. However, we will divide it into the following broad categories. A single act may be a combination of more than one of the following types of aggression.

- *Verbal*: Verbal ragging is defined as a non-consensual conversation between the senior and freshman, where the senior humiliates the freshman, forces him to answer personally/socially-unacceptable questions/topics, teases/harrasses him/her, does an exhibition of his/her superiority leading to mental trauma, uneasiness, discomfort for the fresher.
- *Physical:* Physical ragging is defined as a non-consensual act by a senior toward the junior with the goal of hitting, inflicting physical injury or compromising the dignity of the fresher. Also, the act of asking the fresher to do something which is not normal human physical disposition; could create physical injury, health problems or lose of dignity for the freshman are considered physical ragging. Possible examples for the former are: beating the fresher, touching the fresher with one's shoe/feet, hitting the fresher with objects, etc. The latter would comprise asking the fresher to slap him/herself, sit in a 'cuckoo' position, drink/eat something inedible, stand for long on one feet, sweep his/her room, etc.
- *Sexual*: Sexual ragging is defined as an non-consensual act by a senior, that of asking the junior to do something which is damaging or compromises the sexual dignity of the junior; doing an act of sexual nature with the junior. This shall comprise of asking the junior to strip, have unnatural sex, masturbate in public, touch private parts, etc.



3. Problem of Ragging: A Bird's Eye View

Ragging is a psychological phenomenon. The psychology of seniors who indulge in ragging in spite of having faced the same just an year ago and the psychology of freshers who surrender their self respect completely to them.

Ragging is an interesting example of group push-pulls. The sociology of groups – seniors are a strong, existing group and a large number of new members suddenly join this group on a particular day. This group dynamics plays a major role in promoting, crossing lines and condoning the acts committed in the name of ragging. The group gives a feeling of security to the seniors who indulge in insensitive acts. In certain cases, the freshers too form a group and in most such cases things tend to turn ugly with violent clashes being common among the two groups.

Ragging is a problem of enduring suffering because everyone around me is suffering too. Ten times out of ten, the silence of the victims gains strength from the fact everyone in their batch is subjected to the same treatment. "Maybe, this is what is meant by college and growing up!"

Ragging is a problem of dreams and parental expectations. Dreams that seem to have been fulfilled at the point of gaining admission into the college. Expectations which are threatened when someone wants to withdraw from the college due to the inhuman environment around.

Ragging is a problem of law enforcement and saving reputations. In spite of several legislations passed over the years, laws of the land are seldom enforced. College reputations take priority over information being passed to law enforcement agencies of the government. "Do you know what will happen if the media comes to know about it?" Questions like these routinely pressurise freshers into withdrawing complaints.

Ragging is a problem which enjoys social acceptance. Indeed, there is no other way to explain the belief among some parents that ragging is actually good for their kids. Who on earth would encourage their kids to face up and tolerate horrible things happening to them in their colleges? Students who revolt against ragging are believed to have "broken down". Is this what our society has to offer to someone who has garnered the courage to stand up against something wrong being done to him/her?

Ragging is a problem of social ignorance. Ragging is a problem of false beliefs. There are so many myths and factually incorrect assumptions floating around under which almost the entire society is blissfully ignorant. Ignorance of the reality, denial of its very existence by the society at large. Every discussion trying to make sense of this issue within the general public finds a large number of believers in ideas like "severe ragging is rare" and/or does not exist in most colleges, or the more common belief that ragging makes the fresher bold enough to face the world.



Ragging is the biggest fear of any student entering college, especially those moving away from home to lead lives in hostels. In fact, many times students choose colleges based on the perceived extent of ragging in different colleges.

This report attempts to analyse some of these problems and tries to find the underlying reasons and suggest approaches.

4. Current Extent of Ragging

This section intended to discuss more than 200 reported cases of severe physical, mental and sexual abuses, that could be collected from internet newspaper archives (see Appendix), in the name of ragging in the past 9 years in the country. This list could be just a miniscule fraction of the actual number of ragging cases that have occurred, as not all the incidents of ragging are complained to the college authorities, not every complaint is reported in the newspapers and not every newspaper report is saved in the online archives. This figure certainly indicates an emergency like situation but serious effort has to be made to disseminate this information to the society, before it accepts ragging as a social evil.

A detailed analysis of the remaining cases will be released shortly.

4.1 Introduction and Methodology

Ragging has been in considerable debate with regard to how widespread it is, its nature, the kind of colleges it is prevalent in and its effects. These are a few samples of the kind of questions under debate, there are many more of these and many of them have popular opinions (or myths) associated with them.

In this work, we look at the ragging cases reported in the media in the last two years to be able to understand different aspects of ragging based on evidence rather than popular belief, rhetoric or anecdotal evidence. Two years is a good amount of time to be able to make some quantitative claims and fairly short to be representative of the current scenario. The cases here are those reported in print media and news channels. They have been collected from the world-wide-web. All cases included in this study are from a news media house and not from a personal memoir, experience, blog or narration. Our team found 64 ragging cases reported from 2005 to present with no replications.

Before we delve into our analysis of the data, it is important to mention some of the limitations of our approach to provide a perspective to understand the findings. The given data is not based on survey and doesn't adhere to any randomization with regard to type of colleges, regions in India or other parameters. The choice of including (being reported or finding) a case is not made by us, but by the victim, college and/or the popular media. Therefore a number and nature of cases 'reported' is only loosely correlated to the actual number of cases that took place and their nature. The reported number is a pessimistic approximation of the real number; however the degree of pessimism is not known. Also, the real number of occurrences of different kinds of ragging could be misrepresented (represented disproportionately) in the report cases.



Given these caveats however, the numbers are astonishing and immensely disturbing. The pessimistic estimate is also worrisome. Given that this is the only data available, we shall provide its analysis and provide perspective throughout on how the numbers could be biased due to the mismatch in 'reported cases' vs. 'actual occurrences'.

Since 2005, 64 cases of ragging (as defined in Section 1) have been reported, of which 61 were in colleges and 3 were reportedly from schools.


4.2 Kind of Ragging

Out of 61, we could ascertain the kind of ragging only for 41 cases. The distribution of the kind of ragging the to which the fresher was subjected are summarized in Table 1. The definitions for the different ragging are as considered in Section 1.

A graphical representation of the number of cases of different kinds of ragging as a percent of known cases is shown in Figure 1. It can be seen that 62% reported cases were that of physical ragging, majority of which comprise of beating the fresher. Sexual ragging cases comprise of another 33%, where 13% cases not only comprised of sexual abuse, but physical violence. In general, the sexual ragging cases comprise of asking the fresher to strip, dance naked, imitate pornographic postures, etc. In two cases, one at Visva Bharti, Santiniketan and the other at School of Medical Education, Kottayam, the fresher were actually raped by the seniors on the name of ragging.

The instance of verbal ragging are low, however this is an obvious bias due to disproportionate reporting. Given that the verbal ragging cases are milder than physical or sexual ragging cases, they are generally not reported. On the other hand one would believe that the ratio of cases of physical ragging should be representative, given that its importance with regard to social norms is high. Also, one would expect the number of sexual ragging cases being underestimated given the shame and taboo associated with it for the victim and his/her family.







In absolute terms, the number of cases of physical ragging being 25 and sexual (inc. sexual with physical ragging) being 13 is startling. It should be noted that each of these are criminal offences in themselves, thus points toward more than 20 criminal offences perpetuated under the guise of ragging each year. Also, these are a pessimistic estimate. *This debunks the popular myth that sexual and physical ragging is no more prevalent after the Supreme Court Judgment of 2001.*

4.3 Consequences of Ragging

A lot of debate on ragging is hinged on its apparent harmlessness and fun nature. This belief is not only wrong, but a convenient oversimplification. A quantification of the outcomes of ragging is summarized in Table 2. *Death* refers to any death caused due to a ragging incident and not necessarily that of the fresher. *Injury* refers to reported physical injury or hospitalization. 'Deterimental effect on mental health' implies psychological disorders and depression. 'Victim left college' implies that the ragging victim fleed the college due to ragging or further threats. In most cases, we are unable to ascertain whether the victim returned or not. 'Violence' refers to any violence or indiscipline that resulted in the college as a consequence of ragging. It doesn't refer to the violence perpetrated on the victim by the senior during ragging.




Figure 2: Outcomes of ragging

A graphical representation of the statistics is shown in Figure 2. Ragging has caused a total of 10 deaths in the last 2 years, 10 of which were that of young college-going students. Surprisingly, all these deaths are not those of freshers. C. Lalitha, the mother of Mukesh ended her life due to the controversy surrounding the sexual abuse of her son during ragging (Andhra Pradesh, Sept 2006). Three of the ragging deaths were that of seniors: 2 seniors were killed by a first year student when he was being ragged (Vidyanagar, MP, Aug 2006); 1 senior ended his life when he was punished for ragging and one due to the result of brutal ragging (equivalent to murder). This statistics debunks the popular myth that ragging is just a cause of trouble for freshers. It has led to the death of senior students and even ruined a family as in case of C. Lalitha. The problem is far more complicated than in general assumed.

Suicide attempts refer to suicide attempts by freshers which may or may not have led to death. There were a total of 10 suicide attempts, out of which three individuals were saved. In the case, that these individuals were not saved the total death count would go to 14. Such a high number of suicide attempts by well-educated individuals coming from an economically-sufficient class of the society is highly disturbing. It has to also be considered that ragging is a punishable offence according to Indian Law.

Out of 42 cases for which 'injury' could be ascertained, a whooping 23 cases (54%) led to physical injury (like fractures) or hospitalization to students. *This totally debunks by all metrics the notion that ragging is harmless fun.* The flippant attitude of the media and the society in this regard is unfortunate and unjust. In many cases, more than one student was injured: 5 freshmen were hospitalized when they were beaten by seniors (Dehradun, Oct 2005); 2 freshman were injured, one in spine and a fracture in hand for the other (Andhra Prahesh, Dec 2005), 6 freshmen beaten with iron rods (Timkur, Karnataka, Mar-2005), etc. In the case in Jammu, a junior girl was beaten up by senior girls leading to bruises and soft tissue injury.

Out of 42 cases where it could be ascertained, 12 cases led to mental health problems to victims (some leading to attempts to suicide). A few examples exemplify the state of the victims:

- Victim's condition after being forced into group sex by seniors, Visva Bharti, Santiniketan, Jul 2006.
 By the time she was released, the girl was in a state of physical and mental trauma. Later she was hospitalised for her treatment and under uncosciousness she kept saying, "I'm not a thief, I'm not a fallen girl," said the victim's local guardian, Amita Hazra. (Quoting Print Media)
- Condition of Raja, S. Ashok Technological Institute, 26-Aug-2005. Driven to near insanity, he now spends most of his time in the isolation ward of a local hospital. Raja shudders while recounting his first term in college. He had to suffer hundreds of slaps and public abuse by senior students for almost six months.Requests to be pardoned only heightened his woes and he instead of disclosing his torture, endured it silently till he lost his sanity. His dreams of earning an engineering degree has been replaced by an acute desire for vengeance. "I will not let them get away with it," he keeps on repeating every time images of two senior students flash through his mind. When not in hospital, Raja is confined round-the-clock in a small room of his Rohtas Nagar house. He is undergoing extensive psychological treatment (Quoting Print Media)

These examples clearly show how traumatic the experience of ragging could be for the fresher. Even though some freshers may not be driven to a psychologically unstable state



immediately, the emotional scars of physical and sexual ragging are bound to affect the mental stability of the victim.

An astonishing outcome of ragging is the violence and indiscipline it causes in the college apart from its affect on the fresher. Atleast 10 cases of ragging caused other problems in college which included violent clashes, violence with teachers and journalists, strikes, vandalism and breakage and involvement of unions and local parties. *Again, this turns the oversimplifying arguments, with ragging being an ice-breaker for the fresher, on its head.*

A study into the various outcomes of ragging clearly show that it is a menace to the society. 11 deaths and an additional 23 cases of injured students is extremely disturbing. We also see that 5 victims fled from college due to ragging, which is extremely sad and a challenge to a merit based system of admission. Cases of mental health problems are just representative and indicates long term and subtle mental instabilities a victim may experience in life. Finally, the violence and indiscipline ragging creates in the college inhibits the efficient delivery of education in colleges, which is their main purpose. *These numbers show that claiming ragging as harmless fun is totally baseless and its oversimplification as an ice-breaker is problematic and immature.*

4.4 Place of Ragging

The popular belief is that ragging is most widely spread in medical and engineering colleges. Out of 64 cases, we were able to ascertain the nature of college for 51 cases. Their distribution is presented in Table 3.

Clearly the highest number of ragging cases are reported from Engineering colleges (35.3%). Though the medical colleges also form a substantial percent, one observes that a huge percentage (37.3%) of ragging cases are reported from colleges running B.Sc., B.A., B.B.A, vocational courses. This debunks the popular myth about the reason why seniors rag is linked with the tight schedule and stress of studies in professional courses. One cannot be sure how representative these statistics are of the proportion of actual occurrences of ragging incidents. One can argue that ragging cases have become a



tradition in medical colleges and thus do not exposed to the media. Only further study through surveys or more evidence could substantiate or negate this theory.

Though the distribution of ragging cases among different courses is not completely clear, the verdict is loud and clear regarding the place of ragging in colleges. A whooping 84% cases of ragging were conducted in hostels (or out-of-campus housing) versus a small 16% which happened on campus or other places off-campus. Out of the 44 cases where the place of ragging could be ascertained, 37 were done in hostels, while 7 were on-campus. This shows a big problem with the current discourse in the media, which floods pages with photos of ragging on campuses at the beginning of every academic year. These photos are not representative of the real 'place of action' of ragging, where it takes form of human-right abuse. These pictures misguide the public to a 'harmless fun' view of ragging causing the *problem of denial*.

4.5 Other Considerations

- Involvement of girls: 7 out of 46
- Money-exhortation: 2 cases
- Non-consensual alcohol consumption: 2 cases
- Casteist colors in ragging: 1 case



5. Social Perceptions: Debunking Prevalent Myths

As discussed earlier, the most important problem encountered while trying to build a consensus against ragging is the social denial that accompanies any mention of the ill effects of ragging. The level of ignorance among the general public about its existence, effects and presence of a framework to deal with it is startling, to say the least.

We mention some of them here and also provide real explanations.

• Ragging is harmless fun

Most people think ragging is mild involving verbal interaction or having freshers do funny acts for a laugh. A darker side of ragging is widely prevalent in hostels and in outlying colleges. Here the practice of ragging revolves around cases of emotional harassment, sexual and physical abuse. Most of the cases are undocumented, and even if publicised are denied by colleges for fear of reprisals or loss of public image.

• Ragging doesn't mean more than cleaning the senior's room or removing your shirt

Ragging incidents have included stripping of all clothes, public sexual acts to the extent of sexual intercourse & sodomy. Ragging takes its worst form when freshers are mercilessly beaten, asked to take drugs, made to work 24x7 and forced in rules such as not removing shoes for months.

• Severe Ragging is not prevalent anymore

Severe ragging is widely prevalent in most of the colleges which have hostels, be it the smaller cities or the metropolitans. Nothing speaks louder than 25 cases of suicide due to ragging in the last seven years. After the Supreme Court Judgment, colleges have just geared up to keep ragging incidents under the cover. The problem is not solved yet, it is just hidden.

• Ragging helps in breaking the ice between the seniors and freshers. It helps in their interaction and developing friendship between them. Ragging is an archaic method of interaction with several harmful effects. Today with advancements in psychological science, there are many other healthy ways of interaction which are more effective and without any human rights abuse.

• **Ragging generates a feeling of unity and oneness.** Ragging divides the students on the lines of caste, region, class etc. It sets up a mob mentality among the students.

• Ragging makes the fresher bold

Let us consider, what is boldness. Boldness is actually taking a stand for ones principles and truth, even when the person knows that he could lose something for taking this stand or it can become dangerous for him. Acceptance of wrong done



to you and not breaking-down is not boldness. It is revolting against the wrong done to you and not breaking down! Ragging does not make one bold, it teaches us how to be exploited and mutely, non-resistively accept it.

To flip the argument, let us now consider ragging where a person is asked to do something stupid in public, but this time the ragging act has a sexual/physical/unethical attributes. This could be hurling nasty/sexual abuses to someone, holding your private parts in publics, making an indecent proposal to a girl, stripping oneself, etc. Yes, indeed this makes once courageous! But, is it the courage to do the wrong? Ragging tend to instill the courage in an individual that he shouldn't be afraid to be something which is socially unacceptable and wrong, since their consequence wont be much! One can appreciate that this boldness is actually 'gunda-gardi'. This is the courage which all unsocial elements like eveteasers, bullies and even murderers possess. The courage is not derived from the truth of one's stand, but the non-existence of dire consequence. It is once again a perverted boldness/courage.

Thus, we strongly object to this kind of ragging not only due to its unprincipled and unethical nature, but because it instills the worst kind of courage into a person. [One is tempted to compare it with the courage of the suicide bombers!] Wrong-doers are persons who lose sensitivity towards the self-respect of the other person and who are not afraid to do the wrong. This ragging indeed moulds freshers in this way, as is proved when the freshers become perpetrators in the second year!

• No one can rag me, if I don't allow it

A disorganised set of freshers face a united front of seniors who ask them to do the most unthinkable things on the name of ragging. A NO from the fresher means public humiliation, beating and infliction of worst torture. Singling out a protesting student is a regular feature of the game of ragging. Complaints may mean facing hostile authorities, threat from the whole senior batch leaving no option for the fresher but to leave the campus and ruin his career. The options for the perpetrated fresher are few, though there are always exceptions, who prove it otherwise. It is rightly said, "Exception Proves the Rule".

Colleges are serious about preventing ragging

In many violent cases, colleges have actually denied the incident, or worse, indicated that the fresher had initiated the altercation. The college authority prefers to deny ragging incident for face-saving at the cost of the fresher's trauma. In stray cases, where action has been taken against the seniors, public sympathy towards the perpetrator has made justice difficult. Many colleges now try their best to keep the incident under the cover to save themselves from embarrassment and the reputation of the college. The attempts of colleges fall way short of the basic expectations in dealing with ragging incidents.



• Why is the practice so difficult to change or police?

The problem is endemic and very difficult to police. The worst cases occur in hostels, behind closed doors and late at night. Fear of reprisal, mass intimidation and shame or embarrassment at the incident makes freshers reluctant to approach authorities. The authorities anyway turn a blind eye to the issue due to fear of student mobs and loss of reputation. The problem maintains its continuity, when the victim becomes the perpetrator in the very next year.

• In which colleges is ragging more prevalent?

Ragging is widespread in colleges where students stay in hostels. In hostels, the fresher is totally at the mercy of the seniors with no support from family and friends. The problem magnifies at engineering and medical colleges, where students believe that they are the cream of the society and it is their right to do socially unacceptable practices on the name of ragging.

• Are there any laws against ragging?

The Supreme Court in its verdict, in response to a PIL filed by Vishwa Jagriti Mission in August 2001, had put a ban on ragging. Many states have also passed laws against ragging. But unfortunately, college authorities are not willing to accept their role and responsibility in this.

• What is society's role in stopping ragging?

Indian society needs to wake up and realize these events are happening, today, in the 21 st century. The biggest role of society today is ACCEPTANCE – that inhuman ragging exists, it must be stopped and alternatives explored for the Indian Educational system. There are better and positive ways to promote interaction with seniors than ridicule, humiliation and abuse.



6. Psychological Perspectives: The Viciously Circular Tradition

Ragging has always been considered a phenomenon of vicious circle. It is a phenomenon which if started in any educational institutional, may carry its legacy forever. It is a concept which passes from one batch to the next, making it an unending chain. But what are the factors which ensure this legacy? What are the components of this chain? How & where does it actually get its strength from? These are some of the questions which are perhaps not answered yet.

CURE's research suggests that there hasn't been much of a psychological study done to understand ragging, which is one of the most complex behaviour of human beings. It is perhaps the only phenomenon in which the victim himself becomes the perpetrator in a short span of just one year. What puzzles the most is the fact that the victim starts practicing worst sorts of human rights abuse of the modern civil society, which he himself endured only a few months ago.

In our seven years of experience with ragging, we were always very fascinated to understand this particular phenomenon. Though for a long time we did not get any answer but we always had a belief that ragging is no doubt a psychological aberration. It was this intense interest which always propelled us to go deeper and deeper and understand this vicious circle.

Ragging is more of a psychological problem than anything else. The whole concept of it is based on two major superstitious beliefs about ragging i.e. first that it has a positive effect on the personality of the fresher and secondly that it helps in the interaction between the seniors and freshers. The seniors make every effort to ensure that these beliefs are well passed on to their juniors.

It is normally seen that when fresher enters the college then initially he is too horrified with the ragging practice. During the initial days of ragging, even a minor abusive word hurled on him or a small act of physical or sexual violence with him is unbearable. He makes every possible effort to save himself from this unjustified torture. The option of complaining this to the authority is mostly ruled out by him due to the already set in insensitivity among the college authorities towards this traditional concept of ragging. Secondly the newly admitted fresher lack confidence in complaining this to the college authorities approach of a backlash by his seniors.

Most of the freshers choose to rather run away home and see it as the most viable option to temporarily avoid ragging. When they return back they face the same ordeal again. The initial ragging days are some of the most traumatic days in anyone's life. Since getting



admission in professional colleges in India is too difficult therefore the freshers decide to compromise with the situations and search for support among the fellow sufferers i.e. batch mates. It is commonly seen that most often the freshers who drop out of college or commit suicide are the ones who are singled out from their batch or are ragged most severely. It is also observed that sometimes one or two freshers who are ragged severely or are singled out by their seniors are ostracized by their batch mates too and this leads to severe depression among the fresher who then decides to harm himself. It is noted that most of the cases which are reported are the ones in which the victim were singled out.

Gradually as the freshers face ragging, their sensitivity to abusive words, physical and sexual violence starts decreasing day by day. The rate at which this sensitivity decreases varies from fresher to fresher. Many a times after severe ragging, seniors offer cold-drink or samosas to eventually reconcile with the fresher. After which freshers are explained that ragging is good for them as it would make them smart and familiar with the seniors. Later the senior promises to help the fresher with notes and books. Therefore the session of familiarization which started with physical, sexual and verbal torture ends up happily.

Likewise the fresher has to go through the same sessions of torture until he becomes familiar with each and every senior of the college, following more or less similar method of familiarization. Freshers are told that if they don't go through ragging they will not only remain shy but never know their seniors and would thus remain isolated in college. Gradually as the fresher goes through repeated tortures and is inculcated with the myths of ragging, he not only becomes insensitive to it but starts believing in the concept of ragging. It is this which ensures the phenomenon of ragging to pass on from batch after batch.

Ragging has also been associated with machoism. Seniors, who are able to sexually or physically rag their junior, see it as an act of courage. It is because of this that many seniors who are reluctant to rag their juniors, finally succumb to peer-pressure. It is often found that not all the seniors are in favor of sever ragging but are indirectly forced to rag in order to stay in their group of friends else they are bullied by their batch mates.

It is often found that many a times ragging start as a healthy introduction exercise but due to sudden rush of adrenaline in teenage that gradually the seniors get carried away in a large group of friends and ragging turns ugly.

The superstitious beliefs about ragging get their strength both from the society and the college administration. In the society either people have already gone through ragging and therefore later justify it or else they see it as a mild practice of singing and dancing. The college administration sees it as a traditional practice being followed for a long time and thus becomes insensitive to it. These two factors play an important role in indirectly encouraging the students to practice ragging.



7. Solution Approaches: Core Issues

In this section, we try to understand reasons behind the major problems outlined in the previous sections.

- Denial of ragging: Ragging is not recognized as a social evil by the society.
 - Denial since normal people have indulged in it as seniors and want to now explain their conduct morally.
 - Colleges deny its existence in campus for good reputation and also because they are unable to control it.
 - Parents (of freshmen) don't know the full extent of ragging and henceforth think it is some little teasing for personality enhancement.
 - Parents also deny it since when they get to know about the extent of ragging, they are unable to do anything about it.
 - General people see ragging in light of simple teasing, dancing, etc. on campus captured by media and doesn't know its real extent as in hostels. They think these cases are corner cases and don't think they are widespread.
 - Macho image is associated with ragging and criticizing it is considered a weakness among youth.
- No clear guidelines on how to deal with ragging seniors, in case of complaint and substantial evidence.
 - There are multiple parties involved including college authorities, police, parents, students and student bodies. The sympathy of the parents, the society and student bodies lie more with the seniors than the ragging victims. The college has vested interests to deny the incident to save reputation. The role of police is unclear and adhoc. There is a possibility of strikes and hooliganism in support of ragging perpretators.
 - The nature of incidents in ragging comprise of physical injury, sexual abuse and subjugation. All these comprise of criminal offence according to the judicial system of India. The ragging seniors are above 18 years of age and cannot be considered juvenile. The Supreme Court judgment of 1998 notes, "Some of the States have acted by enacting legislations and making ragging as defined therein a cognizable and punishable offence. However, we feel ragging cannot be cured merely by making it a cognizable criminal offence." It is clear by CURE's collected statistics that the college authorities have been unable to contain ragging and function according to the Supreme Court guidelines.
- Complete helplessness of freshmen



- Away from family in hostel with a worrisome family at home, which cannot be worried more.
- Shame and shyness to share experience with family. Indian societal nature doesn't allow easy talk between parents and children about sex related issues and ragging takes sex colors most often.
- At complete mercy of seniors in a new environment. Retaliation (complaints, information to parents) may mean dire consequences and complete ostracism to possibility of being forced to leave college.
- Peer-pressure of seniors and batchmates to obey seniors to become a part of the cult.
- Inaccessibility, indifference and inaction of college authorities.
- Worst practices have become part of ragging as documented.
 - The best analogy to these practices are with those practiced in the camps of Abu-Gharib.
 - Complete emotional subjugation by humiliation and stripping right to basic human tendencies as that of smiling, laughing, talking, clothing by choice, etc. in a hostile environment.
 - Subjecting to physical injury through beating, hitting by people and objects.
 - Forced sexual acts in public including stripping in front of same or opposite sex, passing urine in public, forced public masturbation, forced sexual activity including unnatural sex with person(s) of opposite or same sex.
 - Forceful initiation into cigarette, alcohol and drugs.
- Disinterest and fear in college authorities to get involved in the problem of ragging.
- Casteist and regional colors of ragging.
- Zero research on the issue of ragging.
 - Only book published on ragging was in the 1960's and as per the best knowledge of CURE, no paper on ragging has been published in any journal. Only analysis and research reports published in 2005-06 are by CURE.



8. Conclusion

It is clear that ragging is a criminal problem which has psychological roots and a social ignorance around it. It is somewhat like dowry in its characteristics *i.e.* it the magnitude of the problem is so humongous that a top-down law enforcement approach may not be adequate to solve it.

Unfortunately, ragging does not have a quick-fix solution. Passing a law or even implementing it will not solve the problem. We must understand that unless the society condemns it, ragging cannot be eliminated. We require a focussed and concentrated effort to educate the masses.
